Below is a letter from your Town Selectboard:

Dear Colchester Voters, Residents, and Taxpayers,

We, your Selectboard, are writing to provide information on the Town of Colchester's FY 27 Municipal Services Budget to be voted on Town Meeting Day 2026.

The proposed FY27 municipal services budget, of \$18,163,756, represents a 7.2% increase in planned expenditures for maintaining our current level of Town services, and addresses additional resource needs for: 1) paid on-call staffing for the Fire Department; 2) increases in salary, benefits & training for the Police Department; 3) increases in salary, benefits and training for the Rescue Department; 4) increased costs for necessary software for Information Technology (IT).

Forty-four percent, or \$7,967,487 of the FY27 Municipal Services budget is dedicated to the Town's public safety services – Police, Fire, Rescue, Technical Rescue, and Public Safety Dispatch.

This amount doesn't include the other municipal support services provided for public safety equipment, vehicle/building maintenance, information technology, human resources, finance/payroll, and general management needs. With those costs included, the public safety services would represent well over half of our municipal services budget.

The largest factor impacting this budget is Vermont's Labor Market. According to the U.S. Bureau of Labor Statistics, Vermont only has 60 available workers for every 100 open jobs. Due to the high cost of living and limited available housing, both private and public sector employers are competing for this same small pool of workers. We must ensure our pay and benefits continue to retain and attract quality employees in all work groups. Employee turnover in any department can cause delays in service delivery to the public and result in higher costs for training and onboarding new staff.

The tax impact of the FY27 municipal service budget, along with previously approved capital items, represents an estimated 6.6% increase to municipal services property taxes compared to the prior year.

Based on 2025-26 taxes, Colchester's municipal services taxes are 17% below average and the second lowest per resident among the seven inner Chittenden County communities. We ask that you support the FY 27 municipal services budget with your vote.

A Message from the Town Clerk's Office: Stormwater Bills and Property Tax Bills

With US Postal Mail service having difficulties with staff shortages, here are some services that the Town Clerk Office provides to assist the community in receiving and paying these bills.

Property Tax bills are sent by US Postal Mail annually in July of each year, the bill covers July 1st through June 30th of the next year. There are three installments on that bill.

Stormwater invoices are sent by US Postal Mail annually in January of each year, it also covers July 1st through June 30th. There is only one payment due within 30 days to the Town of Colchester. For more information on Stormwater go to <https://colchestervt.gov/1837/Stormwater>. Stormwater bills are due February 20, 2026.

New owners or owners who may not have received the mailed bills may contact the Town Clerk's Office anytime for a copy to be picked up or emailed. The Clerk's Office can be contacted by townclerk@colchestervt.gov or called at 802-264-5520.

To pay these installments and not use the US Postal Mail;

- Town Clerk's Office maintains a secure drop box on the exterior of main entrance of Town Hall that is open 24/7 and checked multiple times per day.



- We accept payments during office hours, M-F, 8:00am to 4:30pm.

Mail Service in Colchester: A letter from your Selectboard

Dear Colchester Residents,

The Colchester Post Office is experiencing significant delays in delivery time due to staffing issues and resource shortages. We have heard from residents who are understandably frustrated by the situation. We share your frustration and hope that our local post office and the postal service can get the help it needs.

The Selectboard and Town staff have no influence over the United States Postal Service (USPS). The USPS, including our local post office, is part of the federal government. The United States Postal Service is overseen by a Board of “Governors” appointed by the President of the United States with the advice and consent of the U.S. Senate.

The Selectboard has written to Senator Sanders, Senator Welch, and Representative Balint to ask them to properly resource our postal service, including our local post office.

Here are contact forms and information for the people who oversee the USPS and our federal delegation. The more people they hear from directly, the more they will appreciate and understand the magnitude of the problem.
