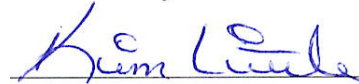
1. Call to Order, Invocation, and Pledge of Allegiance to the Flags of the United States of America and the State of Texas.

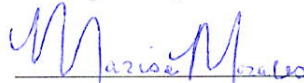
