The City Council of the City of Coleman, Texas will meet in session on **Thursday, January 15, 2026**, at **5:15 p.m.** in the Council Chambers of City Hall, 200 West Liveoak, Coleman, Texas. All items on the agenda are for possible discussion and action. Council may vote and/or act upon each of the items listed on this Agenda. One agenda item will be discussed at a time, in the order determined by the Mayor, unless logic and practical considerations allow similar topics to be considered together for purposes of convenience and efficiency. Consent items are considered to be non-controversial and will be voted on in one motion unless a council member asks for separate discussion. The City Council of the City of Coleman, Texas, reserves the right to meet in closed, executive session on any of the items listed below should the need arise and if authorized by Title 5, Chapter 551, of the Texas Government Code. 1. Call to Order, Invocation, and Pledge of Allegiance to the Flags of the United States of America and the State of Texas.
2. Introductions, Announcements, and Recognitions.
3. Items to be withdrawn.
4. Citizen Presentations: Any citizen who desires to address the City Council on a matter not included on the agenda may do so at this time. The City Council may not deliberate on items presented under this agenda item. Presentations are subject to five (5) minutes for items not on the agenda. If you wish to speak to an item on the agenda, you will be allowed to speak when the council addresses the item. There is a (3) minute time limit for items on the agenda. The presiding officer (with the consent of a majority of the City Council) may grant additional time. To comply with the provisions of the Open Meetings Act, the Council respectfully requests that prior to addressing Council, that each person submit a Speaker Request Form stating your name, address, and topic of presentation. The form is located at the entryway to Council Chambers.
5. Consider and act upon the approval of minutes for the regular City of Coleman Council Meeting held on December 18, 2025.

6. Discuss, consider, and act upon a Resolution of the City Council of the City of Coleman, Texas adopting an Investment Policy.
7. Discuss, consider, and act upon adoption of a Resolution of the City of Coleman designating the Coleman Chronicle and Democrat Voice as the official City newspaper for publications required by State law and/or by City Charter.
8. Discuss, consider, and act upon adoption of a Resolution of the City of Coleman, calling for a General Election to elect member(s) to the City of Coleman City Council; establishing date of election; designating polling places; providing for early voting; providing for the appointment of Election Judge(s) and Early Voting Clerk(s), etc.; authorizing the City Secretary to publish and/or post Notice of Election; and resolving other matters incident and related to such election.
9. Discuss, consider, and act upon the City of Coleman authorizing the issuances of Requests for Proposals (RFP) for Administrative Services and/or Requests for Qualifications (RFQ) for Engineering Services for the 2025 U.S. Economic Development Administration (EDA) Funding Grant.
10. Discuss, consider and act upon approving a Resolution of the City of Coleman, approving the lease of approximately 27,000 square feet of space at the Airport/Industrial Park between the Coleman Economic Development Corporation, Coleman Community Coalition and Eddie Adams / CC Metals, LLC for manufacturing purposes.
11. Discuss, consider, and take action to authorize the City Manager to apply to the U.S. Department of Defense Firefighter Property Program, administered by the Texas A&M Forest Service, for the acquisition of a surplus military vehicle. The program provides a reimbursable grant in an amount not to exceed \$45,000, with a required local match of five percent (5%).
12. Discuss, consider, and act upon a Resolution of the City of Coleman, Texas authorizing the submission of a FY 2027 Criminal Justice Division (CJD) Grant for the Coleman Police Department – Grant Number 5693801 and authorizing the City Manager as the authorized official to apply for, accept, reject, alter, or terminate the grant.
13. Discuss, consider, and act upon a Resolution of the City of Coleman, Texas authorizing the submission of a FY 2027 Body Worn Camera Grant for the Coleman Police Department – Grant Number 5694001 and authorizing the City Manager as the authorized official to apply for, accept, reject, alter, or terminate the grant.
14. Hear presentation from Chief JD Ravenscroft regarding establishing a Citizens on Patrol Program and discuss, consider and act upon establishing the Citizens Police Academy and Citizens on Patrol (COP) Program.

15. The City Council may enter Executive Session to discuss the following items pursuant to:
- a) Government Code §551.071 (Consultation with Attorney) discussion with City Attorney regarding management agreement between the City of Coleman and Coleman County Chamber of Commerce for use of HOT funds.
16. Upon returning to open session, the City Council may take whatever actions as they may deem appropriate regarding items discussed in Executive Session, including:
- a) Discuss, consider, and act upon the Publicity and Tourism agreement between the City of Coleman and the Coleman County Chamber of Commerce.
17. Hear status report from the City Manager regarding City Operations: a) Coleman 150; and b) Construction Project Updates
