



Curry County has third COVID death

After seeming to be immune from the worst parts of the COVID-19 pandemic, Curry County was pushed back into reality Tuesday.

Cases in the county have been surging in recent weeks, to the point the county moved into the Extreme Risk category last week. But even with rising cas-

es, hospitalizations and deaths remained low. Until Tuesday, when the Oregon Health Authority reported a third death in Curry County.

The third person to die with COVID-19 is a 50-year-old man who tested positive Dec. 11 and died Dec. 21 at Southern Coos Hospital & Health Center in Bandon. He had underlying conditions. The death was the third in Curry County since the beginning of the pandemic and was one of 35 reported in Oregon on Tuesday.

Across the state, there have been just more than 105,000 COVID cases with 1,282 deaths related to the virus.

Sherrie Ward, the Curry County public health administrator, announced Tuesday morning the county had 34 new cases in the last week. Ward reported 32 cases were in south

Curry County residents, two were in residents in the central part of the county and several were linked to Sea View Assisted Living Center and household contacts previously linked to Pelican Bay State Prison.

Since the beginning of the pandemic, Curry County has had 254 cases with 104 cases considered active.

Ward said with COVID-19 cases on the rise, it is important to follow state and local guidelines. She urged residents to wear masks, remain at least six feet away from people outside your immediate home and, most importantly, stay home as much as you can.

Vaccinations in Oregon have begun, but health authorities urge residents to be vigilant until the vaccines can be widely used.

Food drive fills shelves at food bank

As the clocked turned to 4 o'clock Friday, the cars began to line up. One by one, they drove down the alley and dropped off food for people in need.

And as she watched, Pamela Winebarger couldn't help but smile. Winebarger, the executive director of the Brookings Harbor Food Bank, came up with the idea of a drive-through food

drive as a way to collect food needed to feed the hungry in the community.

"The Elks do Christmas and we do Thanksgiving, but we always have a shortage," Winebarger said. "That's not the only reason we do a food drive. We also do the food drive to restock our shelves. They are not overflowing now. A lot of it goes to replace the shortage and make sure we can get through the new year."

Because of the struggles COVID-19 has caused in the last year, organizations like the Brookings Harbor Food Bank have never been more important. At Thanksgiving, the food bank provided food for 407 families, 100 more than just a year earlier.

Winebarger said a lot of new people are coming in, pointing to a marked increase of families in need.

"More and more people are coming in," she said. "More and more people are in need."

Winebarger, who helped in similar drive-through food drives in Carson City, Nevada, said she hoped to collect 2,500 pounds of food during the drive-through event.

"That's our goal," she said as the first cars arrived. "I don't know how it's going to work. For us, 2,500 pounds is a good goal."

Injured surfer is transferred to Colorado hospital

Zac Abblitt's life changed last month after a day of surfing went wrong.

The Brookings 18-year-old dove head-first into shallow water and didn't come up until he was pulled out by friends nearby. The dive fractured vertebrae and paralyzed Abblitt from the neck down.

Up until about a week ago, Abblitt was slowly regaining muscle function at a hospital in Redding, California. But since then, he's been transferred to a new hospital, where he'll be for several months.

In the meantime, his family in Brookings is going through the highs and lows of his recovery, but is remaining optimistic.

"They're all very strong, I would say," said Kevin Knoll, Abblitt's uncle who's been coordinating community support for his recovery.

Currently, a big reason for their optimism is Abblitt's transfer to Craig Hospital in Englewood, Colorado. There he's seeing experts in spinal cord rehabilitation.

His condition has improved, and he's often seen talking and laughing in videos posted by family members on a Facebook group dedicated to updating friends about his recovery.

"I know that though all of this God's just been such a blessing in everything that he's done,"

Abblitt said in one of those videos. "I am highly encouraged, just the support that I've had from people, and just what God has been doing, and how I've seen others touched, too."

But, largely paralyzed from the waist down and classified as an incomplete C5-C6 quadriplegic, Abblitt's best hope for a return to more normal body function is intensive rehabilitation.

One voice trying to change the world

BROOKINGS - Jessica Garcia's life changed forever six years ago when she was violently sexually assaulted in her own home. After surviving the attack, she quickly realized the worst of it wasn't over when she tried to go to the hospital.

What followed was an ordeal Garcia believes no one should have to endure. So, she's trying to change it. And she just might succeed.

Garcia has already made big strides thanks to a partnership with State Rep. David Brock Smith's office. In 2019, House Bill 2375 passed the legislature and was signed into law by Gov. Kate Brown. The law requires district attorneys and hospitals to have a plan to treat sexual assault survivors or a plan to quickly transfer them to a facility that does.

Garcia pushed for the law because she felt the way she was treated after her rape was an ordeal no one should have to experience.

To understand, one has to go back to 2014. Garcia remembers meeting a man at a local business and agreeing to have a drink with him. After one glass of wine, the two went to her house. While things were great at first, the man, Lorenzo Ignacio King, quickly changed and violently attacked and assaulted Garcia for hours.

Once he left, Garcia was like many assault survivors.

"After I was assaulted, first, I didn't want anybody to know," she said. "I was embarrassed. When I went to the hospital, I didn't want anybody to know. At first, I wanted to say my ribs were broken."

A nurse at the hospital knew differently after seeing obvious signs of trauma, including bite marks and extensive bruises.

"That's when I found out they don't do our kits," Garcia said.

At the Brookings facility, she was told to get a rape kit done, she had to drive to Grants Pass or Coos Bay. Garcia almost left it there, but a friend convinced her to fight back, even if it was only so others wouldn't have to run into King.

# Central Curry SD begins superintendent search

With Superintendent Tim Wilson retiring at the end of the school year, the Central Curry School District board is asking the community to help find a replacement.

Last week, the board voted to use the Oregon School Boards Association as the agency to help find candidates for the opening. It also voted to bring together a board of community members and district staff to serve as the application screening committee.

The committee will look through the applications and decide which ones to bring to the school board for consideration.

With Wilson serving through the end of June, the board declared the superintendent's post open effect July 1 and set a swift timeline in an effort to find a replacement.

Community members who wish to serve on the application screening committee can apply through Jan. 15, with the board slated to choose committee members at its regular meeting Jan. 20. The committee will be made up of 10 to 15 members.

The board set a goal of interviewing candidates in February with a goal of selecting the new superintendent before spring break in March.

Anyone who is interested in serving on the screen-

ing committee can get an application by visiting the district website at [www.ccsd.k12.or.us](http://www.ccsd.k12.or.us) and looking under the "New Superintendent Search" tab. Interested people can also receive applications by contacting Wilson at [twilson@ccsd.k12.or.us](mailto:twilson@ccsd.k12.or.us) or contacting any school offices.

According to the school board, the qualities they

are looking for in the new superintendent are:

- Effective communication and listening skills;
- Proven ability to make tough decisions when necessary and effectively communicate the reasons (transparency);
- Background in teaching and building administration (instructional leadership) preferably in

small rural communities;

- High degree of integrity/honesty with strong core values
- Empowering innovative leadership that collaborates with community and staff committed to serving all kids K-12;
- Is personable/approachable while keeping an open mind; good sense of humor;

- Understands Oregon school finance, demonstrates sound fiscal management and strong budgeting skills;
- Ability to build and sustain strong, effective family/community partnerships that impact student success;
- Works well with others with a high-degree of cultural competency.

# COVID vaccines trickle into Oregon

Oregon recently exceeded 100,000 cases of COVID-19 and recorded over 1,300 virus related deaths. Despite the consistent increase, Gov. Kate Brown and the Oregon Health Authority remain optimistic the coronavirus spread is slowing.

During a Dec. 22 press conference, Brown was joined by OHA Director Pat Allen to update Oregonians on COVID-19 vaccine distribution, financial relief and more.

"It's really, really tough to be heading into a time where traditional celebrations are once again hindered by the virus," Brown said. "Every single family that has lost a loved one to this virus and every Oregonian that has suffered emotionally, financially or physically from COVID-19, I want you to know that you are in my thoughts."

Brown said there is light at the end of the tunnel however, and nearly 4,500 healthcare workers in Oregon have received the COVID-19 vaccine so far. Oregon received the full 35,100 doses of the Pfizer vaccine allocated by the federal government and distributed doses to 16 hospitals across the state last week.

"I'm grateful for the healthcare workers who have been heroes throughout this pandemic," Allen said. "It's fitting, truly, that they are the ones among the first to be vaccinated who will light the path for all of us to follow out of this dark terrible forest that is the coronavirus pandemic."

In addition to the Pfizer vaccine, Allen said the Western States Scientific Safety Review Workgroup

now recommends the Moderna vaccine after confirming it as safe and effective. An issue with distributing the Pfizer vaccine is the need to store in freezing temperatures. But according to OHA, the Moderna vaccine does not need to be stored at those temperatures. Allen feels this gives the state an advantage to easier distribution, especially to more rural areas.

More than 12,000 doses of the Moderna vaccine arrived in Oregon this week and the state is expecting an additional 25,000 doses of the Pfizer vaccine. Later in the week, Allen said over 72,000 doses of the Moderna vaccine are due to arrive in Oregon.

By the end of the month, OHA expects to have received over 92,000 doses of the Pfizer vaccine and 97,000 doses of the Moderna vaccine. However, Allen said these allocations are often ever-changing due to supply and demand across the United States.

"That means we have to be prepared for months of limited supplies and the need to prioritize who gets the vaccine and when," Allen said.

Oregon has also begun administering the vaccine to residents and staff of long-term care facilities. OHA reported that 10,000 doses of the Pfizer vaccine have been distributed so far statewide as Brown noted the care facilities have been among the hardest hit by the pandemic.

"It feels really good to be able to start these vaccinations with the hope that these folks can reunite with their families once again and feel safe from the virus soon," Brown said.

Brown also noted that daily case counts have

tapered off a bit lately. The state is attributing some of the decrease to the two-week freeze and additional safety restrictions that Brown said "blunted the virus surge."

"Thanks to the decisions you, and the majority of Oregonians continue to make, we are slowing the spread of this disease," Brown said. "While our case counts are still up, we are avoiding many worse case scenarios. This is proof that we determine how the next few months play out while we work to swiftly distribute the COVID vaccine far and wide across the state."

Both Brown and Allen encouraged Oregonians to continue following safety guidelines and to rethink their Christmas and New Year plans.

"Don't let the memories of this holiday turn into painful regrets because of a careless gathering that led to a tragic outbreak," Allen said. "We can enjoy each other's company without being in each other's presence. We can celebrate the season together in different locations. We can show we care about one another by keeping each other safe and healthy."

**Financial Relief**

Oregon held a special session this week to address several financial needs that have been caused by the pandemic. The Legislature passed an \$800 million package that will provide relief for tenants and landlords, keep roofs over people's heads by extending the eviction moratorium and provide support for restaurants and bars. Brown said they also passed a wildfire relief package.

"I called for a special session because it is absolutely critical we get the

help to Oregonians who have made the necessary sacrifices to prevent the spread of COVID-19," Brown said.

She also acknowledged the \$900 billion pandemic relief package that passed through the United States Congress this week that includes direct stimulus payments to Americans. The bill includes \$600 to individuals making up to \$75,000 per year and \$1,200 to couples making up to \$150,000, with payments phased out for higher incomes. An additional \$600 payment will be made per dependent child, similar to the last round of relief payments in the spring of 2020. There is also a \$300 per week jobless benefit that will be distributed to individuals on unemployment, which will last until March 2021.

"(Both packages) will help carry us through the coming months as we continue to gain traction with our vaccine campaign," Brown said.

The next steps on that vaccine campaign includes widening distribution of the vaccine to people over 75 and essential workers. Brown noted Tuesday that educators and various school staff members will be at the top of the list in Oregon's next round of vaccines.

"Our kids need to know they are number one, and we are doing everything we can to get them back in our classrooms," Brown said. "This pandemic has shown us the hard truth that in person instruction is so much more than what we take for its face value. School is where our kids connect with their community, it's where many kids get meals and much needed support from caring adults."

While COVID has impacted families, it has also impacted organizations like the food bank. Through the year, the food bank traditionally hosts events to raise money and food, but in 2020, almost all were canceled.

"This is the first real thing we've done with COVID, and the best thing we've ever done," Winebarger said. "We're going to do it every year."

As the cars began to arrive, led by several members of a local car club. Winebarger said things

were going well. As cars arrived, volunteers from the food bank collected the donations, took them inside where they were weighed and placed on shelves. Before long, the food will be in the hands of people in need.

One of the early arrivers stopped and helped volunteers unload five turkeys and 60 pounds of fresh fruit. As he drove off, he smiled and said, "I did what I could."

With a steady stream of cars for 20 minutes, Winebarger said she was relieved and excited.

"This means a lot," she said. "This is exciting and it's not just exciting for us. It's exciting for the partners to see, it's exciting for the community to see. It's

After thinking for a few minutes, Garcia decided to do what she thought was best and drove to Crescent City, Calif., 30 minutes from Brookings. At the time, it made sense because Crescent City is much closer than Grants Pass or Coos Bay. “What I think is a problem is maybe someone should tell you if you cross state lines, you have to talk to the police there, too,” she said.

Over the next 16 hours, without sleep and without food and water, Garcia told her story over and over to the Brookings police, Curry County Sheriff’s Office, Crescent City police, Del Norte County Sheriff’s Office and a nurse advocate.

“You need to be able to do this one time, so you can get as much out as you can,” she said. “It was a nightmare from one end to the other. It’s a completely humiliating experience.”

But it was only starting. After a 12-hour standoff where he injured himself seriously, police eventually arrested King. He was flown by air ambulance to a hospital and recovered.

“We can give him the best care he can have, but we don’t want to invest in SANE nurses because it’s too expensive,” Garcia said.

But Garcia survived, and the worst was over. Or so she thought. When King came to trial, Garcia said the nightmare started over again. During the trial, she had to testify in public, in front of her friends, her neighbors and even her pastor, about the experience she went through. To top it off, everyone in the courtroom saw blown-up photos of her private parts during the testimony.

After her first day of testimony, Garcia remembered going to the grocery store because her children wanted ice cream. As she pushed the cart around, she saw a man who was at the courtroom that day. She said as he stared at her, and she remembered him seeing close-up photos of her body. She left the cart and ran out.

After the trial, that ordeal continued. For two years, she pretty much locked herself in her home,

afraid to venture out.

“I would go to the grocery store 10 minutes before closing,” she said. “My kids never got to go to the river. They were raped from the activities they could have been doing.”

Garcia said just living was difficult. While her rapist was locked away for 46 years, she was still not free.

“About two years later, I looked at myself in the mirror and said, ‘What are you doing?’” she recalled. “I looked at myself in the mirror and said, ‘Is this going to define you?’”

It was then she started thinking about changing the system.

“After this experience, I asked does this just happen in Curry County or does it happen in other counties, too,” she said.

It turns out, most smaller counties have similar issues. Because it’s expensive to train and keep Sexual Assault Nurse Examiners, many small counties have none. At the time, those counties and their medical facilities had no plans on how to help assault survivors. When she first looked, 15 Oregon counties had no SANE nurses, leaving 500,000 people without that service.

“Rape does not discriminate based on geography,” Garcia said. “Rape happens in small towns and big towns, so we need care in small towns and big towns. I decided I’m going to devote my time to this.”

That was when Garcia began working to change the laws in Oregon. She had lots of help, pointing to Jaculin Smith, an attorney in Oregon, sexual assault survivor Brenda Tracy and sexual assault reform advocate Leah Griffin. But the real change was when Garcia got to tell her story to Brock Smith. When Brock Smith and his team got on board, things began to happen.

HB 2375 was filed in the 2019 legislative session.

“He and his team, they just took it,” Garcia said. “It passed the committee and went to the House of Representatives. It passed there. It went to the Senate and passed there. It was all unanimous.”

Garcia was even invited to the state capital for the signing ceremony with the governor. The new law

went into effect in January, although Garcia admits COVID has delayed some elements of it.

From Garcia’s standpoint, the key element of the law is hospitals cannot turn sexual assault victims away and if they don’t have a SANE nurse, they must provide transportation to and from a location that does.

While Garcia is happy with HB 2375, she is not done. She is already working with Brock Smith and his team on two new pieces of legislation.

One would require hospitals and police to have pamphlets available that tell sexual assault survivors all their rights. While there are pamphlets available now, many list only a small portion of a victim’s rights.

The second is admittedly a little more complicated. Garcia would like to see the state’s Fair Trial Law changed so sexual assault survivors can ask for the courtroom to be cleared of spectators when graphic photos are presented or graphic testimony is going on. All attorneys, jurors and the defendant would be permitted to stay. She said having to go through that in public is nothing short of witness intimidation.

“Having strangers in the courtroom looking at your private parts, that’s witness intimidation,” she said. “I didn’t say everything 100 percent because I was so humiliated.”

Garcia said Friday she had just learned Brock Smith had filed the legislation to change the Fair Trial Law.

“It needs to be a fair courtroom, but when your body parts are up there, do you really want your neighbors sitting there?” she asked. “It’s intimidating witnesses.”

Garcia said the changes won’t help her, but there are others it will. Regardless of age or gender, sexual assault victims should be allowed to confront their abusers without intimidation, she said.

“This is not my story,” she said. “This is every survivor’s story. Think of your mother sitting on the stand with a picture of her vagina. Would you want her neighbors to see her vagina? I don’t want anyone to go

through what I went through. I don’t want anyone to sit on the stand like I did.”

While it took years for Garcia to get her life back after being assaulted and testifying, she said she has a focus now. Changing laws in Oregon is a start, but it won’t be the final story. She said she is always coming up with new ideas that could help survivors in the future.

“I really want to work on a training manual for safety personnel to appropriately interview the survivors, so they get as much information as possible,” she said.

She is also hoping to work with others like Griffin to promote federal laws. Griffin has been working with Washington Sen. Patty Murray to push the Survivors Access to Supportive Care Act. If passed, the law would provide the resources to conduct a national survey to identify where gaps are in hospitals nationwide. It would also implement federal standards of care, a grant program to expand access to SANE training, a national task force to address the quality of the exams and a national best-practices clearinghouse so healthcare providers can improve the quality of care.

Garcia admitted it is often difficult to tell her story, but if it helps others, she is willing to.

“It is a purpose, it is a mission, and if I don’t sit in front of you, who will listen?” she asked.

Thinking back on the night in 2014 when she was assaulted and the trial that tore the wounds open, Garcia admits it was terrifying and difficult. More than six years later, there are still moments that are very hard. Just last week, she was with her boyfriend when he had to stop near the house where her assault occurred. She admitted it was difficult, but she made it through.

And today, she wouldn’t change her experience.

“I would not want to be that Jessica again,” she said, referring to before her assault. “I have a voice. I don’t think people realize how important one voice is. If you assert your voice in a healthy way, and you continue to assert your voice in a healthy way, somebody will listen.”

# Bipartisan bill aims to curb price-gouging for health insurance

The Competitive Health Insurance Reform Act, bipartisan legislation introduced by Reps. Peter DeFazio (OR-04), Paul Gosar (AZ-04) and House Judiciary Committee Chairman Jerrold Nadler (NY-10) to rein in health insurance price-gouging and promote fair competition, unanimously passed the Senate this week and was expected to be signed into law. The bill passed unanimously in the House in September.

The bill, H.R. 1418, would repeal an antiquated exemption that allows health insurance companies to operate beyond the reach of federal antitrust laws and collude to set health care costs, increase profits and price gouge consumers.

“Even before the COVID-19 pandemic, nearly 1 in 4 Americans — including insured Americans — were already skipping medical care and prescription drug doses be-

cause of high costs. Today, while affordable medical care is more important than ever, health insurance companies still have free rein to price-gouge consumers and reap massive profits on the backs of seniors, working families and everyday Americans. That’s obscene,” said DeFazio. “As long as this exemption is still on the books, health insurance companies legally can collude to drive up prices, limit competition, conspire to underpay doctors and hospitals and overcharge consumers. Our bipartisan legislation will protect consumers and make sure the health insurance industry plays by the same rules as virtually every other industry in America.”

# Water bill provides key relief for Oregon coast

While much of the state was paying attention to the COVID-19 relief package that passed Congress on Monday, Congressman Peter DeFazio was celebrating another win.

DeFazio, who serves as the chair of the House Committee on Transportation and Infrastructure, said the spending bill that also passed was a big win for the nation's coastal communities. Included in the package was the Water Resources Development Act of 2020, which fully funds harbor maintenance.

"This is a tremendous victory for Oregon's coastal communities," DeFazio said. "For decades, I have fought to unlock the Harbor Maintenance Trust Fund and ensure that funds already collected for harbor maintenance are fully utilized to keep our local ports dredged and jetties maintained. Finally, WRDA 2020 fulfills that goal. With this fix, our ports and harbors will have the resources they so desperately need, all without raising taxes or adding a penny to the deficit. My bipartisan bill, approved by both the House and the Senate, will create and sustain jobs on the coast, make conditions safer for Oregon's commercial fishing and recreation industries and boost our state and national economic competitiveness."

DeFazio explained Congress passed a small tax

while Ronald Reagan was president to fund harbor maintenance. But over the last decade, Congress has withheld some of that money, which accumulated to \$10 billion.

When the spending bill passed, the money was unlocked and will be spent over the next decade. DeFazio said beginning in 2021, \$500 million in extra funding will be released every year, with the number climbing to \$1 billion in the sixth year.

"By unlocking the Harbor Maintenance Trust Fund, my legislation will ultimately provide up to \$3 billion annually for port maintenance around the country and right here in Oregon," he said. "I also successfully pushed for a 50 percent increase in funding for small harbors, like the Port of Gold Beach and the Port of Siuslaw, and for a provision that allows harbor maintenance funds to be seamlessly spent on the maintenance of adjacent marinas. This funding will be put to immediate use paying for planned projects such as the Coos Bay North Jetty rehabilitation and maintenance dredging along the coast."

DeFazio said the Water Resources Development Act twice passed the House unanimously, but the Senate refused to take it up for consideration. That left no choice but to attach it to the spending bill that was approved by Congress on Monday.

DeFazio said the addi-

tional funding will help offset years of deferred maintenance at ports and harbors across Oregon and the nation.

"This is going to be big," he said. "The North Jetty at Coos Bay has needed repairs for a long time. When jetties start to go, they go quickly. This assistance will help us go forward with the North Jetty repair."

DeFazio also pointed to a dredging project at the Gold Beach harbor as much needed. He said so much gravel has washed into the harbor that the Coast Guard had to remove its boat from the area. Most boats can only enter and exit at high tides due to the built-up silt. With the funding, not only can the harbor be dredged, but work can be done upriver to keep rocks from flowing in for several years.

At Port Orford, the funding will help reconfigure the jetty or put in a permanent dredging system.

"It's really good for coastal communities," he said. "We've got to dredge these. We lose people on the harbor bars up and down the coast every year."

DeFazio said he also got funding for the Coast Guard attached to the spending bill. The legislation will fully fund the Coast Guard and will keep an air station in Newport that was in danger of closing.

While DeFazio said he would have preferred to pass the legislation

independently, he was forced to attach it to the spending bill when the Senate refused to consider it. The \$10 billion surplus will help make repairs and finish dredging projects at all the harbors across the nation over the next decade, the congressman said.

### COVID-19 relief

DeFazio said the package that was approved by Congress was not perfect, but it was nice to see something done.

"It is not as much as I would have liked," he said. "This got restarted by a bipartisan group in the House and I weighed in and said, 'Hey, this may not be what we like, but we

have to do something.'"

DeFazio said even the imperfect package will help Oregon residents. He said 100,000 Oregonians who would have lost unemployment this month will continue to receive it. He also said federal money will go to tenants and landlords to stop evictions, and money would go to small businesses that need it most.

"That should provide particular relief to restaurants, gyms and other small businesses that have been impacted by coronavirus restraints," DeFazio said.

While DeFazio has been spending most of his time in Oregon to limit travel during the pandemic, he said he would return to

Washington D.C. early in the new year. He will be sworn in for a new term Jan. 3 and will take part in the Electoral College vote Jan. 6. DeFazio said he expects some Republicans to protest the results but was confident nothing would change.

"They could drag it out for a few days, but the result is preordained," he said. "This craziness has got to stop at some point so we can get back to the business of helping the country."

DeFazio said he anticipates the new Congress will take up more COVID relief discussions, but the end result is uncertain.

"There's a lot of room for improvement," he said.

# Merkley, Thune introduce legislation to support small food processors

U.S. Sen. Jeff Merkley and U.S. Sen. John Thune (R-S.D.) recently introduced the Strengthening Local Processing Act, bipartisan legislation that would provide much-needed federal support to America's small meat and poultry processors and help strengthen and streamline their operations. The legislation would give small food processors more access to information that is critical to food safety planning, allow more inspector-approved meat products to be sold across state lines and funnel federal dollars toward training, education and technical assistance grants. Sens. Susan Collins (R-Maine) and Angus King (I-Maine) are original co-sponsors of this legislation.

"Dedicated workers across our food supply chains in every corner of our country work hard to ensure that when we go to our local grocery stores, there will be plenty of food on the shelves for our families," said Merkley. "But now — as the coronavirus pandemic continues to upend every aspect of our economy — our food processors, especially small plants that have been hit particularly hard, need help. This bipartisan bill would help provide these plants with valuable support, while also strengthening our food safety inspections

and cutting red tape."

"The pandemic has created significant challenges to our nation's food supply chain, especially when it comes to meat processing capacity," said Thune. "South Dakota's producers work hard to raise high-quality livestock, and we need to invest in expanding processing capacity to help meet consumer demand for their products. I'm proud to introduce this bipartisan legislation to support small meatpackers and to create additional marketing options for livestock producers."

"The supply chain disruptions and restaurant closures caused by the COVID-19 pandemic have placed increasing financial pressure on Maine's rural farming communities, including our small farms that raise livestock," said Collins. "This bipartisan bill would provide some relief by clearing unnecessary, bureaucratic hurdles, which would ensure that the livestock raised in Maine can also be processed right here in our state by local, family-owned food processors and butchers."

"Maine's small family farms and meat and poultry processors are key building blocks of communities across our state, providing healthy, locally raised meat for their neighbors

and making important contributions to the local economy," said King. "I'm proud to work with Senators Thune and Merkley to empower small processors to do their jobs and grow their businesses. It's our hope that this legislation will act as a helping hand in these difficult times by directing resources and investments to where they can do much good and bolster local economies around the country."

### Heard's actions fell short of standards

In a 2018 interview, our own State Sen. Dallas Heard (R-Roseburg) admitted that he had once been, in his own words, "a loudmouth radical," and called some of his past public statements "non-thinking," "juvenile" and "boorish."

Unfortunately, that version of Heard returned Monday at the State Capitol in Salem.

After openly encouraging a mob of some 300 heavily armed Proud Boys and other far-right radicals to forcibly crash a special session of the legislature (they smashed glass doors and attacked courageous state troopers with bear spray but were held back), Heard made a fool of himself on the Senate floor by accusing his Democratic colleagues of a "campaign against the people and the children of God" and an "unchecked assault" against freedom, among other offenses.

According to news accounts, Heard then proclaimed a 30-second personal anti-mask protest, yanked off his mask, yelled at the Senate president and stormed ridiculously out of the session.

The public re-emergence

The Strengthening Local Processing Act would require the Food Safety Inspection Service to establish a searchable database of peer-reviewed, publicly available studies to establish and maintain Hazard Analysis and Critical Control Points plans. This step would help small food processors develop their own HACCP plans and help expedite the HACCP approval process.

To incentivize more

states to establish meat and poultry inspection programs — which small food processors need to approve their products — the legislation would increase the federal government's cost-share for the programs from 50 percent to 65 percent. The bill would also allow state-inspected meat facilities to operate as federal inspection facilities, allowing more small and local processors to ship their products to other

states and countries.

Lastly, the Strengthening Local Processing Act would create a grant program to support small plants by providing reimbursement grants to help cover costs associated with meeting state or federal inspection guidelines, expanding infrastructure to establish or increase harvest and processing capacity, and adapting to the COVID-19 pandemic and future market needs.


**FIANCEE LOSES SLEEP OVER WIDOWER'S MANY MEMENTOS**

"They're in therapy right now," Knoll said. "They're doing stuff every day, about eight hours a day."

Even still, it's hard to predict what the outcome

of that therapy could be. But just because only Abblitt and his mother are now in Colorado away from home, that doesn't mean he's alone. Abblitt's family has set up an online community to support his recovery, including a website, donation platform and online shop.

"I've had five donors

from Japan give because they saw his story on a Japanese surf website," Knoll said.

The family's developed a slogan, morphing it into a hashtag and a logo for T-shirts and wristbands: "#zacsHope."

"It has kind of this double meaning. Zac's hope is to be whole again," Knoll said. "But the real meaning behind the hashtag is that Zac's hope is Jesus."

Abblitt and the family have seen a lot of support from their church community, and Knoll said they're confident the injury and road to recovery are all part of God's plan.

"If we just focus on what's happening, it's very discouraging," Knoll said, adding that trusting in their faith keeps them optimistic. "This is Zac's purpose right now."

The family also points to a Bible verse, Hebrews 12:1-3, for inspiration. It's printed on some of the T-shirts they've gotten made to support Abblitt's recovery.

"...Let us run with endurance the race that is set before us, looking unto Jesus the author and finisher of our faith..." the verse says in part.

Again, Knoll said there's a double meaning behind the choice. First, that Abblitt is in the "race of his life" to rehabilitate himself and regain his usual function.

"But again, it's not the biological and physical that we're ultimately focused on," Knoll said. Instead, the family is focused on Abblitt as an example of rehabilitation and the power of faith.

That road to recovery will likely be a long, and

expensive one. But Knoll said the family is all behind him, rallying around the idea of "zacsHope."



NOTICE OF ADOPTION  
ORDINANCE NO. 824

AN ORDINANCE OF THE CITY COUNCIL AND THE PEOPLE OF THE CITY OF CRESCENT CITY ADDING CHAPTER 3.30 TO TITLE 3 OF THE CRESCENT CITY MUNICIPAL CODE IMPOSING A TRANSACTIONS AND USE TAX TO BE ADMINISTERED BY THE CALIFORNIA DEPARTMENT OF TAX AND FEE ADMINISTRATION

NOW, THEREFORE, the City Council and the People of the City of Crescent City, State of California, do ordain as follows:

SECTION 1

The Crescent City Municipal Code is amended by adding Chapter 3.30, Transactions and Use Tax, to Title 3, Revenue and Finance, as follows:

TITLE 3 – REVENUE AND FINANCE

CHAPTER 3.30 – TRANSACTIONS AND USE TAX

3.30.010 Title. This chapter will be known as the "Crescent City Transactions and Use Tax Ordinance" and referred to herein as "this Ordinance."

3.30.020 Operative Date. "Operative Date" means the first day of the first calendar quarter commencing more than 110 days after the adoption of this Ordinance, the date of such adoption being as set forth below.

3.30.030 Purpose. This Ordinance is adopted to achieve the following, among other purposes, and directs that the provisions hereof be interpreted in order to accomplish those purposes:

A. To impose a retail transactions and use tax in accordance with the provisions of Part 1.6 (commencing with Section 7251) of Division 2 of the Revenue and Taxation Code and Section 7285.9 of Part 1.7 of Division 2 which authorizes the City to adopt this tax ordinance which shall be operative if a majority of the electors voting on the measure vote to approve the imposition of the tax at an election called for that purpose.

B. To adopt a retail transactions and use tax ordinance that incorporates provisions identical to those of the Sales and Use Tax Law of the State of California insofar as those provisions are not inconsistent with the requirements and limitations contained in Part 1.6 of Division 2 of the Revenue and Taxation Code.

C. To adopt a retail transactions and use tax ordinance that imposes a tax and provides a measure therefore that can be administered and collected by the California Department of Tax and Fee Administration in a manner that adapts itself as fully as practicable to, and requires the least possible deviation from, the existing statutory and administrative procedures followed by the California Department of Tax and Fee Administration in administering and collecting the California State Sales and Use Taxes.

D. To adopt a retail transactions and use tax ordinance that can be administered in a manner that will be, to the greatest degree possible, consistent with the provisions of Part 1.6 of Division 2 of the Revenue and Taxation Code, minimize the cost of collecting the transactions and use taxes, and at the same time, minimize the burden of record keeping upon persons subject to taxation under the provisions of this Ordinance.

3.30.040 Contract with State. Prior to the operative date, the City must contract with the California Department of Tax and Fee Administration to perform all functions incident to the administration and operation of this transactions and use tax ordinance; provided, that if the City has not contracted with the California Department of Tax and Fee Administration prior to the operative date, it must nevertheless so contract and in such a case the operative date will be the first day of the first calendar quarter following the execution of such a contract.

3.30.050 Transactions Tax Rate. For the privilege of selling tangible personal property at retail, a tax is hereby imposed upon all retailers in the incorporated territory of the City at the rate of 1.0% of the gross receipts of any retailer from the sale of all tangible personal property sold at retail in said territory on and after the operative date of this Ordinance.

3.30.060 Place of Sale. For the purposes of this Ordinance, all retail sales are consummated at the place of business of the retailer unless the tangible personal property sold is delivered by the retailer or his agent to an out-of-state destination or to a common carrier for delivery to an out-of-state destination. The gross receipts from such sales include delivery charges, when such charges are subject to the state sales and use tax, regardless of the place to which delivery is made. In the event a retailer has no permanent place of business in the State or has more than one place of business, the place or places at which the retail sales are consummated will be determined under rules and regulations to be prescribed and adopted by the California Department of Tax and Fee Administration.

3.30.070 Use Tax Rate. An excise tax is hereby imposed on the storage, use or other consumption in the City of tangible personal property purchased from any retailer on and after the operative date of this Ordinance for storage, use or other consumption in said territory at the rate of 1.0% of the sales price of the property. The sales price includes delivery charges when such charges are subject to state sales or use tax regardless of the place to which delivery is made.

3.30.080 Adoption of Provisions of State Law. Except as otherwise provided in this Ordinance and except insofar as they are inconsistent with the provisions of Part 1.6 of Division 2 of the Revenue and Taxation Code, all of the provisions of Part 1 (commencing with Section 6001) of Division 2 of the Revenue and Taxation Code are hereby adopted and made a part of this Ordinance as though fully set forth herein.

3.30.090 Limitations on Adoption of State Law and Collection of Use Taxes. In adopting the provisions of Part 1 of Division 2 of the Revenue and Taxation Code:

A. Wherever the State of California is named or referred to as the taxing agency, the name of this City is to be substituted therefor. However, the substitution will not be made when:

1. The word "State" is used as a part of the title of the State Controller, State Treasurer, State Treasury, or the Constitution of the State of California;

2. The result of that substitution would require action to be taken by or against this City or any agency, officer, or employee thereof rather than by or against the California Department of Tax and Fee Administration, in performing the functions incident to the administration or operation of this Ordinance.

3. In those sections, including, but not necessarily limited to sections referring to the exterior boundaries of the State of California, where the result of the substitution would be to:

a. Provide an exemption from this tax with respect to certain sales, storage, use or other consumption of tangible personal property which would not otherwise be exempt from this tax while such sales, storage, use or other consumption remain subject to tax by the State under the provisions of Part 1 of Division 2 of the Revenue and Taxation Code, or;

b. Impose this tax with respect to certain sales, storage, use or other consumption of tangible personal property which would not be subject to tax by the state under the said provision of that code.

4. In Sections 6701, 6702 (except in the last sentence thereof), 6711, 6715, 6737, 6797 or 6828 of the Revenue and Taxation Code.

B. The word "City" is to be substituted for the word "State" in the phrase "retailer engaged in business in this State" in Section 6203 and in the definition of that phrase in Section 6203.

1. "A retailer engaged in business in the District" also includes any retailer that, in the preceding calendar year or the current calendar year, has total combined sales of tangible personal property in this state or for delivery in the State by the retailer and all persons related to the retailer that exceeds five hundred thousand dollars (\$500,000). For purposes of this section, a person is related to another person if both persons are related to each other pursuant to Section 267(b) of Title 26 of the United States Code and the regulations thereunder.

3.30.100 Permit Not Required. If a seller's permit has been issued to a retailer under Section 6067 of the Revenue and Taxation Code, then an additional transactor's permit is not required by this Ordinance.

A. There will be excluded from the measure of the transactions tax and the use tax the amount of any sales tax or use tax imposed by the State of California or by any city, county, or county pursuant to the Bradley-Burns Uniform Local Sales and Use Tax Law or the amount of any state-administered transactions or use tax.

B. There are exempted from the computation of the amount of transactions tax the gross receipts from:

1. Sales of tangible personal property, other than fuel or petroleum products, to operators of aircraft to be used or consumed principally outside the county in which the sale is made and directly and exclusively in the use of such aircraft as common carriers of persons or property under the authority of the laws of this State, the United States, or any foreign government.

2. Sales of property to be used outside the City which is shipped to a point outside the City, pursuant to the contract of sale, by delivery to such point by the retailer or his agent, or by delivery by the retailer to a carrier for shipment to a consignee at such point. For the purposes of this paragraph, delivery to a point outside the City will be satisfied:

a. With respect to vehicles (other than commercial vehicles) subject to registration pursuant to Chapter 1 (commencing with Section 4000) of Division 3 of the Vehicle Code, aircraft licensed in compliance with Section 21411 of the Public Utilities Code, and undocumented vessels registered under Division 3.5 (commencing with Section 9840) of the Vehicle Code by registration to an out-of-City address and by a declaration under penalty of perjury, signed by the buyer, stating that such address is, in fact, his or her principal place of residence; and

b. With respect to commercial vehicles, by registration to a place of business out-of-City and declaration under penalty of perjury, signed by the buyer, that the vehicle will be operated from that address.

3. The sale of tangible personal property if the seller is obligated to furnish the property for a fixed price pursuant to a contract entered into prior to the operative date of this Ordinance.

4. A lease of tangible personal property which is a continuing sale of such property, for any period of time for which the lessor is obligated to lease the property for an amount fixed by the lease prior to the operative date of this Ordinance.

5. For the purposes of subparagraphs (3) and (4) of this section, the sale or lease of tangible personal property will be deemed not to be obligated pursuant to a contract or lease for any period of time for which any party to the contract or lease has the unconditional right to terminate the contract or lease upon notice, whether or not such right is exercised.

C. There are exempted from the use tax imposed by this Ordinance, the storage, use or other consumption in this City of tangible personal property:

1. The gross receipts from the sale of which have been subject to a transactions tax under any state-administered transactions and use tax ordinance.

2. Other than fuel or petroleum products purchased by operators of aircraft and used or consumed by such operators directly and exclusively in the use of such aircraft as common carriers of persons or property for hire or compensation under a certificate of public convenience and necessity issued pursuant to the laws of this State, the United States, or any foreign government. This exemption is in addition to the exemptions provided in Sections 6366 and 6366.1 of the Revenue and Taxation Code of the State of California.

3. If the purchaser is obligated to purchase the property for a fixed price pursuant to a contract entered into prior to the operative date of this Ordinance.

4. If the possession of, or the exercise of any right or power over, the tangible personal property arises under a lease which is a continuing purchase of such property for any period of time for which the lessee is obligated to lease the property for an amount fixed by a lease prior to the operative date of this Ordinance.

5. For the purposes of subparagraphs (3) and (4) of this section, storage, use, or other consumption, or possession of, or exercise of any right or power over, tangible personal property shall be deemed not to be obligated pursuant to a contract or lease for any period of time for which any party to the contract or lease has the unconditional right to terminate the contract or lease upon notice, whether or not such right is exercised.

6. Except as provided in subparagraph (7), a retailer engaged in business in the City will not be required to collect use tax from the purchaser of tangible personal property, unless the retailer ships or delivers the property into the City or participates within the City in making the sale of the property, including, but not limited to, soliciting or receiving the order, either directly or indirectly, at a place of business of the retailer in the City or through any representative, agent, canvasser, solicitor, subsidiary, or person in the City under the authority of the retailer.

7. "A retailer engaged in business in the City" also includes any retailer of any of the following: vehicles subject to registration pursuant to Chapter 1 (commencing with Section 4000) of Division 3 of the Vehicle Code, aircraft licensed in compliance with Section 21411 of the Public Utilities Code, or undocumented vessels registered under Division 3.5 (commencing with Section 9840) of the Vehicle Code. That retailer will be required to collect use tax from any purchaser who registers or licenses the vehicle, vessel, or aircraft at an address in the City.

D. Any person subject to use tax under this Ordinance may credit against that tax any transactions tax or reimbursement for transactions tax paid to a district imposing, or retailer liable for a transactions tax pursuant to Part 1.6 of Division 2 of the Revenue and Taxation Code with respect to the sale to the person of the property the storage, use or other consumption of which is subject to the use tax.

3.30.120 Amendments. All amendments subsequent to the effective date of this Ordinance to Part 1 of Division 2 of the Revenue and Taxation Code relating to sales and use taxes and which are not inconsistent with Part 1.6 and Part 1.7 of Division 2 of the Revenue and Taxation Code, and all amendments to Part 1.6 and Part 1.7 of Division 2 of the Revenue and Taxation Code, will automatically become a part of this Ordinance, provided however, that no such amendment will operate so as to affect the rate of tax imposed by this Ordinance.

3.30.130 Enjoining of Collection Forbidden. No injunction or writ of mandate or other legal or equitable process may issue in any suit, action or proceeding in any court against the State or the City, or against any officer of the State or the City, to prevent or enjoin the collection under this Ordinance, or Part 1.6 of Division 2 of the Revenue and Taxation Code, of any tax or any amount of tax required to be collected.

3.30.140 Oversight Committee. A seven-member oversight committee will be created and meet annually to review and publicly report on the expenditure of revenues generated by the tax imposed by this Ordinance. The committee will include the City Manager or designee, the City Finance Director or designee, and five residents of the City. Resident members of the committee will be appointed to two-year terms by the Mayor and confirmed by the City Council. The City Manager and City Finance Director will serve as non-voting members of the committee.

3.30.150 Independent Annual Audit. The proceeds of the tax imposed by this Ordinance, as well as the expenditures thereof, will be audited annually by an independent accounting firm.

3.30.160 Severability. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid by a court of competent jurisdiction, then the remainder of the Ordinance and the application of such provision to other persons or circumstances will not be affected thereby.

3.30.170 Effective Date. This Ordinance relates to the levying and collecting of the City transactions and use tax and will take effect immediately upon its approval by the voters.

3.30.180 Termination Date. The authority to levy the tax imposed by this Ordinance will expire upon repeal by the voters of the City of Crescent City.

SECTION 2

This Ordinance will be effective only if a majority of votes cast on the measure at an election to be called for such purpose vote to approve the Ordinance. The Mayor shall sign and the City Clerk shall attest to the passage of this Ordinance upon certification by the City Council of the results of the election approving this Ordinance.

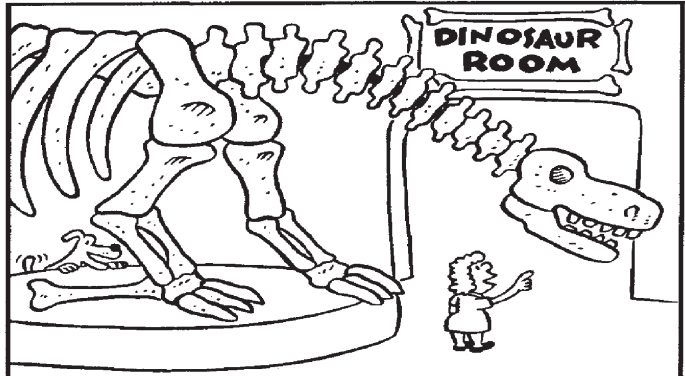

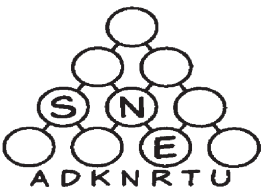

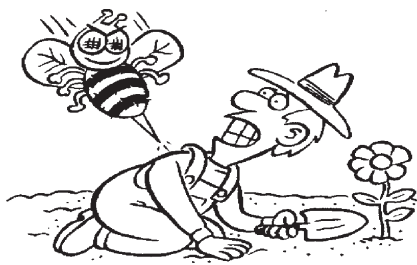
