COVID cases fall, but 'not out of the woods yet'

"We're not out the woods yet." That was the dominant theme of the second Curry County Town Hall on COVID-19 held Wednesday evening via zoom and expressed by Doctor Tom Jeanne from the Oregon Health Authority.

14 new cases were tallied by OHA on October 26, and the average number of new cases per week in Curry County is roughly five. The county is modeling closely to the national numbers, showing a decrease since a large spike in August of 134 new cases on the 16th and another smaller spike in September.

In total, Curry County has reported 25 deaths and 1,827 cases. But Wednesday's presentation also documented an uptick in vaccinations to 63% of Curry County residents having at least one shot. A fact which Olivia Davis from the Brookings Harbor Community Food Bank drove home with her personal story of contracting COVID-19 despite being vaccinated with the Johnson and Johnson vaccine.

"I was very, very sick. I didn't know if I was going to make it. I'm a two time cancer survivor and a diabetic. I'm here because I had that shot. Take it from me," she said.

Her group, The Brookings Harbor Community Food Bank, The Curry County Homeless

Gold Beach to discuss moving power lines

A workshop to discuss the possibility of funding a feasibility study to pursue moving unsightly power lines underground at a projected cost of up to \$6 million will be held prior to the Gold Beach City Council meeting Dec. 6, at 6 p.m.

Gold Beach Main Street, a group that's made impressive strides to improve the livability, safety and aesthetics of the town, is asking the city to invest in a feasibility study to determine whether power lines along Highway 101 - on land owned by the state - can be buried. Just prior to the Nov. 1 city council meeting, the council members convened as the city's Urban Renewal Agency to discuss the matter.

"The city doesn't have a dog in this fight, so to speak," stated staff reports submitted to the URA prior to the meeting.

Staff reports further stated that "while it is understood that a segment of locals are deeply committed to removal of the visual clutter of the utility poles on Highway 101, removal of the visual clutter comes at hideously expensive estimated cost - especially considering the depressed economic condition of Gold Beach, Curry County and the SW Coast region generally." Elsewhere in Gold Beach, where property is not owned by an outside government entity, power lines have already been placed underground.

GBMS has partnered with the URA and Oregon Community Foundation before - most recently to bring several benches and improved landscaping to several public and private properties within the city.

Changes needed to protect the ocean, world

As climate change begins to impact the ocean, legislative action could help the ocean be one of the ways to solve the problem. That's the message Jean Flemma, director of the Ocean Defense Initiative, shared last week during a discussion with the Oregon Shores Conservation Coalition.

And the rest of the country would be better off if it followed Oregon's lead, she said.

"Oregon was ahead of the curve when it came to ocean planning," Flemma said. "As much as Oregon was a leader in ocean planning 30 years ago, the state is still a leader today."

Flemma said as the climate changes, the ocean is overwhelmingly impacted.

"The climate crisis is an ocean crisis," she said. "The ocean has been capturing our global climate emissions, and it has been absorbing the heat."

Flemma listed ways the ocean has struggled due to climate change, pointing to rising sea levels, coral bleaching, toxic algae, acidification and struggles in the fishing industry. But as much as the ocean has changed, it can be a part of the solution, if local, state and federal politicians are willing to act.

"Here in the U.S., integral ocean policy was somewhat stymied the last four years at the

### A Japanese-American internment camp has much to teach us

“While other children were sent to daycare, when I was 3 years old I was sent to a Japanese-American prison,” Carlene Tanigoshi Tinker, now 82, told the Washington Post recently. She was one of some 120,000 Americans of Japanese ancestry who were forcibly imprisoned during World War II, a time when racist fears swept the country.

After traveling in a railroad car from the West Coast, Tanigoshi and her family arrived at a prison camp close to Kansas that became known as Amache. The military-style barracks were laid out on a barren landscape in lightly populated eastern Colorado. It was one of 10 such prisons hastily erected in America during the 1940s.

Now, thanks to a bill that passed the House and is now before the Senate, there’s a good chance that Amache will become a new national historical park, telling its story of mass hysteria, hardship and survival.

Tanigoshi, who I met at Amache recently, said that the people imprisoned were patriotic Americans, and after men in the local town of Granada joined the military and labor became scarce, camp prisoners filled in at harvest time, mostly as volunteers. The need to harvest the main crop of sugar beets set the stage for camp residents and locals to trust each other.

Once Amache Director James Lindley got to know the incarcerated families, he began to relax restrictions, opening the door for a new community to form. Teachers were allowed to move into the camp to be closer to their students. He also allowed internees to work at other jobs in Granada, one mile away, and permitted camp residents to go to town for social activities such as seeing a movie or going to a soda fountain. According to reports told of the camp, Amache was humanely run, the place internees in other camps wanted to transfer into.

Living conditions, however, were grim for the approximately 7,000 people who were never allowed to protest their incarceration. Still, 441 men from the camp served in our military during World War II.

When the camp was closed after three years, its origin story was mostly neglected. But in 1993, Granada High School teacher John Hopper asked his students if they’d like to do

some volunteer work, helping to restore the camp’s water tower and signs and any structures that remained standing. The students were enthusiastic, he said in an interview, and so began the Amache Preservation Society that continues to maintain the site today, along with other volunteer groups.

“Generations of kids and their parents have worked to keep Amache’s history alive,” said Hopper, who is now school principal. “Students travel all over, including Japan, to tell the story of how the camp came to be and what it was like.”

Another frequent visitor is Bonnie Clark, archaeologist at Denver University. Since 2008, she and her team, some descendants of internees, have been researching life at the camp.

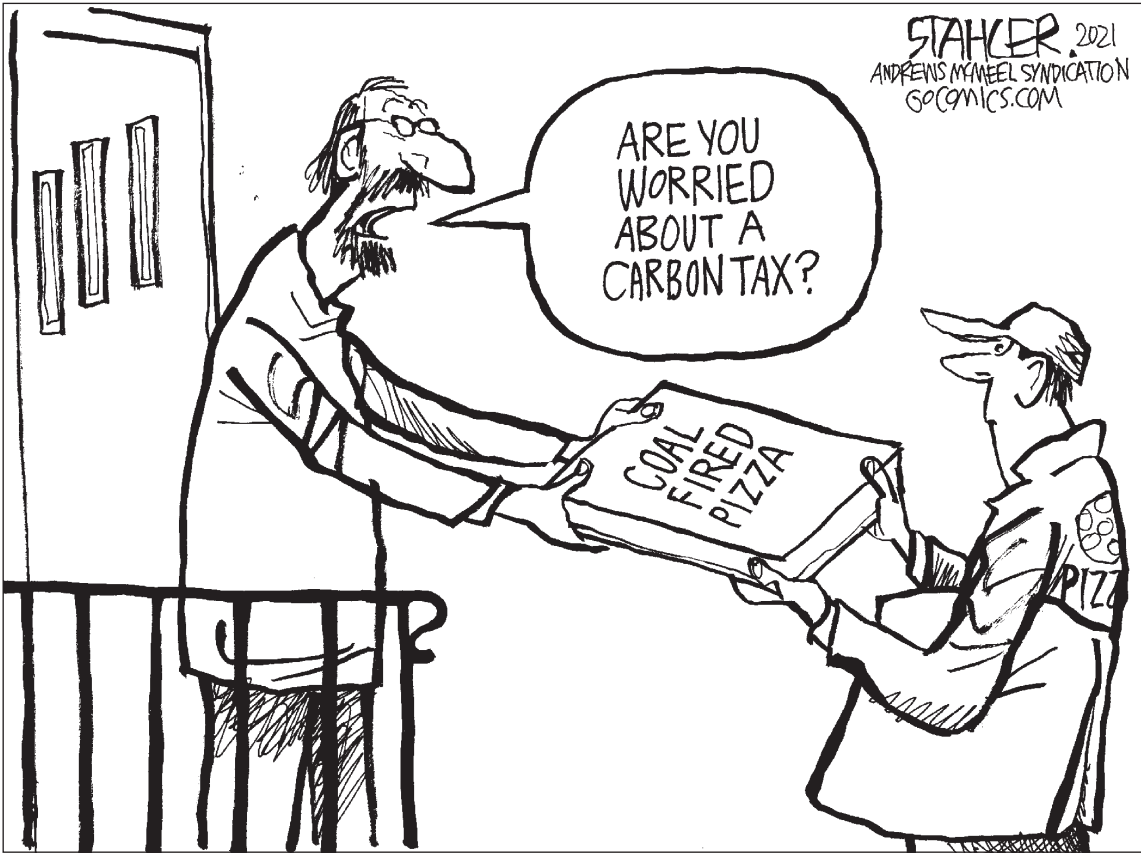
When I visited the camp and its museum, one of her team, Greg Kitajima, showed me butterflies made from tiny seashells that his mother made when she was an internee. The layered shells give shape to the insect forms; the pastel stripes of the shells add delicate color to the shapes. Greg also tells me stories he heard from his grandparents, strawberry farmers in San Jose, California, who suffered severe discrimination as war fever swept through America. They, too, were sent to Amache. His eyes well up as he shares the memories. It is painful to hear. My eyes tear up, too.

I believe that the move by four Colorado Congressmen to designate Amache a national historic site is one that can bring us together. This place of deprivation, yet community, needs to be preserved.

Late in the day, when I’m walking around the camp’s recreation hall, bunkhouse and a guard tower, the setting sun mellows the landscape. I think about what Greg told me, about how his family feels linked to this place. They were people who made the best of a bad situation – the best they could.

Amache’s power is that it invites us to listen and learn from the past, to renew our sense of humanity. Perhaps Amache can help to heal our nation’s troubled soul.

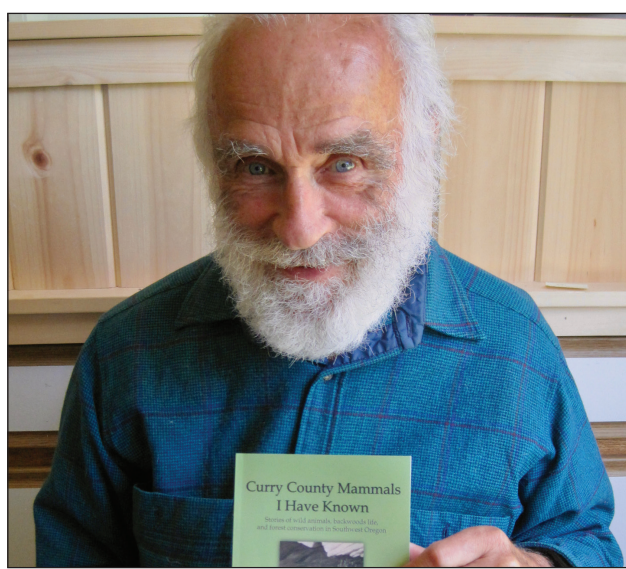

## Local author releases new book

Jim Rogers has written a book of short stories about the wild animals that he’s encountered through his life as a woodsman: Curry County Mammals I Have Known: stories of wild animals, backwoods life, and forest conservation in Southwest Oregon.

Rogers is best known as an industry-forester turned environmentalist who led efforts to protect both the Grassy Knob and Copper Salmon wilderness areas up Elk River. The book captures some of Rogers’ wealth of knowledge and experiences in local forests. His stories offer scientific information with a personal touch as he shares his experiences with wild animals, offering local insight and often the opportunity for a good laugh.

His stories first appeared in a popular column in the newsletter of the Kalmiopsis Audubon Society, a local conservation group that Rogers helped to found more than 40 years ago. According to the group’s President Ann Vileisis, “Jim Rogers knows the backwoods of Curry County better than anyone and has a one-of-a-kind voice as a local woodsman, hunter and conservationist.” Kalmiopsis Audubon published the book in order to share Rogers’ writings with a broader audience. compiled by Teresa Bird, who has long admired Rogers’ knowledge of and love for Curry County’s forests — and felt that everyone in the area would love to share in his encounters with animals through his gift of storytelling. It includes an introduction by Ann Vileisis about his unique life path and why he’s been so important to the history of conservation in our region.

The final essay is one Rogers wrote about his personal transformation from timber manager to conservationist and his efforts to protect the Grassy Knob Wilderness. Michael Kauffman, noted author of the book Conifer Country,

offered this comment after reviewing the book: “With observations made across decades, Jim has nurtured deep connections with the natural world. His stories, weaving personal tales with scientific understandings, give us all a path to better know and connect with the wild mammals of this place.”

political level,” she said.

Flemma said politicians need to act on several different levels, the first being harnessing the ocean’s power to address climate change.

She specifically pointed to the prospect of expanding win energy in the ocean in an effort lessen the demand for fossil fuels.

Second would be to increase the ocean’s resiliency to climate change, and finally, protect the ocean’s ability to capture carbon.

“To put any of these policies in place, Congress, administration, state and local governments will have to continue to take action,” Flemma said. “There’s a lot of hope the

Ocean Climate Act we want to see will be included in the reconciliation package.”

The first step Flemma wants to see is a permanent ban on offshore drilling.

“Why the Biden administration did pause offshore drilling, the ban has already been lifted,” she said.

Flemma said both Oregon senators, Jeff Merkley and Ron Wyden are pushing for a permanent drilling ban.

In addition, governments need to push for more clean energy offshore.

“We need to scale up clean offshore energy,” Flemma said. “The administration has committed to getting 30 gigawatts of offshore energy by 2030, but 30 gigawatts is not that much.”

Flemma said Oregon must see changes if it

wants to continue as the state we know and love.

“In Oregon, the coast defines what we are,” she said. “Looking ahead, we have right now in the reconciliation process, the ability to collect \$2 billion for projects for the ocean. We could be looking at \$7-\$10 billion for ocean restoration projects. Should this money actually appear, this will be a huge opportunity for Oregon.”

Overall, up to \$500 billion could be included in federal money to combat climate change, she said.

“The devil will be in the details,” Flemma said. “Where is the money going to? The next few weeks we will learn a lot more about that. Depending on what does happen in the reconciliation process, there’s going to need to be a lot more that needs to get done.”

Coalition and Saint Timothy’s Episcopal Church were all on hand to let the public know they are offering food, rental and mortgage assistance as well as help paying utility bills so people who become ill with the coronavirus can afford to isolate and recover.

“We want people to be able to quarantine so they don’t go out in the community and spread the virus,” said Homeless Coalition Executive Director Beth Barker-Hidalgo.

She reported that her organization has helped roughly 120 households with housing, utility and food assistance so far and they’ve offered 12 vaccine clinics.

They’ve also hired a new staff member who is bilingual and able to help Spanish speaking community members. Barker-Hidalgo says the coordination between agencies has helped people who might otherwise not have come through the pandemic. “It’s been an amazing response.”

Father Bernie from Saint Timothy’s Episcopal Church told the audience they’ve been coordinating testing and vaccination clinics three days per week. “Just today we were responsible for 45 vaccinations,” he said.

In 1992 the state required all water customers to be required to hve meters installed for waste and water conservation purposes. A few residences within the district do not have water meters. Since they are required by state law the district is considering an ordinance to allow property owners to install the meters in accordance with the district's specifications or if they do not, by a certain time the district will install the meters and charge or assess the property for the district's costs of installation. It is estimated that installation will cost \$1,160 per residence but the cost will vary depending on the time and labor needed to locate each water line.

The ordinance requires: a) its customers to comply with the district's rules and regulations; b) to allow the district access to service the facilities; c) to install or have installed the required water meter; d) imposes the charge of the direct cost of installation and creates a property assessment on the benefited property if the district's invoice is not paid; e) establishes time limitations for the election of whether the property owner or the district will perform the installation; f) finds the ordinance, if adopted exempt from CEQA; and informs its customers how to protest or object to the charge.

## Oregon children ages 5 through 11 expected to become eligible for Pfizer COVID-19 vaccines; doses expected to be available this week

The Centers for Disease Control and Prevention’s Advisory Committee on Immunization Practices voted 14-0 to recommend the pediatric Pfizer-BioNTech vaccine for 5- through 11-year-old children. Once the approval process is complete, an estimated 330,000 children across Oregon will be eligible to receive the vaccine.

This afternoon, Oregon Health Authority expects the CDC’s director to endorse ACIP’s decision. Then, the Western States Scientific Safety Review Workgroup, composed of health experts in Oregon, Washington, California and Nevada, will meet this evening to consider the recommendation. If approved, Governor Brown’s office

will announce the decision. As early as Wednesday, state health officials will issue standing orders that will allow providers to begin administering vaccinations to children 5 years and older as soon as supplies become available.

OHA is currently helping prepare provider sites around the state to begin administering the vaccine.

State health officials expressed their optimism about vaccinations for younger children. They also cautioned parents and caregivers to be patient as states await sufficient supplies of doses from the federal government in coming weeks.

“We are excited to be able to start immunizing school-age children

against COVID-19, which should bring relief to many parents and guardians, and those who work in education and child care,” said OHA Director Patrick Allen. “We hope vaccinating kids will help our communities continue to build population immunity that will protect our children, help keep them in school and ultimately bring this pandemic to an end.”

The Food and Drug Administration authorized the vaccine for 5- through 11-year-olds on Oct. 26 after a Vaccines and Related Biological Products Advisory Committee review that found it safe and effective for this age group.

The federal government has a standard allocation

system across all states. Roughly 120,000 initial, pre-order doses are coming to Oregon and have been ordered by vaccination providers. With delivery anticipated this week through Nov. 8, the supply will go to approximately 350 provider sites across the state, guided by our goals to protect children and end health disparities among communities of color. Vaccines will also arrive in Oregon within days after the anticipated go-live for vaccinating children ages 5 through 11. Every county has sites receiving pre-order shipments, and every enrolled provider that filed a request for doses was offered vaccine.

In addition, 60,000 doses were offered to

pharmacy chains by the federal government. Those were allocated via a federal process with orders going to 87 pharmacy sites.

OHA estimates the 180,000 total Pfizer doses are likely a four- to six-week supply of vaccine. The state has been informed it will have access to tens of thousands of doses to order for shipment on Nov. 9, again on Nov. 18 and thereafter on a periodic basis.

“Once the COVID-19 pediatric vaccine gains final approval, it may take a few days before it will be widely available. We strongly recommend you contact your healthcare provider, community health center, clinic or local pharmacy before

bringing your child in to be vaccinated,” said Director Allen. “OHA is also working with the Oregon Department of Education, local public health authorities, the health care industry, community-based organizations and additional vaccine providers to make doses readily available at public and private schools, child care facilities, community sites and other locations easily accessible to families and education providers. Your child should be able to be vaccinated within the next few weeks. It is extremely important that all eligible children have equitable access to the vaccine and we appreciate your patience as we go through this process.”

Drop them off at the circulation desk at Curry Public Library during business hours.





# Hundreds flock to see Sugar Bear in Crescent City

Sugar Bear, the 84-foot white fir selected as this year’s U.S. Capitol Christmas Tree, made its first stop in Crescent City - where hundreds of local residents posed in front of the tree, listened to the Del Norte High School band and choir, posed with Big Foot and listened to an essay reading by fifth-grader Michael Mavris.

The day’s event also included lines of local students who passed through educational booths, before stopping to pen a note and take a picture in front of Sugar Bear - which was carefully nestled and decorated inside a 102-foot-long cab and trailer.

For the next 10 days, the tree will travel and make several stops in California before heading eastward towards Washington D.C., which is located 2,500 miles away.

“One of the reasons for a project like this is to connect people to public lands and the national forest,” said Samantha Reho, public affairs specialist with the U.S. Department of Agriculture. Over the next three weeks, Sugar Bear will stop in 25 different communities before it will take its place on the west lawn in front of the capitol.

According to a Department of Agriculture

fact sheet, the process of providing the capitol Christmas tree is a year-long undertaking that includes the cutting down of 60 other “companion” trees ranging from 10 to 25 feet, which will also be displayed in various government locations.

“We deliberately chose this tree and the others in areas that needed to be thinned anyway,” said Reho.

When the tree arrives at its destination, Mavris, a student from Mary Peacock Elementary in Del Norte County, will officially light up the tree sometime in December, though the actual date of the tree-lighting ceremony has not yet been set.

Mavris was chosen for the high-profile ceremonial position after his essay ‘Six Rivers, Many Peoples, One Tree’ won first place in a contest that drew 53 submissions.

Mavris read his essay in front of a large crowd at the Crescent City event on Oct. 29 and will do it again in front of the capitol.

“From this great forest, we bring you the majestic white fir to be the capitol’s Christmas tree,” Mavris read. “As the lights are strung and the ornaments placed, we, the people who live in the tree’s symbolic shadow, hope that its beauty and grandeur provide a beacon to America and

a reminder that on this Christmas all things are possible.”

According to Reho, the entire event - from the harvest to its delivery to the east coast - is paid for through private donations.



## Oregon Delegation Urges Fishery Disaster Declaration

Oregon’s U.S. Senator Jeff Merkley is leading members of the Oregon delegation, including U.S. Senator Ron Wyden and U.S. Representatives Peter DeFazio, Kurt Schrader and Suzanne Bonamici, in urging the U.S. Department of Commerce to grant a catastrophic regional fishery disaster declaration for the state of Oregon, after three consecutive years of drought have harmed salmon populations.

“The value of salmon to Oregon cannot be overstated. In addition to the economic activity generated by this industry, salmon are an important part of the cultural heritage of Pacific Northwest tribes, generate recreational activity, and are a treasured natural resource across the state,” the lawmakers wrote in a letter to Secretary of Commerce Gina M. Raimondo. “However, the challenging impacts of climate change, increased drought, and changing ocean conditions complicate the recovery of salmon populations in the Pacific Northwest.”

From 2013 to 2017, the commercial value of Chinook salmon was around \$6.3 million annually for Oregon fisheries. But with the impacts of climate chaos impacting salmon populations, the economic value has dropped precipitously — down to \$2.3 million in 2018, \$2 million in 2019 and \$1.4 million in 2020.

# Voters say no to parks and recreation district

Curry County voters overwhelmingly defeated ballot measure 8-102 - negating an initiative that would have created the South Coast Parks and Recreation District. If passed, the measure would have also given a green light to the SCPRD

to pursue a second measure to fund an aquatics and recreation center in Brookings. According to the Curry County Clerk Elections Division, 4,370 people voted in the Nov. 2 election. With 4,198 of those votes tallied, the measure failed by 61.36%. If passed, the SCPRD would have been funded

with a permanent tax rate of 0.33 cents per \$1,000 assessed property value, or about \$99 per year on a home valued at \$300,000. Proponents of the ballot measure touted the measure as necessary in order to create year-round physical fitness and other social activity opportunities at a new community center, which would have

been run by the new South Coast Parks and Recreation District and managed by the YMCA. The outcome of the election was another in a string of elections in Curry County where voters either voted down proposals that would have raised taxes or voted down proposals to add a new tax to the current system.

**South Coast Parks and Recreation District Special Election**

Yes - 1,622 38.64%

No - 2,576 61.36%

If approved, the district would have increased property taxes by 33 cents per \$1,000 of assessed valuation to create a parks district. A second vote would have asked voters to fund and indoor aquatics and recreation center.

# Tree drivers looking forward to festive journey

Drivers Jeremy Bellinger and Bill Brunk stood somewhat back from the day’s festivities in Crescent City, but kept careful watch over their precious cargo Sugar Bear.
