

Governor Brown extends schools closure

Governor Kate Brown announced Tuesday, March 17, an extension of Oregon's statewide school closure to a total of six weeks, until April 28, and also issued further guidance for Oregon's public schools. This follows on an initial two-week closure of Oregon's schools that was set to end on March 31.

"I do not take the decision to extend school closures lightly," said Governor Brown. "This will have real impacts on Oregon's students, parents, and educators. But we must act now to flatten the curve and

slow the rate of COVID-19 transmission in Oregon, otherwise, we face a higher strain on our medical system and greater loss of life to this disease."

The orders are as follows:

- Schools are to remain closed through Tuesday, April 28.
- Districts are to provide learning supports and supplemental services to students and families during the closure period, including meals and child care. This includes the delivery of food assistance and offering child care for essential health care professionals and first responders.
- School districts may call on public school educators and employees to deliver

limited learning and support services.

- Each district will pay all their regular employees during the closure.
- The Oregon Department of Education, Oregon Health Authority, and Department of Human Services are directed to support public schools in the continuity of mental health services.

After Gov. Brown's order, Brookings Harbor School District interim Superintendent Chris Eberhardt issued the following statement:

Oregon Governor Kate Brown has announced an extension to her mandate to close Oregon schools to help prevent the spread of COVID-19 (coronavirus). The

governor's new orders mean that schools will be closed until April 28, 2020.

We know this is a trying time and that the closure of our schools is a challenge. Please know we are doing all we can to plan for our students' potential return and are looking for additional guidance from the Oregon Department of Education during this extended closure.

What we do know right now:

- We will continue a food distribution of boxed or bagged food from the school district and distribute "snack packs" from the local food bank. See our website for information

Food service and volunteers gear up to deliver

All hands were on deck on Monday, March 16 as food service workers and volunteers prepared 600 bags of food.

"It's a daunting task but with many hands, it's coming together," said Lynn McPherson, who was one of about 20 workers packing bags of food at the Brookings Harbor High School (BHHS) Cafeteria.

"We are trying to include enough inside the bags to help supplement for a few days," said Brookings Harbor School District (BHSD) food service manager Cindy Badger. They packed 600 bags of food for Tuesday alone to be distributed to students at the cafeteria and via bus.

"We will do the 'reverse bus routes' again on Friday morning to take food to our regular bus stops at the usual morning time," said Nancy

Raskauskas-Coons, BHSD public information officer. Meals will also be available at the cafeteria.

Meanwhile, at the Brookings-Harbor Community Food Bank, nearly a dozen volunteers, including the Food Bank along with community kitchen volunteers, BHHS leadership students, Board of Directors from Brookings Harbor Education Foundation, members of the Brookings Church of the Nazarene and the Neighborhood Food Project and Azalea Princesses, showed up to put together 800 snack packs for kids.

"We just heard there is a need, so here we are," Sarah Burd said. "Kiddos need their food."

The snack packs from the food bank were to be distributed at the BHHS Cafeteria site on Tuesday and again this Friday from 7 to 10 a.m. along with the school district food bags for student families that qualify for free or reduced-price meals.

The food bags being packed at BHHS contained applesauce, juice,

breakfast bars, apple strudel, chips, condiments, pasta, spaghetti sauce, bread rolls and apples. Refrigerated bags included salads, vegetable mix with salad dressing, cheese, lunch-meat and milk.

The snack packs put together at the food bank consisted of either milk or juice, applesauce, fruit snacks, crackers and granola bars. The food bank group put together 800 packs on Monday and will pack another 800 to 1,000 packs for Friday.

BHSD has not received word whether they will be distributing food next week since food is not usually distributed during spring break.

Central Curry School District 1 is providing meals from 9-11:30 a.m. at Riley Creek School in Gold Beach to children ages infant-18 through Friday this week and will resume on March 30.

"This is a grab-and-go meal," said CCSD1 Superintendent Tim Wilson.

Curry County Sheriff's Office announces operational changes

The Curry County Sheriff's Office is making some temporary operational changes in order to assist in stopping the possible spread of COVID-19, reported Sheriff John Ward on Tuesday, March 17.

Following is the release from his office:

Sheriff's offices across the state have all made some changes in operations including jail intake services. We can assure you that Oregon sheriff's and jails are doing their absolute best to implement appropriate protocols to address the threat of COVID-19. We are working with our local law enforcement partners, the courts, district attorney's offices and public defenders to implement changes to the entire criminal justice system which will help us manage this

crisis.

We are also communicating with our public health departments, the governor's office and emergency management to ensure that we have the most current information and are implementing the latest recommended changes. Those changes include a careful evaluation of who gets booked into our facilities to limit intakes, a host of environmental precautions, and screening of staff, inmates and contractors.

Effective immediately for the duration of at least four weeks or until further advised, we have canceled all fingerprinting for outside employment purposes, to include all concealed handgun license appointments. We will continue to issue CHL renewals on a

case-by-case basis. We have also closed our South County Sheriff's Substation in Harbor to the general public. Those who may need immediate attention will need to contact the Sheriff's Office in Gold Beach.

We have suspended inmate visitation for the time being and are not allowing any unauthorized persons beyond the secure doors past our lobby. We will still help those who come to the Sheriff's Office lobby in need of assistance. We ask that people who come to the Sheriff's Office for assistance make sure they are not sick or show any symptoms of the COVID-19 virus, for if they do they will be asked to leave and call in.

We regret the inconvenience of these measures we are forced to take, but the safety

and security of the inmates and our staff is critical to being able to continue providing the best service possible. It does not matter about our personal beliefs regarding the reported coronavirus outbreak or how the nation is trying to combat it because we all have to do our part to help protect our citizens.

We will keep the public informed on when we can lift these restrictions. Updates regarding the coronavirus can be found on the Curry County webpage, under the COVID-19 link. Stay safe and please follow all recommended precautions by CDC, OHA and Public Health to keep yourself, friends, and your family healthy.



Retail perspective on COVID-19 event

Editor's Note: Local Fred Meyers Store Manager Henry Johnson has more than 30 years of retail experience and has been giving people an insider's view via extended Facebook posts of what he's seeing as the nation comes to grips with COVID-19. Although he works at the local store, the posts are not being done on behalf of the company. He's allowed The Pilot to print these in the newspaper.

Here are a few of his thoughts from a retail perspective on the COVID-19 event:

I know many people are frustrated by long lines, busy aisles and empty shelves. So, to give you all some insight.

Empty shelves are a reflection of tight supply chains or tight business operations. Most grocery retailers only have 2-3 days or less of a product on hand, warehouses about 7-10 days, fresh products can be even less.

Logistically there is an amazing ballet of growing, manufacturing, shipping, warehousing and merchandising that flows flawlessly behind the scenes. It is only in times of weather or unexpected demand (like we are experiencing today) when this dance falters and is exposed for others to see.

In retail, we use a variety of tools to anticipate the demand for products and services. This includes average movement of goods, tracking responses to advertising, third-party data, customer counts by day and time and

much more. We then place orders and write schedules based on this data weeks, months and sometimes year(s) in advance.

Typically the biggest interruption to the chain is the weather in the growing fields. But when an event ruins the data or estimates then things get crazy!

Events such as "Black Friday" or holidays like Thanksgiving or Christmas can be hectic but are rarely crazy. This is because we know when it will be happening and what people will be looking for.

The COVID-19 event is an outlier. Not just because of the horrible impact it can have on each of us or our families, but because of how quickly it has spread and how scary its potential can be.

Know that retailers, suppliers, manufacturers, growers, etc. simply are not prepared for this kind of demand and as such you are seeing the ripple effects of customer behavior across the entire supply chain.

For example, the most popular sizes of toilet paper are emptied from the warehouses, then the second-most popular, then the third. What you see now in stores is quite simply whatever retailers have been able to obtain from their primary source (manufacturers or distributors) from existing orders or it is possibly something that they found on the secondary market (wholesalers).

Meanwhile, other things that are grown then processed are

being hit hard, too. I am talking about things like rice, beans, canned vegetables, etc. Retailers are selling through inventories that are supposed to last until the next run of harvest and production is complete. (Don't forget items manufactured, especially in China. Factories were closed which will create shortages of durable goods in the future.)

So, why do people panic buy? I think it comes down to a few basic elements. 1) Fear of the unknown, for example, what happens if I am quarantined for two weeks at my house? 2) Fear of missing out, for example, if I don't stock up now I might not be able to get basic necessities later. 3) Other people are doing it so I should, too. These areas, combined with love for our families and our lifestyles can be extremely compelling!

So, there is some insight into the world of retail, especially in times of emergency. However, to leave you with one last thought, know that every retail employee you see is working hard to keep their store in stock for you and their families.

Many of my employees and others throughout the retail, medical and other supply chains are working extra shifts, long hours and in areas, they aren't trained in just so that you can find the things that you need.

So please take a moment to thank them for what they are doing, not just today, but every day you are in a store, office or business.

Employment Dept. guidance due to impacts of COVID-19

The health and safety of workplaces is of utmost importance to the Oregon Employment Department, and the agency's mission is to support business and promote employment. The Employment Department has guidance available to employers, workers, and job seekers impacted by the COVID-19 coronavirus situation.

Unemployment Insurance Benefits

The Oregon Employment Department provides Unemployment Insurance (UI) benefits to most workers who are out of work through no fault of their own.

To get benefits, workers must meet some requirements. In general, to claim and receive unemployment benefits for a week, workers must be available for work, able to work, and actively look for work they can do.

The Employment Department on Wednesday, March 18, enacted temporary rules to give more flexibility in providing unemployment benefits to COVID-19 affected workers.

on dates and times.

- Our facilities will remain closed to students and most staff during the extended closure

While our students are away from school, please help them understand the importance of this national health emergency by encouraging social distancing, good hand hygiene, avoiding people who are sick, and covering their coughs and sneezes. Gatherings of more than 10 people are not recommended by the U.S. government at this time.

Unemployment Insurance benefits are available during temporary layoffs related to COVID-19 situations. These benefits occur for employees whose employer stops operation for a short period of time, such as cleaning following a coronavirus exposure, or by government requirement.

Workers can get unemployment benefits, and do not need to seek work with other employers if their place of employment will resume operations. To receive benefits, affected workers must still be able to work, stay in contact with their employer, and be available to work when called back.

A full resource guide with questions and answers about specific COVID-19 coronavirus-related situations and unemployment benefits is available at Oregon.gov/employ. This site also has information for filing an online claim.

Economic Impacts

The number of initial Unemployment Insurance claims filed in Oregon rose from approximately

800 on Sunday, March 16 to a total of 18,500 on Tuesday, March 18. Although the COVID-19 coronavirus is causing a reduction in economic activity both nationally and in Oregon, it's too early for unemployment rate or payroll jobs numbers to show the impact of these employment disruptions. The Employment Department will provide more information online as updated data become available.

To file an online claim for unemployment benefits, go to Oregon.gov/employ or call 1-877-FILE-4-UI.

Oregon expands child care benefits to support families and providers during spread of COVID-19

To support Oregon’s working families dealing with the spread of COVID-19, Governor Brown directed the Oregon Department of Human Services and the Early Learning Division to make changes to child care benefits.

“These measures are helping families access safe care for their children and will help stabilize child care businesses during an unprecedented time,” said Early Learning System

Director Miriam Calderon.

The temporary changes, which are effective immediately, will help more low-income, working families access child care and help providers stay in business during the state of emergency.

“At a time when Oregon’s families are weathering numerous difficulties in their daily lives due to the spread of the coronavirus and its impact on our economy, we need

to do everything we can to make sure child care providers can keep their doors open so parents can continue to work,” said Governor Kate Brown.

The changes are:

- Eliminating co-pays for eligible families.
- Providing access to more families by increasing the income limit from 185 percent of the federal poverty level (\$4,040 per month for a family of four) to 250 percent of the fed-

eral poverty level or 85 percent of the state median income, whichever is higher for the family size (\$5,899 per month for a family of four).

- Ensuring more certainty for providers. Child care providers are able to continue to receive payments from DHS, even if children are unable to attend or if they have to temporarily shut down during the state of emergency.

“It is important that we come together

and help one another through this difficult time,” said Fariborz Pakseresht, Oregon DHS Director. “Child care providers play an important role in supporting families, and we want to make sure families can still access this important service.”

Market overreacts to COVID-19 epidemic

Viruses are nothing to dismiss lightly, but people should not panic in regard to COVID-19.

In the U.S., each year between 9 million and 45 million are infected by an influenza and between 12,000 and 61,000 die. To

put this in perspective, there are approximately 600 confirmed cases of COVID-19, and 23 people have died in the U.S.

Data shows that new viruses appear in Asia months before they show up anywhere else. The annual influenza epidemics infect between 5 percent and 15 percent of the world population each year, and cause approximately 300,000 deaths.

Many Chinese people insist on freshly slaughtered animals rather than frozen meat. This is one of the major reasons China has been such a hot spot for new influenza viruses.

Nowhere else on Earth do so many people have such close contact to so many caged live animals in unhealthy conditions. The virus COVID-19 is a coronavirus, from the same family as the viruses that caused

SARS and MERS. Much like SARS and the common cold, COVID-19 targets the respiratory system.

However, the media and the public are confusing the transmission rate (RO) and the Mortality rate (CFR). Just because something is “highly transmissible” does not mean it is fatal.

The common cold is very transmissible but millions get it and survive. The RO rate of COVID-19 is

between 2 and 3. Which means one person who contracts this virus tends to spread to 2 to 3 people.

What is more important is the case fatality rate (CFR) or the percentage of people who die from this virus. The World Health Organization (WHO) has been publishing the number 3.4% as the percentage of confirmed patients who die from COVID-19. President Donald Trump believes the

CFR rate is under 1%.

The reason the WHO may be high is because there are many people who have the virus, but are not confirmed cases. In South Korea, where they are testing more people, their case fatality rate is around 0.5 percent, which may be closer to the number the U.S. will experience.

Curry County Commissioners declare local emergency

Curry County Commissioners declared an emergency within Curry County in response to the novel coronavirus (COVID-19) at the Board of Commissioners meeting held on Wednesday, March 18.

“We all need to pull together as a county and as a nation,” said Commissioner Christopher Paasch in a statement. “To the citizens of Curry County, know that we are doing all we can to keep you informed, and we are working with all state and federal authorities to curb this COVID-19 coronavirus.”

Under state statute, the county is authorized “to act as an emergency management agency, including the authority to establish policies and protocols for defining and directing responsibilities during a time of emergency,” according to the resolution.

Commissioners expect resources and funding will be exhausted at the local level for contact tracing, disease investigation and community information. Responding to local needs to keep the public informed and as safe as possible will require many resources.

The declaration specifically requests assistance from the state for help providing consistent mes-

saging to the public and for disease investigation.

“The Board of Curry County Commissioners hereby resolves: Under the emergency powers granted by ORS 401.305 declare that a local State of Emergency exists within Curry County. This declaration directs the Curry County Office of Emergency Management and Curry County Public Health to take all necessary steps authorized by law to coordinate response and recovery from this emergency including, but not limited to requesting assistance and potential reimbursements from the State of Oregon and the appropriate Federal authorities.”

Two more deaths related to COVID-19 in Oregon

COVID-19 has claimed two more lives in Oregon, raising the state’s death toll from this virus to three, the Oregon Health Authority reported at 8:30 a.m. on Wednesday, March 18.

The cases are a 60-year-old woman in Lane County, who died at PeaceHealth Sacred Heart Medical Center at Riverbend on March 14, and a 71-year-old man in Washington County who died March 17 at Providence St. Vincent Medical Center. The Lane County resident tested positive for the virus March 17, while the Washington County resident received a positive result on March 16. Both had underlying medical conditions.

They are among a total of 75 people in Oregon who have been confirmed to have COVID-19, the novel coronavirus. That includes 10 new cases that were confirmed statewide today in the following counties: Benton (1), Lane (2), Marion (4), Washington, (2) and Yamhill (1).

“We are saddened at the news of these additional lives lost in Oregon due to COVID-19,” said Patrick Allen, OHA director. “These deaths only strengthen our resolve to slow the spread of this disease in our communities. We are in this together.”

Washington County Health Officer Christina Baumann, M.D., M.P.H., said, “We are sad to learn of

the first death in our county due to COVID-19. Our hearts go out to his family during this time. We are committed to slowing down the spread of this disease and to protecting those most vulnerable among us.”

Patrick Luedtke, M.D., M.P.H., Lane County senior public health officer, said “First and foremost, we are deeply saddened by the loss of our community member. We ask that our community members, and the greater Oregon community, show kindness and compassion for the family of the deceased at this time. We are absolutely committed to preventing future death through slowing the spread of COVID-19.”

Patients with the flu-like symptoms of COVID-19 such as fever, cough, or shortness of breath will be directed to the Emergency Department at Curry General Hospital in Gold Beach where they will be seen in the Triage Room.

The patient will receive a medical screening examination by the emergency physician, and this facility’s laboratory can perform a rapid test to rule out influenza as a potential cause. The emergency physician then will follow guidelines established by the Oregon Health Authority (OHA) to determine if the patient should be tested for COVID-19.

If so, specimens will be collected and sent to

an external laboratory for testing as long as collection supplies are available.

Current OHA guidelines for hospitals recommend the patient may have specimens collected for COVID-19 testing if the patient tests negative for influenza and:

- the patient has a fever or respiratory symptoms (cough, shortness of breath) AND has been in contact with a confirmed COVID-19 patient in the 14 days before symptom, or
- the patient has fever AND respiratory symptoms with travel to areas with widespread COVID-19 transmission in the 14 days before symptom onset, or
- the patient has a fever with severe acute lower respiratory illness (e.g. pneumonia, ARDS) requiring hospitalization and without an alternative explanatory diagnosis (like

influenza)

WHY IS THIS ONLY BEING OFFERED AT CURRY GENERAL HOSPITAL?

There are several reasons why this is being offered only at CGH.

- To reduce the number of staff and other patients being exposed to potential COVID-19 positive patients — remember, safety is the number one goal.
- Current OHA guidelines recommend ruling out influenza before COVID-19 testing. Recent changes to regulations now require that all influenza testing be done under a containment biological hood that Curry Medical Center’s laboratory does not have, so influenza specimens must be couriered to and from Curry General Hospital for testing. This can result in a 4 to 6-hour turnaround time during normal hours,

and longer during hours without courier service — time that we do not want a potential COVID-19-positive patient to spend in the very busy Brookings emergency department at Curry Medical Center, which is also near to other clinic staff and patients.

- To expedite the process for our patient in the safest manner possible.
- To maintain the highest level of safety for the most people possible.
- To provide a safer environment for patients who need to see a primary care provider or specialist for conditions unrelated to influenza or COVID-19.
- To manage resource constraints and conservation of COVID-19 collection supplies to ensure that patients needing the tests are receiving the appropriate level of care.

WHY CAN’T THIS BE DONE AT AN ALTERNATE SITE, OR FROM A VEHICLE?

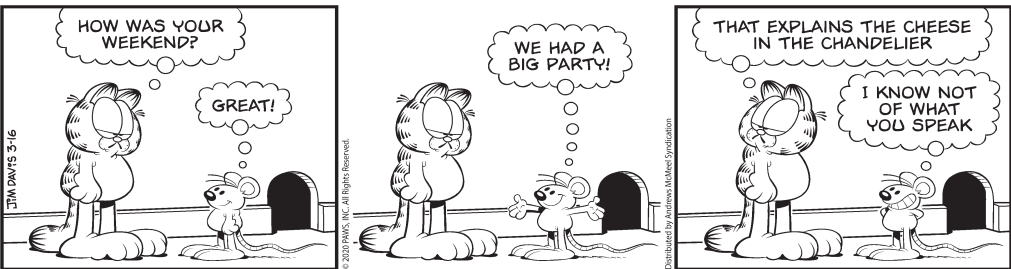
- Currently, most rapid alternate screening locations or “drive-through” screening locations have been established in urban areas and manned by Public Health officials, nurses, and physicians. Curry County does not have the resources in its Public Health agency to establish an alternate care location. Although it is not generally recommended to bring people into an emergency department, at Curry Health Network and given current OHA guidelines, the hospital emergency department is the safest and most efficient facility and department that currently has the resources and ability to care for and screen these patients.
- With current guidelines and current

collection and processing requirements, COVID-19 specimens must be handled in such a way that it is kept at a frozen temperature until delivered to the external testing laboratory. Our courier services would not be able to keep the specimens at the required temperature during transport between facilities. Therefore, COVID-19 specimens must be collected at the hospital and managed by the hospital laboratory that can ensure the needed handling and temperature control.

Curry Health Network would like to reiterate that the decisions made related to the provision of care is to maintain the highest level of safety for the most people possible while at the same time serving the needs of the community.

Temporary camping closures announced for Oregon state parks, forests, and wildlife areas

Three Oregon state agencies will suspend camping to help reduce the spread of COVID-19.

The Oregon Parks and Recreation Department will accommodate current overnight guests through April 2. Reservations for all state park stays from April 3 to and including May 8 will be canceled and site fees refunded. Before May 8, the department will review the state park campground closure to decide whether it should be extended. The decision affects all individual and group overnight facilities: campsites, yurts, cabins, teepees, and services operated by concessionaires. The suspended service also affects reservations for group day-use areas.

The Oregon Department of Forestry maintains campgrounds in the Clatsop, Santiam, and Tillamook state forests. Most campgrounds are currently closed for the season, and will not

reopen for individual or group use. Year-round campgrounds will close starting on Monday, March 23. All day-use and campground restrooms are temporarily closed due to limited janitorial services. A reopening date for all restrooms and state forest campgrounds has not yet been determined. During this time, trails, forest roads and trailheads on state forestlands will remain open to the public.

The Oregon Department of Fish and Wildlife is closing its Wildlife Areas to overnight camping effective Sunday, March 22. The closure affects both dispersed camping and established campgrounds. Several wildlife areas are also currently fully or partially closed to all visitors as part of annual seasonal closures to protect wintering wildlife. While camping will be prohibited, wildlife areas that are currently open remain open to visitors for

day-use activities including wildlife viewing, fishing, hunting and other outdoor recreation. See the ODFW Wildlife Area Visitor Guide for more information (link at bottom).

State park, forest, and wildlife area camping areas are built into relatively small areas by design. Maintaining social distance is difficult. Working with fewer staff and volunteers is becoming a reality, making it difficult to maintain proper cleaning procedures. To support the state goal of reducing transmission of COVID-19, temporary campground closures are necessary. The details of these actions — such as dates and affected programs — are under constant review and will change as new information develops.

This will reduce long-distance travel for many people, but all state natural resource agencies remind Oregonians that a local outdoor experience can

improve our mental and physical health, especially now. Daytime activities are still widely available and encouraged. The usual reminders, plus the new COVID-19 guidelines, apply:

- Prepare for your visit with the clothing, supplies, and knowledge you need to have a safe visit.
- If you're ill, stay home.
- Cover sneezes and coughs with a tissue (then throw it away) or inside of your elbow.
- Avoid touching your face.
- Wash regularly with soap and water for at least 20 seconds. It's up to you to practice good personal hygiene, and not every place at every park can be kept clean all the time.
- If a place is so crowded you can't maintain a healthy social distance — at least six feet — find a different place to go.

U.S. Attorney's Office takes steps to maintain mission amidst COVID-19 public health emergency

U.S. Attorney Billy J. Williams announced Wednesday, March 18, a series of steps aimed at protecting consumer financial safety and preventing civil

rights violations amidst the coronavirus outbreak.

U.S. Attorney Williams has appointed COVID-19 fraud and civil rights coordinators to lead investigations into known and suspected occurrences of consumer financial fraud and civil rights violations resulting from the nation's ongoing public health emergency.

"We are aware of instances of consumer fraud and civil rights violations stemming from the COVID-19 public health emergency," said U.S. Attorney Williams. "While Americans work to protect themselves and their loved ones from the threat of COVID-19,

some individuals are actively trying to profit off of this emergency. Equally concerning," Williams continued, "we have received reports of alleged civil rights violations stemming from the false belief that certain groups of people are more susceptible to carrying or contracting the virus based on their real or perceived race, ethnicity, employment or other demographic characteristics."

If you or someone you know believe you've been the target or victim of an outbreak-related fraud scheme, please contact the FBI's Internet Crime Complaint Center (IC3) by visiting www.IC3.gov. Crime tips of any kind, including alleged civil rights violations, can be submitted by visiting tips.fbi.gov or calling the FBI Portland Field Office at 503-224-4181. If you or someone you know are in immediate danger, please call 911.

The U.S. Attorney's Office COVID-19 fraud and civil rights coordinators will be notified of tips submitted via any of the above reporting methods.

On March 13, Chief U.S. District Court Judge Marco A. Hernandez issued Standing Order 2020-4, Court Operations in Response to COVID-19. Under the order, most district court proceedings are continued or will be resolved

via telephone or video conference. Case-by-case exceptions to this guidance will be considered by the applicable presiding judge after consultation with counsel. The court's standing order will remain in effect until vacated or amended.

The U.S. Attorney's Office has taken necessary precautions to protect the health and safety of its staff during this health emergency while continuing to fulfill its public safety mission. Essential law enforcement functions including investigations, the signing and execution of warrants, filing of charges, and case litigation will continue. District of Oregon prosecutors and support staff will continue working with federal, state, local and tribal law enforcement partners to safeguard our justice system and protect the safety and security of our nation during this difficult time.

"We are immensely grateful for the many public health and medical professionals and first responders on the front lines of protecting our communities from the novel coronavirus," said U.S. Attorney Williams, "During this time of uncertainty and fear, it is more important than ever that all Americans look out for one another, act out of compassion and generosity, and look for opportunities to help their neighbors. Likewise, federal law enforcement will continue doing our part to keep our communities safe."

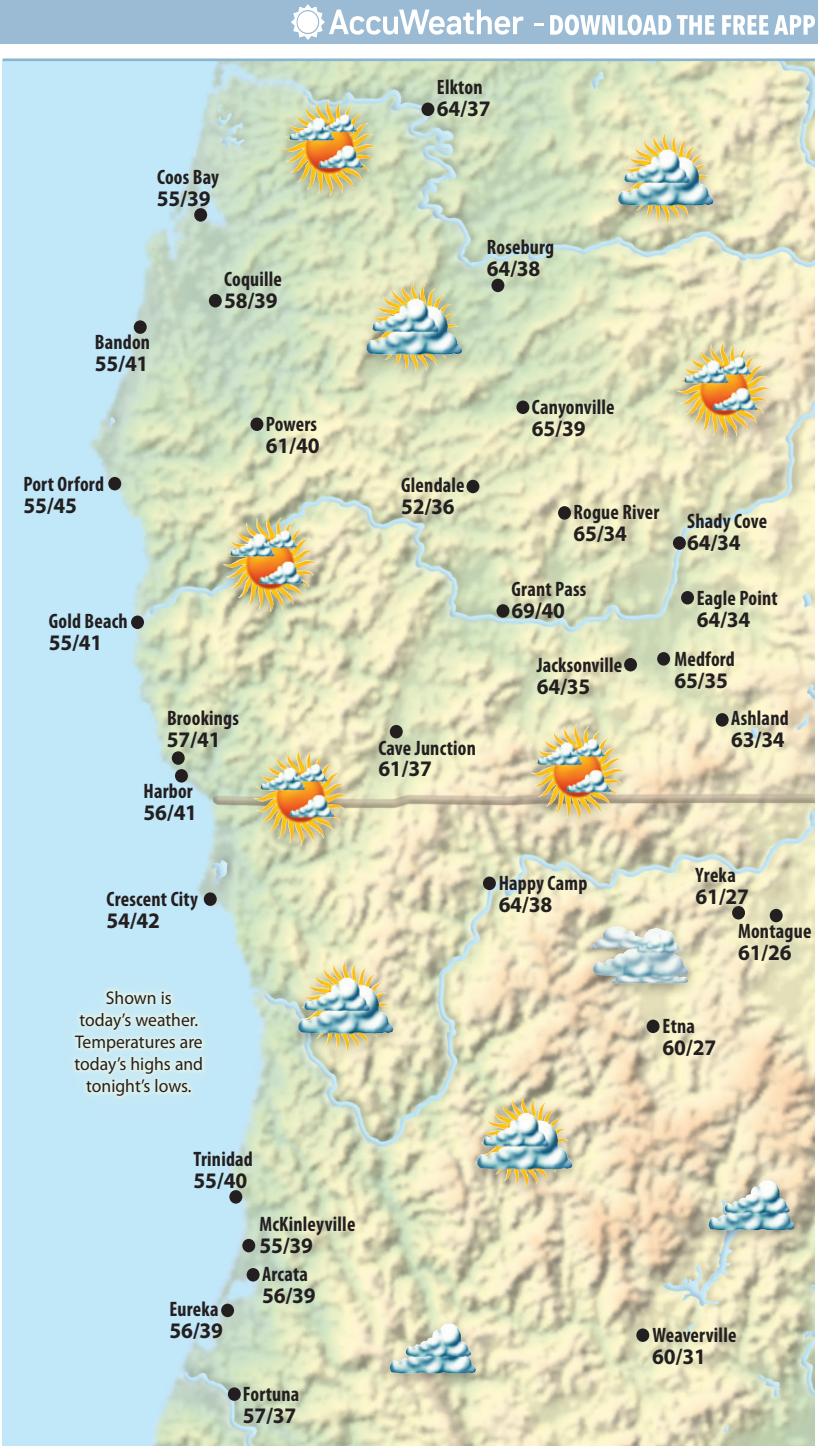

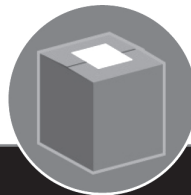

NOTICE IS HEREBY GIVEN that on Monday, April 6, 2020, at 6:00 p.m., or as soon thereafter as the matter may be heard, in the Board Chambers at 981 H Street, Crescent City, CA, the City Council of the City of Crescent City will hold a public hearing and consider the adoption of Ordinance No. 819, Adding Chapter 17.95, Commercial Cannabis Regulations, and Amending Chapter 17.20, C-1 Downtown Business District, Chapter 17.22, C-2 General Commercial District, Chapter 17.23, CW Waterfront Commercial District, Chapter 17.24, HS Highway Service District, and Chapter 17.93, Standards for Marijuana, of Title 17, Zoning, of the Crescent City Municipal Code. The proposed ordinance allows for the operation of and establishes regulations for specific commercial cannabis uses, including storefront retail, non-storefront retail (delivery), indoor cultivation, non-volatile manufacturing, processing, distribution, microbusiness, and testing laboratories. Commercial cannabis uses will be allowed by use permit in the following zoning districts: General Commercial (C-2), Commercial Waterfront (CW), and Highway Services (HS). The following commercial cannabis uses are prohibited: on-site consumption, outdoor cultivation, volatile manufacturing, and mobile or drive-thru sales. Commercial cannabis retail facilities may not be located within a 600-foot radius from the perimeter of a public or private school providing instruction in kindergarten or grades 1 through 12 ("K-12 school") or a day care center (not including family child care homes). The distance is measured as the horizontal distance between the two property lines. No setbacks from the Del Norte County Fairgrounds parcel is required. On a case-by-case basis, an exception to the setback requirement may be granted if the applicant can show that there is 600 feet between the uses although not the parcel boundaries, there is sufficient buffering or development between the uses to minimize potential harmful impacts to minors, and that the location and design of the use is not likely to cause harmful impacts to minors. The Ordinance also regulates signage, advertising, marketing and distributing to minors, health and safety of facility, odors, disposition of waste, discharge of effluent, security measures, mandatory notification of security breaches, hours of operation, compliance with state track and trace program, delivery vehicle requirements, no on-site consumption of cannabis, tobacco or alcohol. On March 12, 2020, the Planning Commission recommended adoption of the Ordinance.

"Sidewalk vendor" means a person who sells food or merchandise from a pushcart, stand, display, pedal-driven cart, wagon, showcase, rack, or other nonmotorized conveyance, or from one's person, upon a public sidewalk or other pedestrian path. Mobile vending will be allowed in all zones on private property and on public streets and parking lots. Mobile vending on private residential property will require a use permit. Both mobile vendors and sidewalk vendors will be required to get an over-the-counter permit to operate. On March 12, 2020, the Planning Commission recommended adoption of the Ordinance.


