# Snow rescue leads to better equipment

Curry County orders Sno Cat to help in future rescue attempts

Four men may owe their lives to a group of search and rescue deputies from the Curry County Sheriff's

Sheriff John Ward said the men became stranded in the mountains late in January when a winter storm dumped three to four feet of snow

in the higher elevations.

That night, Jan. 26, just turned out to be the night the four men, Sean Farris, 30, Aaron Farris, 28, Shawn Miller, 29, and Bjorn Schaller, 21, decided to go up into the mountains and make a campfire to cook some food. When they didn't return home,

Shawn and BJ Farris of Brookings called the sheriff's office to report them missing. Shawn Farris explained the men went up into the mountains before the storm hit. When they had not returned by midnight, Shawn Farris attempted to go find them himself, but he got stuck in the snow and was forced to return home.

Despite the winter storm, search and rescue coordinators Deputy Walter Scherbarth and Deputy Jared Gray got to work. At 4 a.m., the two responded with a search and rescue volunteer to the area only to find the heavy snowfall made it difficult to reach.

Ward said due to the conditions, his team knew it had to react immediately.

"Situations like this, when there's extenuating circumstances, one of them was disabled, we just go out no matter what time it is," Ward said. "The circumstances dictated to us we need to get out there as soon as possible."

Using a side by side with snow tracks, the search and rescue workers continued to make their way up the mountain.

After about six hours of searching, close to 10 a.m., the search and rescue team located the pickup truck the men drove up the mountain in. It was stuck in snow on Wildhorse Road. Sean and Aaron Farris were with the vehicle, and they reported Schaller and Miller had left about an hour earlier to try to hike out.

Deputies took the Farris brothers down the mountain where they were picked up by their father. The sheriff's office ATV, which had made it up the mountain, was struggling to continue because of the deep snow, making it clear better equipment was needed to find the remaining two men.

Ward called Josephine and Jackson counties to ask about using Sno Cat machines, only to learn none were available. Ward then reached out directly to the Tucker So Cat Company in Medford, and they agreed to send over a machine to help in the search.

# Curry County ramps up vaccine efforts

As supplies of the COVID-19 vaccine slowly become more stable, Curry County's hospital system is

ramping up its vaccination effort. As of Monday, data from the Oregon Health Authority showed just over 1,400 people in Curry County have received a COVID-19 vaccine, including just over 170 who've been fully vacci-

nated with the two-dose sequence. Curry Health Network has been vaccinating health care workers and other Phase 1A populations since it received doses of the vaccine in December. But just last week, staff at the hospital took the first step of expanding vaccine access with

The clinics aren't mass vaccination events, and appointments are required for the narrow group which is eligible to receive vaccines under state guidelines – but hospital CEO Ginny Williams says staff are doing all they can to get shots into arms.

several clinics across the county.

"Honestly, I think we've done a good job," Williams said.

Currently, individuals in Phase 1A and educational staff are eligible to

receive vaccines. Williams said the hospital reached out to a number of organizations in health care settings early in the vaccine rollout to offer vaccination appointments for staff.

"For those that want it, we're almost 100% complete with those folks," Williams said.

Teachers and other educational staff – the next group after health care workers on the Oregon vaccination schedule - are well on their way to being completely vaccinated, too, with Williams projecting they'd be complete by the end of the week.

The hospital receives shipments of vaccine each week, and the goal is to use up that quantity by week's end, maximizing efficiency with appointments scheduled online and a staff of volunteers which moves vaccine recipients from registration to post-shot observation in a matter of minutes.

So far, Williams said CHN has come close to that goal, usually with a small handful of each week's doses still in vials by the end of the week.

But a fact she's proud of? "To date, we have not wasted one

dose," Williams said.

# Harmony and Me: Bringing people together

In a time of a global pandemic where it feels like people are always fighting, Tricia Bartlett-Iverson has a suggestion – turn to music.

The founder and executive director of Harmony and Me Music, Bartlett-Iverson has seen firsthand the power of music to bring people and cultures together.

"Music is the most powerful tool," she said. "It does so much for therapeutic purposes alone. There are very few people in the world

who can't engage with music."

Bartlett-Iverson knows how music can impact people, and she hopes to bring that impact to more and more people. Her nonprofit Harmony and Me is based in Brookings, but she hopes to bring it and the power of music to Crescent City and many others places soon.

By any description, Bartlett-Iverson had a difficult childhood, spending most of her youth in foster homes. Music gave her a sense of direction then, and her vision of using music to bring people together first started as a 5-year-old.

"It was an experience I had in the community I was in, and I didn't like it," she said. "There were all these differences, and no one was coming together. So, I started dreaming of a way to bring us together. We're all suck here, we might as well get along.'

In 2009, while living in the San Francisco area, Bartlett-Iverson launched Harmony and Me as a way to teach young children music and provide comfort and entertainment to the elderly.

She taught music to pre-schoolers at Mission San Jose and would bring the youngsters to assisted living facilities where they would sing for the patients. The result was inspiring for both age groups.

When she moved to Brookings, Bartlett-Iverson brought her idea with her and relaunched Harmony and Me. While the pandemic has changed things, it has not stopped her dream.

"Right now, we do Zoom classes," Bartlett-Iverson said. "It's OK. We might do outside classes. I'm doing babies up to 10 years old."

# Gold Beach looking to expand

Gold Beach may be getting a little bit bigger.

At its meeting Monday, the Gold Beach City Council made another attempt to expand the city limits, reaching up Jerry's Flat Road to several city-owned lots and one privately owned lot.

The move aims to extend the city further up the Rogue River towards the edges of its urban growth boundary and connects the city's water intake infrastructure with the rest of the city.

"Since the 2016 adoption of the Water Master Plan, it had been the plan to annex the city's critical water infrastructure parcels into the city - under our jurisdiction and control once we had secured the raw water intake parcel," city staff wrote in planning documents supporting the move. "This plan was put into motion when we acquired the parcel in 2018.

The city also hopes the annexation will encourage future annexations on the road, encouraging development which benefits the city, and will allow the city to exercise more control in the area, city staff wrote. "Local ownership and inclusion

within the city limits will provide markedly improved security and the ability to protect, enhance and conserve the property's scenic and natural resources," part of the Feb. 1 council report read.

It's the city's first annexation since 2007 — but Monday's meeting was the city's second go-around to make it happen.

The first came in December, when councilors considered a similar proposal. At the time, the council approved the first reading of the annexation ordinance, the first of two such approvals it would have to make.

But that plan was interrupted by objections from Curry County, which raised concerns about the inclusion of the piece of privately owned property in the annexation

plan are owned by the city around the water intake, totaling just under 11 acres. But a fourth piece of property, over 150 acres, is privately owned and has been largely vacant since an old mill burned in 1991, according to city documents.

Three pieces of property in the

County staff and commissioners objected to the inclusion of that property in the plan, as well as some of the plan's technical aspects.

The county sent a letter to the city council before it considered the first ordinance, and then-chair of the board of county commissioners Chris Paasch reiterated that letter before the city council in December.

With classes now on Zoom, Bartlett-Iverson said she can have grandparents in one location sign up for classes with their grandchildren in another. They can get together weekly and sing and make their own music.

'We have ways to connect families like never before," she said.

While there are fees associated with the classes, Bartlett-Iverson said scholarships are available for families in need. She currently teaches music classes for newborns to 10 years old. She is also working to enlist teens to work with seniors on technology. She has plans to distribute iPads to assisted living facilities and hopes the teens can lead distance classes to teach the seniors how to use them.

The iPads can then be used to visit with family, send messages and even do important things like sign up for the COVID vaccine.

While her work today is in Brookings, Bartlett-Iverson is working on a model that can easily be transferred anywhere in the nation. With a trained teacher, Harmony and Me can be used to touch lives anywhere, she said.

While Bartlett-Iverson has been working with her nonprofit for more than a decade. it is a labor of love. She does not get paid and maintains a full-time job to cover her expenses. A few grants have helped provide things like the iPads and music materials she loans out, but it's mostly a labor of love.

"This just passion work, this is totally passion work,' she said. "It's a calling. I can't not do it. I want it to explode."



# Deputies rescue man, dog

A Grants Pass man who became stranded when heavy rains caused the water level to rise near Miller Bar is safe and warm thanks to the Curry County Sheriff's Office Search and Rescue Team.

Kristopher Bural drove out to Miller Bar with his 15-year-old dog Pearl on Sunday but realized Monday morning the rising water was not going to allow them to leave.

At 9:37 a.m., Bural call 911 and told the dispatcher they were stranded in the water and needed help getting out. Deputies and a state trooper responded to the area and were not able to find Bural

With the Chetco River rising due to the rains, responding deputies could not reach Miller Bar.

Two hours after the 911 call, deputies spotted Bural's vehicle about a half mile below the entrance to Miller Bar. At around the same time, Bural called 911 a second time to report he was not able to climb up the bank any further with

A deputy and the state trooper made their way through the water and reached Bural. At the time, he said he had come to area around noon Sunday and was cold and lethargic but mostly healthy.

The two law enforcement officers at the scene determined the only way to get Bural and his dog away from the rushing water was by boat.

Search and rescue member Ryan Mc-Ginnis, who is also a rescue swimmer, was called in to assist and he arrived with a small jet sled boat he built himself. McGinnis has previously used the boat on several rescue missions.

At around 2:41 p.m., McGinnis and Deputy Garrett Shannon, also a rescue swimmer, launched the boat at the base of Miller Bar Road. McGinnis and Shannon located Bural and his dog

about a quarter mile away and were able to transport them back to the entrance of Miller Bar.

A deputy then gave both a ride to a Brookings hotel for the night. Bural said once the water receded, he would return

# Curry County COVID case numbers remain low

COVID-19 cases ticked up slightly over the last week, but COVID remains mostly under control in Curry County despite most of the economy opening up in recent weeks.

Ward said despite the recent drop in cases, it remains important that all residents take basic steps to protect themselves from COVID. That includes washing hands regularly, wearing a mask in public and maintaining social distancing. Most importantly, if someone is showing symptoms of COVID, they need to stay at home to avoid spreading the virus.

Just before the machine arrived, deputies made it through the snow and were able to locate Schaller and Miller walking in the deep snow a couple of miles from their vehicle. Despite having to cut several trees, the deputies were able to transport the two men about 10 miles to a waiting ambulance. Schaller and Miller were both wet and cold and showed signs of hypothermia, but they refused medical services and went home with friends.

Ward said one good thing that came out of the rescue is he was able to use it to order a Sno Cat for Curry County. He explained Title 3 funding is available for the county, but the money can only be used to assist search and rescue efforts on federal land. Since the men were lost in federal forest, Ward ordered a Sno Cat that will be paid for by the federal government.

"It would probably turn a 10-hour day into a twohour day," Ward said. "The machine we were using struggled quite a bit."

Ward said having the Sno Cat will save lives in Curry County and possibly else-

where as well.

"We used to have a couple of snowmobiles, but they were the wrong kind," he explained. "We have to go off road just to find people. We'll be the only county on the coast to have one, so we can help other counties."

Ward said over the years, several people have died after being trapped in snow, especially near Bear Camp. With the Sno Cat, the search and rescue teams will be able to find people faster, which will save lives.

In the search last month, Ward said the men made a big mistake when they split up. He said the two men who left would have had to walk 15 miles in thigh-deep snow to find help, and they easily could have gotten lost Without being found by the search and rescue team, they easily could have died on the mountain, Ward said.

Before going on trips to the mountains, Ward said tell loved ones where you are going and everyone should be prepared for an emergency.

"Make sure you're prepared, just in case things go bad," he said. "If you're lost and nobody has heard from you, we will find you. Just stay with your vehicle."

# Keeping an eye on government can be enlightening

One of the interesting parts of working during a global pandemic, especially in 2020 and 2021 with

the technology we now have, is being able to be in more places than ever before — without ever leaving my home or my desk.

In the first two days of this week, I have covered government meetings in Crescent City, Calif., Brookings and North Bend. Over the last month, I have covered the Coos Bay City Council, North Bend City Council,

Coos County commissioners, Curry County commissioners, Del Norte County supervisors and Crescent City City Council, and only twice have I gone anywhere in person, once to Curry County commissioners and once to North Bend City Council.

The ability to do so much without ever leaving my desk, or in some cases, my bedroom has given me the unique opportunity to watch how different government entities work. Those of you who rarely see government bodies in action would be surprised how different they can be from city to city and county to

Generally speaking, there are three kinds of local government bodies. The first is dominated by a strong hired official, either a city manager or county administrator type. Often, those meetings are rather boring as the elected body listens to a report from staff and votes how staff recommends. Often in those cities, you will see few opposed elections as the level of interest in government is pretty low.

That can be good and bad. A strong leader is wonderful if the leader is wonderful. If the leader has issues and the council puts all their faith in him or her, that can be a big problem.

In this region, none of our gov-

ernments work that way. I would guess the closest is probably Coos Bay, where Rodger Craddock is a deeply respected city manager who seems to know the answer to every question. I say that as a compliment. Rodger really does appear to know it all, and his council seem to agree. But the Coos Bay council does ask a lot of questions, does debate issues and does come to conclusions on their own.

In North Bend, you can tell there is a relatively inexperienced council with a new city leader. They are learning together. But in doing so, they listen intently, ask a lot

of questions and work together to come up with solutions. I actually

North Bend has some big budget issues it is dealing with, so the council and staff have some challenges over the next few months. It will be interesting to see how it plays

I have only seen one Coos County meeting, but since there is no hired leader in the county, it is clear commissioners are in charge. And they are different. It leads to good

debates and good details about the nitty-gritty of government. With no administrator and strong elected officials, Coos County put a lot of faith in three people, but so far, they seem up to the task.

That brings us to Curry County, where county officials have been in the news a lot lately. I have covered several communities similar to Curry County, and what they are going through, I commonly refer to as growing pains. Much like Coos County, Curry County has strong commissioners. They do have a top county official, but that position is not meant to be a county administrator, leaving three commissioners to oversee day-to-day operations.

And it's been a challenge. Two commissioners have differing views on what being in charge means and it shows at almost every meeting. While it is concerning at times, ultimately, it's a pretty good sign. Curry County is going through growing pains, but to get anywhere good, sometimes it requires some pain.

To the far south of our coverage area, lies Crescent City, Calif. The city council and city staff there might be my favorite to watch of any of them. The council is mostly young and relatively inexperienced, and almost every department head in the city was hired in the last four years.

But they have big plans and big goals and are shooting for the moon. I can't predict how things will turn out long-term, but the city seems to trust them based on election results last year where voters approved a tax on themselves to fund city functions.

Government from the inside is a messy beast. It moves slow, it often angers the residents, but it is vitally important. During COVID, you, too, could get an inside look. Watch on Zoom or via video. It might be

# State health officials modify vaccine allocations, report 'dramatic declines' in cases

In a press conference Jan. 29, officials from the Oregon Health Authority and state researchers discussed the state's shifting vaccination plans, the prevalence of COVID-19 variants in the state and a significant slowing of the virus in recent weeks.

On vaccines, OHA Director Patrick Allen told reporters the state was planning to change how doses of the COVID-19 vaccine would be distributed the following week. The move came after some

counties across the state announced they'd finished with vaccinating individuals in the phase 1A population — health care workers and first responders and were beginning to vaccinate older individuals. The state's timeline doesn't

open vaccine eligibility up to seniors until Feb. 8, so Allen said the state needed to reallocate some planned doses to areas with more health care workers and others in the first category of vaccine distribution.

"If you're a county that believes you've vaccinated all your eligible populations, we're not giving you additional doses to vaccinate your ineligible populations," Allen said.

In effect, the announcement means 18 counties will receive fewer doses Feb. 1 than were originally planned, including Clatsop, Josephine, Lincoln, Marion and Tillamook.

On the flip side, 13 counties will receive additional doses of the vaccine the same week to help push through phase 1A, including Columbia, Coos, Douglas, Jackson and the tri-county area around

The change only applies to the Feb. 1 dose allocation in an attempt to keep the level of immunity equitable across the state, Allen said. The state will also begin receiving about 10,000 more doses a week the coming weeks. Teachers and other education-

al staff have begun receiving vaccinations statewide, and Allen said OHA hopes to have a "critical mass" of them vaccinated by

Feb. 14, when individuals over 75 become eligible for the vaccine under the state's plan. "In general, we're aiming to

reach approximately 70% of each eligible population before moving to the next eligible population," Allen said. Allen also said the state's

Vaccine Advisory Committee had recommended which groups should be next in line to receive the vaccine: People 16 to 64 with certain medical conditions, "frontline" workers (which has yet to be defined), adults and youth in custody and those living in low-income housing and congregate senior housing.

Under the VAC's plan, people living in multi-generational homes would follow those groups before eligibility opened to the general population. The proposal still needs to be

reviewed by OHA officials and forwarded to the governor's office for final implementation, Allen A panel of scientists from Or-

egon Health and Science University and Oregon State University also discussed the presence of COVID-19 variants in Oregon.

Dr. Brian O'Roak, an OHSU researcher leading an effort to sequence the genome of the virus which causes COVID-19, first explained how virus variants come As the virus reproduces, it

copies its genetic code to pass on but sometimes, mistakes in that copying process can change the genetic code. "We know now that it makes

on average about one mistake copying that genome every two weeks," O'Roak said. O'Roak and his colleagues have

collected thousands of samples of the virus from across the state to analyze for variants. The analysis can also show

researchers how many different forms of the virus came into the state from elsewhere. In the first three months of the pandemic, the state saw about 20 introductions of the virus from various parts of the world, O'Roak said. A team from OSU has also been

tracking the spread of variants in the state by analyzing wastewater from 40 different sites, including OSU's campuses as well as several cities along the coast.

They've identified the presence of several global variants of the virus, including forms which some studies suggest are more transmissible and less susceptible to antibodies. The possibility they could spread is a reason for caution, said Dr. Brett Tyler, part of the OSU tracking effort.

"As these strains continue to enter our communities as our findings indicate, we reinforce the importance of all Oregonians being vigilant about protecting themselves, their families, and those around them by wearing at least one correctly fitting mask when in contact with others, limiting indoor gatherings, maintaining social distancing, washing hands regularly and, above all, getting vaccinated when their time comes," Tyler said.

Still, the conference came on the heels of significant improvements in the state's key health

"In the past two weeks, we've seen dramatic declines in daily cases, as well as our hospitalizations," said Dr. Dean Sidelinger, state epidemiologist. "We are returning to daily case numbers last seen in early November, before our winter surge."

The period between Jan. 13 and 26 saw a 45% drop in average daily cases, and Oregon is ranking among the lowest in COVID-19 cases and deaths, Sidelinger said.

He attributed the decreases to Oregon residents following pandemic precautions, adding that numbers could quickly surge again if the state lets its guard down.

"Back in early December we were worried, legitimately, that unabated the virus would overtake us, swarming our hospitals and medical facilities with new infected patients," Sidelinger said. "It's a tribute to every Oregonian that we were able to avoid that fate, and by continuing to heed the personal protective measures, we have succeeded in tamping down the virus."

# Oregon's extended unemployment benefits are about to come to an end

The U.S. Department of Labor informed the Oregon Employment Department that it is turning off Oregon's Extended Benefits program because of Oregon's declining unemployment rate. With this federal decision, up to 13 weeks of EB no longer will be available after Feb. 20.

"Extended benefits has been an important safety net that has helped many Oregonians make ends meet. Fortunately, the Continued Assistance Act is providing another safety net, and EB claimants will be able to move to the Pandemic Emergency

Unemployment Compensation program for an additional 11 weeks," said David Gerstenfeld, acting director of the Oregon Employment Department.

Extended Benefits is a program that extends regular Unemployment Insurance benefits when a state is at high unemployment. The average unemployment rate is reviewed at the federal level over a three-month period to determine if the state goes into this extension. If the average unemployment rate is below 8% but at or above 6.5%, then up to 13 weeks of additional benefits are available under EB.

The ending of EB will not happen immediately. Claimants can continue receiving EB benefits for three weeks and should continue filing EB claims through Feb. 20. After this date, the Employment Department will move claimants to PEUC so claimants will not need to restart their claims. This switch from EB to PEUC may require manual changes, delaying some PEUC payments. All payments will be made retroactively, and claimants will not lose out on any weeks of benefits they are eligible for.

In the event that this improvement to the unemployment rate is temporary and Oregon's unemployment rate increases to 6.5% or higher, OED will not need to meet the statutory 13-week delay period to turn EB on, per a recent authorization from Governor Kate Brown.



That takes planning: CHN's vaccination clinics are currently scheduled to cycle through the network's hospitals and clinics in Port Orford, Gold Beach and Brookings Friday through Monday, with pre-scheduled appointment times for each eligible individual.

But with only a specific number of appointments, there can end up being more doses at a clinic than patients, if someone doesn't show up at their scheduled time.

Since COVID-19 vaccines expire relatively quickly once they've been taken out of freezers and mixed for administration, clinic staff have to act quickly to make sure those doses get used, not thrown away after they expire. So CHN calls for backup:

A waitlist of people in the area interested in getting a vaccine when their time comes. As clinic staff discover they have additional vaccine available at the end of a day, they reach out to those who've already signed up and offer them the impromptu doses.

Right now, that interest list is available for anyone 65 or older, and the signup is online at www.curryhealthnetwork.com.

Patients should bring their insurance cards when receiving the vaccine – the costs are covered by insurance (or by another program for those without insurance), but an insurance card is still necessary to bill the right place.

Williams said CHN is following state guidance for vaccine eligibility - meaning vaccines will be available for individuals 80 and up starting Feb. 8, with the eligibility age decreasing by five years each week after that until age 65, though CHN may have to take a slower timeline as the eligible population grows faster than available doses.

CHN is ready to keep expanding its vaccination clinics, but Williams said doses of the shots are the limiting factor in how much the network can do each week. Her staff estimates it could administer 360 doses a day at full capacity, but is only receiving about 300 a week from state health officials. "We just haven't received

enough vaccine to standup a clinic that large," Williams said.

What's more, another challenge is timing, since state officials announce on Thursdays how much vaccine they'll be shipping the very next week. That doesn't give Williams and her team too much time to plan, she said.

Still, she said CHN is making the best of the doses it gets. Williams attributes much of that to the network's staff, as well as a cadre of volunteers supporting the system. "It does take a concerted

effort," Williams said. "It requires you to have additional staffing."

Janet Hoffman, the executive director of the Curry Health Foundation, manages those volunteers.

"We're kind of just the ones that make sure everything flows right," Hoffman said.

Hoffman's volunteers staff the entryway of the CHN clinics, and guide people from registration to the lobby where they'll get their shots. From there, they direct patients toward the second lobby.

"The second lobby is where our lobby monitors are asking for symptoms," she said. Volunteers are trained by the

hospital on things they might encounter during the clinics, like the kinds of symptoms to watch out for after a shot is administered and how to navigate patient privacy laws. They're also required to

be flexible, Hoffman said, in case CHN receives a different number of doses than was planned for and schedules have to change, since "what's basically setting the schedule right now is when the vaccines come in."

"We do have these very dedicated volunteers and they're doing a great job," she said.

At least one other organization in Curry County is

FRIDAY, FEBRUARY 5, 2021 | **A5** distributing vaccines, too. AllCare Health is planning a vaccination event for Feb. 6 and 7, according to organizer Cameron McVay.

That event will deliver between 200 and 250 vaccines to people with intellectual or developmental disabilities, a group identified by state health authorities as necessary to vaccinate, according to McVay. "The state had made it

a priority," McVay said. "We're happy to focus on that population." McVay said many eligible

caregivers of eligible individuals have been contacted and that, with vaccines in such high demand, AllCare's future mass vaccination plans still haven't been finalized.






