

Fire destroys home; neighbors concerned

A devastating early morning fire that may have killed a dog was started by a person still squatting on the property who is now, according to the next-door neighbors, threatening to burn down their home. The fire occurred in the 97900 block of Court Street in Brookings at 2:53 am Monday.

Timothy Capps, the person allegedly responsible for the fire, was inside a camper Tuesday afternoon on the property and was eager to talk about the incident.

While showing the damage to the home, as well as a camper that was parked at the back of property - where Capps was previously staying - he spoke of “divine intervention” that included visions in his sleep of the female property owner escaping the fire unharmed.

While Capps’ dog sniffed at debris near his feet, he also talked about previous fires he had

been in but was unable to elaborate except to say that divine intervention told him to wake up and leave the camper. He then dropped his jeans down to his knees, saying “I was wearing only these when it happened.” Underneath Capps’ jeans was a pair of red, flannel Santa Claus pajamas.

When asked how the fire started, he pointed to what appeared to be the point of origin, and said “It started right there, on the kitchen table.”

All that was left of where the kitchen table once sat was ash, debris and the metal framing of the camper.

According to Capps, he lit a candle Sunday night and fell asleep while it was still lit.

Witnesses and a first responder both said the scene of the fire was chaotic, and not just because of the intense flames.

According to Fire Chief Steve McClintock, of the Harbor Rural

Controversy over St. Timothy’s is growing

It’s Saturday afternoon, and members and volunteers of St. Timothy’s Episcopal Church are huddled at a picnic bench under a stately tree, steaming plates of ribs and calzone before them. Joining them is Diana Akiyama, the R.T. Rev., Bishop of the Episcopal Diocese of Oregon.

It’s been at least a year since Akiyama has been to St. Tim’s, but she made the six-hour trek from Portland to show support to one of the 70 congregations she oversees.

“Welcome!” shouts Father Bernie Lindley, the pastor of St. Tim’s who, for better or worse, is well known in the Brookings community. They all look up, including Bishop Akiyama.

Lindley quickly unfolds his legs from under the wooden table and strolls across the grass while simultaneously explaining that it’s a slower Saturday than usual. Plus, it’s only 12:30 pm - the start of the day for people to arrive to gain access to the many services the church provides.

For all this unfettered comradeship, however, not everyone in the community is pleased that St. Tim’s has hot food available

Significant upgrades coming to Beachfront RV Park

Significant upgrades are coming to Beachfront RV Park in the Port of Brookings, starting early next year.

On October 7, the Port of Brookings Harbor Commission approved sub-contractor and Brookings-based McLennan Excavation to make electrical upgrades at Beachfront RV Park. McLennan beat a competing bid by about \$188,000.

All told, upgrades to the busy tourist destination to the tune of \$657,000 will start next year, with a projected completion date in April.

According to harbor staff reports, the port budget for the project is \$558,416, but another \$100,000 was transferred over from the general fund to cover the remaining costs.

“The project consists of providing six new RV sites and modifications to sites 76 through 98,” said Port Manager Gary Dehlinger.

Specifically, the details include:

- Six new sites
- Front row sites will be upgraded to power 50amp/30amp/20amp GFCI service with new pedestals
- New water and sewer lines to sites 76 through 98 and the six new sites
- All RV sites will receive new spring-loaded sewer caps
- The relocation of up to two existing light poles, and the relocation of two transformers
- Sites 76 through 98:
- Demo of all existing concrete pads
- Demo of existing electrical building and replace with outdoor electrical panel
- Realign sites at 45 degree angle and pour new concrete pads

Rising seas could change coastal regions

With climate change impacting the Earth, sea levels are beginning to rise again, and as they rise it will impact the shorelines many in Oregon and California call home.

That's the message Kim McCoy shared during a virtual meeting celebrating the 50th anniversary of the Oregon Shores Conservation Coalition.

McCoy recently updated the book, Waves and Beaches, which was originally written by Willard Bascom. The book is considered the leading authority on beaches, shorelines and the impact waves and weather have on them.

McCoy, a physical oceanographer, adventurer and expert on coastal wave dynamics, said the impact on the coast is directly linked to weather events far away.

"Everything that happens upstream impacts what happens

Fire District, the female owner of the home was uncooperative, and Capps was “getting belligerent.”

The neighbors, the VanScoyks, collaborated McClintock’s account.

“I heard people freaking out,” said Andrew. “I ran out and started to battle the fire with my garden hose to protect our home. Our neighbors were fantastic and tried to help.”

To which Rebecca interjected with “but he (Capps) was jumping in and out of fire trucks and cop cars,” she said. “He was super combative. Still, they didn’t arrest him.”

According to McClintock, the fire has been ruled accidental, due to the lit candle.

McClintock added that while it appears Capps is mentally incompetent, they have no reason to believe it was set intentionally.

Regardless, the VanScoyks said they are worried.

“He said he was going to burn it down,” said Rebecca. “And he has also said he is going to burn down our home.”

The night after the fire, Rebecca and Andrew said they slept in shifts so they could take turns watching the perimeter of

their home, in case Capps followed up on his alleged threats.

“He’s not even supposed to be there (in the other camper not destroyed by the fire),” Rebecca said.

“He won’t get out of the camper. He broke into it.”

The VanScoyks also said they believe one of the dogs who lived in the mobile home perished in the fire, but another dog named

“Hitch” was now being cared for by the Humane Society.

In the meantime, the VanScoyks reiterated they are on edge and afraid to sleep at the same time.

“He told us this is the fourth place he has been in that has burned down,” said Rebecca. “We also heard that he just got out of jail over the weekend, and he immediately came here and started to say he is going to set our house on fire.”

A call for comment to the Curry County Sheriff’s Department was not immediately returned at deadline.

If you see racism, call it out

Black Americans get a lot of messages about who matters and who does not in this country, and the question is: Are the messages intentional or unintentional? I lean towards unintentional but they have become deeply ingrained.

I’ve driven Interstate 15 in Utah dozens of times over the course of two decades, traveling from my home in western Colorado to one of my favorite adventure playgrounds in Zion National Park and nearby. The route takes me through Saint George, Utah, an area referred to as the state’s “Dixie.”

There are a lot of Utah Dixies, though there’s movement to change some names: Dixie National Forest, Dixie State University, Dixie Hospital. Saint George is a retirement community, and Chamber of Commerce signs on the highway extoll the many virtues of retiring to the Dixie area.

But here’s what I notice: Every sign, no matter how often it gets re-placed, always features white couples.

I used to ski patrol at one of the Aspen ski resorts. Every year the Aspen Skiing Company would unveil a new marketing campaign, and employees were required to attend a meeting to see what the company would promote that year. Ads and movies featured many hundreds of happy people — happy white people.

I met with the senior executive VP of marketing and pointed out that he was sending a message to folks that Aspen was a playground for whites only. Twenty years later, the Aspen Skiing Company, a company with the best of intentions in advocating for and creating racial justice, still does not include any Black images in its advertising, so ingrained is the image of skiers being white.

A few years ago I toured the national capitol in Washington, D.C. The tour ended in the rotunda where the guide proudly drew our attention to a huge ceiling painting and border sculptures that had plenty of room to capture key moments in the development of the nation: Brave-looking white guys astride

ferocious looking white horses. Chinese railroad workers. Noble “savages,” aka Indigenous peoples. Men, woman and children trekking the Oregon Trail.

But what wasn’t there, in a building built with Black labor, was any depiction of a Black American.

When we sing the national anthem, if we get to the third verse, we pay tribute to slavery even there. The man who wrote this ode to freedom owned human beings who never experienced the freedom that Francis Scott Keys wrote about.

When we were very young, all of us were taught about George Washington’s father’s cherry tree, and the “Father, I cannot tell a lie” story. But most of us learned on our own, years later, that the father of our country owned slaves. But his slave-owning isn’t the odd part.

On our \$20 bill we honor a ruthless slave-owner. In an ad headlined “Stop the runaway,” which Andrew Jackson placed in the Tennessee Gazette in 1804, he promised to pay not just \$50 for the return of his escaped slave, but also “ten dollars extra for every hundred lash-es any person will give him, to the amount of 300.” I will be glad to see Harriet Tubman’s face replace Jackson’s on the bill after a long fight to get this done.

And every Black person has had the experience of waiting in some check-out line, only to have a white person cut into the line right in front of them. In a sense, it’s not even rudeness. America has made us invisible.

So now, here we are... a country tearing itself apart with hate, distrust and dysfunction. Over time I’ve come to realize that racism, intentional or not, is the ladle that stirs this dangerous, unpleasant brew. Do we want a better country for everyone? Recognize racism. Fight it. We’re all in this together.

Locking veterans out of the veteran's clinic

Fear can cloud people's judgement. Often, in an abundance of caution, irrational policies and procedures are applied to a perceived threat. For example: Ever since the coronavirus pandemic began, the Brookings Veteran's Clinic has been locking the veterans out of the building. I'm not opposed to a little caution, as long as it's applied with some common sense.

I've checked, and it's not VA policy to lock veterans out of veteran's clinics.

I'm 70, and when I visit the clinic I'm often the youngest veteran in the building. When these 70, 80, and 90 year old veterans visit this clinic (and the guard opens the locked door) they're examined to determine if they're toxic.

Their names are then compared to a clipboard to see if they have an appointment. If their names don't appear on that board they're told, "You're not on my list. You don't belong here."

I've sat in the waiting room of that clinic and seen the fear and desperation on the faces of these old veterans when they're told, they don't belong there. It breaks my heart.

I have a message for these flinty people working at the Brookings VA Clinic. These old veterans don't ask for much, but they do need medical help. Veterans do indeed belong at the veteran's clinic. Quit locking them out.

On Friday, Oct. 8, the actress's rapid test results came back negative. "The show will go on," said Mary Anne Trailor, president of the CPP.

During the board meeting, one of the members stated that she immediately informed the cast, crew and board of the COVID-positive result, and that "she has been contacting those who made reservations that (Oct. 1 - Oct. 3) weekend."

During the performances that the actress may have been COVID-19 positive, none of the actors were wearing a mask.

According to Trailor,

actors are exempt from wearing masks during live productions.

Trailor also stated that she believes the risk of transmission to the audience was low because the nearest row to the actors is 8 feet away, and up to 20 feet away for those sitting in the last row.

However, one board member and a guest at the board meeting expressed concern that at the end of the play, when several of the actors play dead behind a set piece that looks like a wall, the separation is closer to 6 feet.

The venue seats 80, and according to Trailor it was a "full house, or about three quarters full," she said. Trailor added that the usual meet-and-greet where the actors mingle with the audience after the plays did not occur.

The Curry Coastal Pilot attended the Oct. 7 board meeting after receiving a call from a Brookings resident who did not wish to be identified, but said a friend of his attended the Dracula production on Friday, Oct. 1, then developed a fever

three days later.

However, the Pilot was unable to connect with the unidentified person who allegedly became ill, and the anonymous source informed the Pilot on Oct. 8 that a test for COVID-19 for the friend came back negative.

In addition to the COVID-positive cast member, there was some concern about mask wearing.

On Sept. 30, a vandal defaced some of the theater's signs and Drac-

ula promotional banners, including a sign at the entrance that requested members of the audience to wear a mask.

However, according to Trailor, the cast and crew did not notice that the mask-wearing sign had also been destroyed, and last week's shows did not include a verbal request to wear a mask. Trailor said she was unable to verify whether all members in the audience were wearing masks.

Newsom signs K-12, broadband bills

Governor Gavin Newsom recently signed a suite of bills to increase K-12 student supports, expand broadband access to help bridge the digital divide and expand educational opportunities for students to help boost academic achievement and attainment – critical parts of the state’s historic \$123.9 billion K-12 school education package.

“What we’re doing here in California is unprecedented in nature and scale, but it all comes back to providing California’s students with the best opportunities to learn, achieve and succeed,” said Newsom. “We’re implementing the historic, transformative measures needed to help support our students’ health and wellbeing, bridge the digital divide with improved access to broadband, and expand educational opportunities for future generations.”

“I am thankful and thrilled that there are bills, and now law, that will drive more resources and supports to student mental health and help close the digital divide, both of which are major priorities of mine,” said State Superintendent of Public Instruction Tony Thurmond.

“Helping our students rebound from the emotional toll of COVID-19 and develop the social-emotional learning needed to thrive and grow will take a concerted focus on mental health supports at our schools. I thank

both Governor Newsom and the Legislature for their work to bring these much needed resources to our campuses,” said State Board of Education President Linda Darling-Hammond. “I also want to applaud the attention given to connectivity – key to a 21st century education. My hope is that future improvements to broadband will push our educational system to further integrate technology into everyday student learning.”

Newsom signed legislation to significantly improve mental and behavioral health supports in schools, both as students return to in-person instruction after the pandemic and for the long-term benefits for future generations:

AB 309 by Assemblymember Jesse Gabriel (D-Encino) - Requires the California Department of Education (CDE), in consultation with the State Department of Health Care Services, to develop mental health model referral protocols addressing the appropriate and timely referral by school staff of students with mental health concerns, for voluntary use by schools, contingent upon an appropriation for this purpose.

SB 14 by Senator Anthony Portantino (D-La Cañada Flintridge) - Includes “for the benefit of the behavioral health of the pupil” within the “illness” category for excused absences for purposes of school attendance; and requires the CDE

to identify an evidence-based and evidence-informed training program for local educational agencies to address youth behavioral health, including staff and pupil training.

SB 224 by Senator Anthony Portantino (D-La Cañada Flintridge) - Requires schools offering one or more courses in health education to pupils in middle school or high school to include mental health instruction in those courses, as specified.

The governor also signed legislation to improve access to broadband across the state, particularly for those in underserved communities, in order to help bridge the digital divide:

AB 14 by Assemblymember Cecilia Aguiar-Curry (D-Winters) - Extends the California Advanced Services Fund (CASF) program to encourage deployment of broadband service to unserved Californians, and revising the surcharge collection methodology for interconnected Voice over Internet Protocol service and the Deaf and Disabled Telecommunications Program

SB 4 by Senator Lena Gonzalez (D-Long Beach) - Extends the operation of the CASF through 2032, increases the annual funding cap for the CASF, and expands projects eligible for CASF grants to include fund broadband deployment at unserved locations used for emergency response.

SB 28 by Senator Anna Cabalero (D-Salinas) - Expands the authority of the California Public Utilities Commission (CPUC) to collect data to enforce requirements for cable franchises, and authorizes the CPUC to set customer service requirements for cable providers. A signing message can be found here.

Additionally, Newsom signed ethnic studies legislation that will help expand educational opportunities in schools, teach students about the diverse communities that comprise California, and boost academic engagement and attainment for students as shown by a Stanford University study. The bill also provides a number of safeguards to ensure that courses will be free from bias or bigotry and appropriate for all students.

AB 101 by Assemblymember Jose Medina (D-Riverside) - Requires that local educational agencies and charter schools serving students in grades 9-12 offer at least a one semester course in ethnic studies, commencing with the 2025-26 school year. Also requires students, beginning with the graduating class of 2029-30, to complete a one semester course in ethnic studies that meets specified requirements in order to receive a high school diploma. A signing message can be found here.

“Thank you to Governor Newsom for signing AB 101. The inclusion of ethnic studies

in the high school curriculum is long overdue. Students cannot have a full understanding of the history of our state and nation without the inclusion of the contributions and struggles of Native Americans, African Americans, Latinos, and Asian Americans,” said Assemblymember Jose Medina. “I want to acknowledge the countless young people, high school and college students, teachers and professors, who have organized, demonstrated, boycotted classes, and gone on hunger strikes to demand a more equitable and inclusive educational system. The signing of AB 101 today is one step in the long struggle for equal education for all students.”

“At a time when some states are retreating from an accurate discussion of our history, I am proud that California continues to lead in its teaching of ethnic studies,” said Secretary of State Shirley Weber. “This subject not only has academic benefits, but also has the capacity to build character as students learn how people from their own or different backgrounds face challenges, overcome them and make contributes to American society. I want to thank Assemblymember Medina for his persistence in moving this bill forward and Governor Newsom for his support and for making ethnic studies a reality in our schools. This is a great day for California.”

Family Yard Fall To-Dos Wood applauds bill to improve broadband ‘Dig Once’ policy

Fall is a dog-gone good time to spend in your family yard. It’s also the top-dog time of year to prep our living landscape for another favorite season—spring.

Here’s what you need to do now to have a fabulous and TurfMutt-approved family yard this fall and beyond.

Mulch Leaves: Mulching your leaves rather than raking and bagging is good for your lawn and the environment. As shredded leaves decompose, they feed your lawn, naturally.

Aerate the Family Lawn: Aerating prevents soil from becoming compacted and covered with thatch - a thick layer of roots, stems and debris that blocks water, oxygen and nutrients from reaching the soil.

Mow at the Right Height: Keep cutting your grass until the first hard

frost. Find the just-right length for your species, typically between 2-3 inches, to keep your grass healthy when it turns cold.

Water Wisely: If you’re not getting at least an inch of water a week from Mother Nature, you’ll want to keep watering through the fall. Install watering solutions, such as smart controllers on irrigation systems, to help conserve water.

Last week, Governor Gavin Newsom signed AB 41 by Assemblymember Jim Wood (D-Santa Rosa), a bill that will improve California’s “Dig Once” policy and expedite the deployment of broadband infrastructure.

“The lack of broadband availability has always been a serious problem but never has it revealed itself as so critical as we have experienced in this COVID-19 pandemic,” said Wood. “There are many areas of the state that do not have access to the internet at all and many that have substandard connections. We need to connect children to schools and libraries, hospitals and clinics with our health care workforce, business with its customers and ensure access for people in our low-income and disabled communities.”

Many states use the “dig once” policy to maximize broadband deployment by leveraging new and ongoing roadwork and excavations, often along major thoroughfares, by installing conduit for telecommunications infrastructure at the same time. In 2016, AB 1549, authored by Wood and signed into law, required the state’s Department of Transportation to notify companies working on broadband

deployment of DOT-led highway construction projects and authorized those companies to coordinate on conduit installation.

“Broadband companies have been reluctant to build or invest in infrastructure in many rural markets where there are fewer customers, and I can only assume by their reluctance, less profit,” said Wood. “Well, now there is a commitment by the state to provide funding to build out what are called ‘middle miles,’ limiting the investment required by these companies to build out the ‘last miles’ necessary to connect cities and rural communities.”

AB 41 requires DOT, as part of those projects funded by \$5.25 billion in the recently passed Budget Act of 2021 and that are located

in priority areas, to ensure that construction includes the installation of conduits capable of supporting fiber optic communication cables. The new law also requires the California Public Utilities Commission, in collaboration with other relevant state agencies and stakeholders, to maintain and update a statewide, publicly accessible interactive map showing the accessibility of broadband service in the state.

“Broadband is as essential as electricity and water, and people in rural California have not had the access they deserve, especially evident during the COVID pandemic,” said Wood. “For the rural communities I represent, this will mean improved access and more competitive pricing for all residents.”

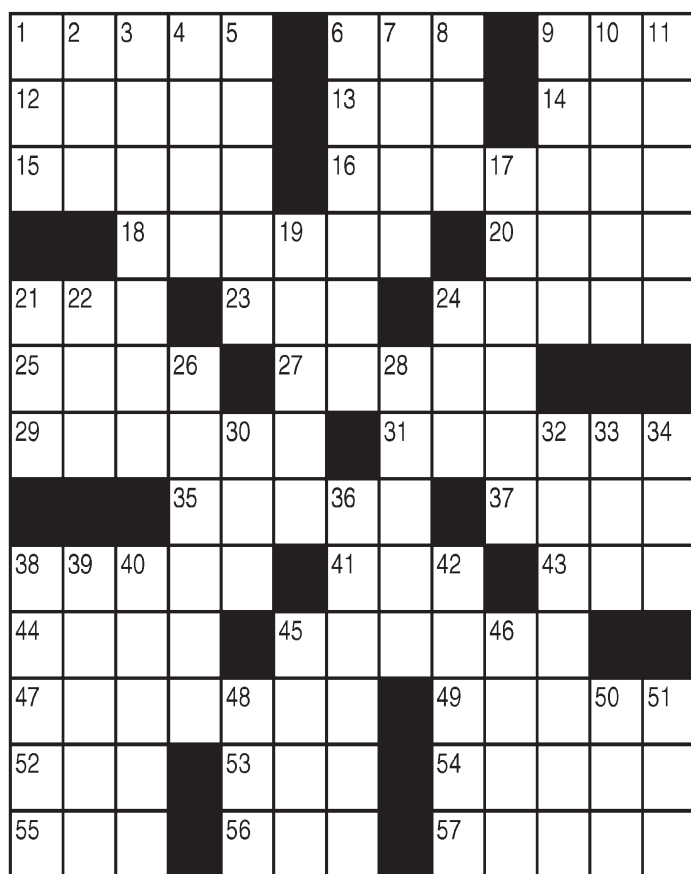

to those who want it. Or, at least some wish it wasn't every day.

On Oct. 5, the Brookings's Planning Commission narrowly voted in a 3-2 vote to recommend to the city council that the city revise its municipal land development code in such a way that "benevolent meal services" be required to obtain a conditional use permit, as well as limit food services to three hours a day, two times a week.

Had Commissioner Cody Coons not abstained from voting due to his membership at one of the churches mentioned in the staff report, a potential tie vote could have created a tenuous recommendation from the seven-member advisory board due to a one-seat vacancy.

The matter will now go before the city council on October 25 for a final decision.

"I am not willing to express any opinion on this issue other than what I have already spoken in the public record," stated Brookings Mayor Ron Hedenskog, following an inquiry on how he might vote at that meeting.

Hedenskog's carefully-worded email response may have provided a glimpse, however, when he added "Bernie Lindley, vicar of St. Timothy, has threatened the city, twice, with litigation if we continue to pursue the matter," Hedenskog added. "So, pending litigation, I have no comment outside of the public record."

Other members of the council did not respond to emailed requests for comment.

Lindley, in fact, did threaten to sue during the planning commission meeting.

"The whole point behind this is to have a prepared meal for people every day," Lindley said to the commission. "We are talking about folks who don't have the capability to make their own meals. They live in a car, or they live in the bushes somewhere. They don't have a refrigerator or stove, and even if they get food at the food bank, they can't prepare it anyway."

Lindley added that pre-pandemic other churches in the community - Star of the Sea Catholic Church, Trinity Lutheran, Smith River United Methodist and Brookings Presbyterian - each pitched in to feed hungry Brookings residents or transients passing through. Currently, St. Tim's, located at 401 Fir St., next to Azalea Park, provides food to the community six days a week.

"The only church that maintained a presence in the soup kitchen ministries, which we call community kitchens, was Trinity Lutheran Church," said Lindley, referring to the year 2021.

Whether churches will reignite their kitchen pilot lights as the pandemic wanes, however, appeared to be a matter of debate.

According to Brookings Public Works Director Tony Baron, two other churches expressed interest

in picking up some of the slack, thus taking the bulk of providing food to the community off St. Tim's plate.

"We met with Star of the Sea and Presbyterian and they indicated they would cover two days," Baron said. "Every church at the workshop had the opportunity to set these parameters. Two days seemed to be the norm with the three we spoke with."

Lindley, however, expressed doubt that other churches would serve food any time soon.

"Other churches aren't going to come forward," he said. "We found that out in the course of the last 11 years. We would be compelled to continue to feed all four days, and as this went forward, we would quickly be in violation of this new city ordinance and if we're fined, we would file a lawsuit against the city of Brookings."

City staff was quick to point out, however, that the CUP requirement is not prescriptive, but rather a way to clean up the code to allow churches to serve meals two days a week because municipal codes now define what churches are doing as being "restaurants" - an activity currently prohibited in residential zones.

"The perception is that we are trying to close these kitchens down, which is not true," Baron said.

Still feeling the sting of Lindley's lawsuit comment, Commissioner Anthony Bond responded by saying "We're being told 'Hey, it's my way or we're going to court,'" Bond said. "That's the second time you've (Lindley) said it. I personally don't take threats lightly. I think that's ridiculous and childish. If you're not willing to work with the city, that's too bad. That's your loss."

Commissioner Bond, Skip Watwood, and Clayton Malmberg then voted in favor of adding the definition of Benevolent Meal Services to the Brookings Municipal Code, as well as an added term that requires a CUP.

Commissioners Gerald Wulkowitz and Ray "Skip" Hunter voted no, and Coons abstained.

Four days after the planning commission vote, the little red church of St. Tim's - which at first glance resembles an old barn or schoolhouse - continued with its services.

A couple from Brookings arrived to undergo a COVID test. One of them wore a mask adorned with cartoonish male genitalia, which either escaped the notice of Bishop Akiyama, or she was too polite to mention it as she gently swirled each nostril five times after he had removed it. The woman with him said they were both vaccinated and not feeling sick but had recently traveled and wanted to be sure they don't expose others to the virus.

Another Brookings resident who had a fever also showed up, but he tested negative.

"Yesterday we tested 40 people, and two of them tested positive, including a 2-year-old child," said Lindley.

In another area of the

church, a Styrofoam sign attached to the door of a small health room advertised St. Tim's official clinic status of the Oregon Health Authority. A designation made possible with an initial \$230,000 grant, which was later bumped up by another \$175,000 due to high demand for COVID tests and vaccines at the church.

According to Lindley, St. Tim's has injected over 1,400 people, rapid-tested 3,500 (which includes tests given prior to vaccinations), and 575 people have learned they are positive for COVID as of July 27.

That, Lindley said, is when their wrap-around services truly come to light, including providing meal services.

While those devoted to St. Tim's remained resolute to the ministry's significance, police dispatch call statistics have painted a less rosy picture.

During the workshop held in June, it was noted that St. Tim's experienced a "significant increase in calls for service through dispatch of the Brookings Police Department," par-



ticularly when compared to other churches in the city.

In 2020, there were 154 calls for service to St. Tim's - well above Star of the Sea Catholic church, which logged 24 requests for service.

Trinity Lutheran, Seventh Day Adventist and Brookings Presbyterian logged 20, 19 and 13 dispatch calls, respectively.

The increased calls for police service, in addition to other concerns, spawned a petition signed by 29 neighbors. The petition requested from city hall that churches have limitations

when it comes to benevolent meal services, with the hope that those receiving meals won't trickle into nearby parks and other public spaces.

Tina Peters, who wrote a letter to the city during the summer workshop talks, said she is afraid to go to nearby Azalea Park, as is her daughter who she said once faced a transient's strike of a whip while walking along a park path.

There are people coming out of the bushes, sleeping in sleeping bags and walking up to us to see if we have coins or food," Peters stated.

"We are very sympathetic to people who feel threatened or concerned that their property has been trespassed," responded Bishop Akiyama last weekend. "But, I don't understand any public body - city, county, state - that does not want to take care of its people."

on the coast," McCoy said. "What happens upstream could very easily push out millions of pounds of sediment."

For decades, Bascom was the expert when it came to coastal areas. McCoy worked under Bascom and was asked to write the third update of Waves and Beaches. McCoy said the book covers coasts worldwide, but the work began in Astoria when Bascom was hired for the Waves Project. Last year, McCoy brought the new edition of the book to Astoria, going full circle.

"Where Willard Bascom started studying waves was in Astoria, and here it was returning a book all these years later," McCoy said. McCoy said as the Earth's temperature has slowly risen, it has caused ice, both on shore and in the sea to melt.

"When things melt above sea level, they raise the sea level," McCoy said. "When it's sea ice, it doesn't, so it's important what happens inland. As the Earth warms, ice not only melts and fractures, but it also melts from below because the water is warming."

As far as climate change, the ocean is the key to changing weather, McCoy said.

"The ocean is the key component to climate change," he said. "The ocean is turbulent. Turbulence is everywhere in the universe. The warming Earth is causing the rapid fluctuations in our weather patterns. You can't separate what's happening anywhere on Earth. It's all connected."

One impact on the coast is the loss of ice. McCoy explained that permafrost and ice on the coast protect the coast from waves and change. As the ice disappears, waves have a greater impact on shorelines.

And the changes could be devastating if something doesn't change.

"If there's a two-degree centigrade increase in global temperature, this is what will happen," McCoy said. "Miami will be underwater."

In Indonesia, rising water is putting 5 million people living in the capital city of Jakarta at risk. The risk is so severe, plans are being made to move the capital.

The danger is rising waters lead to rising waves. And waves change everything they touch.

"Every time a wave come into shore, it moves some sediment," McCoy said. "Every single wave moves particles, millions of grains of sand. Every wave is unique. There's no one wave that is repeated over time. Every single wave stirs up sediment, and that sediment goes someplace."

The good news is, the changes are just starting.

"The sea level hasn't changed much in the last 4,000 years," McCoy said. "It's starting to change. In the last 20,000 years, the sea level has gone up 400 feet, but not much in the last 4,000 years. But it is rising again."

And if climate change continues to lead to a warming Earth, sea levels will begin to rise quickly.

"We're all connected, and I can't stress enough, we need to have an understanding of what's happening," McCoy said. "We need to have average citizens have a sane approach to our coast."
