## NOTICE OF SHENANDOAH VALLEY ELECTRIC COOPERATIVE'S PETITION TO THE VIRGINIA STATE CORPORATION COMMISSION IN CASE NO. PUR-2025-00190

On October 16, 2025, Shenandoah Valley Electric Cooperative ("SVEC" or "Cooperative") filed with the State Corporation Commission ("Commission") a petition ("Petition") pursuant to §§ 56-231.34 and 56-236 of the Code of Virginia ("Code"). Therein, SVEC requests that the Commission accept the filing of SVEC's proposed Large Power Dedicated Facilities Contract Service Schedule LPD-2 ("Schedule LPD-2"). The Cooperative also requests that the Commission accept revised Rate Schedules B-15 and LP-15, which update the Cooperative's existing Schedules B-14 and LP-14 to clarify the eligibility criteria in Schedule LPD-2.

Per the Cooperative, proposed Schedule LPD-2 would be available to new large load consumers with an expected metered load of 40,000 kilowatts or higher served at a voltage of 20 kilovolts or higher through dedicated facilities. Upon Schedule LPD-2 becoming effective, the Cooperative states that it will withdraw its existing Schedule LPD-1.

In support of its Petition, SVEC asserts that large load consumers are expanding in Virginia, and the new Schedule LPD-2 would provide additional protection to mitigate the financial and operational risks associated with serving these consumers, including delays in payment, potentially failed businesses, reductions in contracted capacity, and early contract terminations.

SVEC states that it is proposing Schedule LPD-2 to provide a structured rate that is designed to serve these large load consumers. This rate schedule, according to SVEC, would allow the Cooperative to recover the full cost of providing service to these consumers, and would protect the Cooperative's existing members from subsidizing new large load consumers.

SVEC further states that to implement the new Schedule LPD-2, the Cooperative must revise its existing Schedules B-14 and LP-14 to limit the applicability of those schedules to large consumers.

The Cooperative requests that the Commission permit it to place its proposed Schedule LPD-2 and revised Schedules B-15 and LP-15 into effect on an interim basis for bills rendered on or after January 1, 2026. The Cooperative also requests that the Commission provide direction on whether or not a cooperative may accept cash as collateral, separately from a form of deposit as required by the Commission's regulation 20 VAC 5-10-20, Utility customer deposit requirements.

("Rules of Practice"), any notice of participation shall set forth: (i) a precise statement of the interest of the respondent; (ii) a statement of the specific action sought to the extent then known; and (iii) the factual and legal basis for the action. Any organization, corporation, or government body participating as a respondent must be represented by counsel as required by 5 VAC 5-20-30, Counsel, of the Rules of Practice. All fillings shall refer to Case No. PUR-2025-00190. For additional information about participation as a respondent, any person or entity should obtain a copy of the Commission's Order for Notice and Comment.
