



Board discussion: Additional ARPA funding for Broadband

Background

May 11, 2021, \$21.2M in federal ARPA CSLFRF monies allocated to the County to be deposited in two tranches

May 21, 2021, the first tranche of funding, \$10.6M was received

June 16, 2021, the Board approved an update to the County's ARPA SLFRF implementation framework integrating funding into the FY23-FY27 budget process

July 7, 2021, the Board appropriated \$21.2M in ARPA SLFRF

August 4, 2021, the Board approved including a portion of ARPA SLFRF funding into the FY 23 Agency Budget Review Team (ABRT) Agency funding process

Framework approved by the Board on June 16, 2021

- Funding to the Albemarle Broadband Authority (ABBA)
- For Projects within the ARPA SLFRF Guidelines

Programming Updates

- **\$0.8M** Funding for Emergency Assistance
 - Extending United Way program previously funded by CARES CRF
 - Provides support for rent and mortgage payments as well as utilities (gas, electric, water)
- Staff and County Executive's Office meeting to discuss immediate need programs:
 - Strategic planning around State and Federal programming
- ARPA SLFRF integrated into the ABRT for FY23

Structure to support programming:

 Grant supported resources for compliance, reporting, and procurement

Local ARPA SLFRF Funding

HB 7001 The Budget Bill

- 2021 Special Session II
- Waiting on many of the programs to release how they will be administered

Human Services

- **\$120M** for utility assistance
- \$862M to the Unemployment Trust Fund
- **\$25.6M** for food access
- **\$2.5M** to the Virginia State Bar for legal aid funding for legal representation in eviction cases
- Additional funding for Mental Health, Substance Abuse, Public Health

Economic Development

- \$250M Rebuild VA program
- **\$4M** to support the Virginia Main Street Program
- **\$50M** to the Virginia Tourism Authority

State ARPA Funding Opportunities

Broadband

- **\$0.5M** to the Department of General Services for legal and real estate transaction support
- **\$479M** for Virginia Telecommunications Initiative grant making process
- \$8M for the Line Extension Customer Assistance

Infrastructure

- **\$5.75M** to provide improvement funds for well and septic systems for homeowners at or below 200 percent of the federal poverty guidelines
- **\$75M** for septic, straight pipe, and sewer collection system repair, replacement, and upgrades
- \$50M to support equal access to drinking water

State ARPA Funding Opportunities

Housing Update

- \$20M in HUD grants for eviction prevention services
- \$2M HOME-ARP (coming to Thomas Jefferson Regional Home Consortium)

Tourism Opportunities

- U.S. Economic Development Administration
 - Competitive Tourism Grants
 - \$500M Good Jobs Challenge

Additional Federal Opportunities

Board's Discussion and Approval of Staff Recommendation on Local ARPA Funding

Staff Recommendation - Broadband

\$700M Virginia Telecommunication Initiative (VATI)

- \$479M sourced from the State and Local Fiscal Recovery Fund
- \$221M sourced from the Capital Project Fund



Recommend an additional \$1.5M ARPA SLFRF To ABBA

- Support for Regional VATI application with Firefly in September
- Firefly completed analysis for universal coverage after the first \$3.0 M, noting the need for the \$4.5M match to be competitive



VATI Awards are expected in January 2022

 Award would support goal of County Universal Broadband Coverage
