1 BEGINNING OF RECORDED PROCEEDINGS

2 911 OPERATOR (FEMALE): 911,
3 where is your emergency?

4 ANDREW HULSEY: Yes, ma'am, I
5 need to report a self defense shooting.

6 911 OPERATOR (FEMALE): What do
7 you mean a self defense shooting?

8 ANDREW HULSEY: I was attacked.

9 911 OPERATOR (FEMALE): Okay.
10 Did you shoot somebody?

11 (Whereupon, phone call was disconnected)

12 MESSAGE: This person cannot be
13 reached at the moment.

14 911 OPERATOR (MALE): Did he just
15 call back?

16 911 OPERATOR (FEMALE): No.

17 (Ringing)

18 ANDREW HULSEY: Hello.

19 911 OPERATOR (MALE): Yes, sir.
20 Where are you?

21 ANDREW HULSEY: 445 Church Road.

22 911 OPERATOR (MALE): What?

23 What?

1 ANDREW HULSEY: 445 Church Road
2 Hartselle, Alabama.

3 911 OPERATOR (MALE): And what
4 happened?

5 ANDREW HULSEY: I do not feel
6 emotionally stable right now enough to
7 talk to anybody.

8 911 OPERATOR (MALE): You are
9 going to have to tell me what happened.

10 ANDREW HULSEY: I was attacked by
11 my own parents and my father had a weapon
12 in his hand and things got out of control
13 from there.

14 911 OPERATOR (MALE): Did you
15 shoot him?

16 ANDREW HULSEY: I felt for my
17 life. He had a baton in his hand.

18 911 OPERATOR (MALE): Did you
19 shoot him?

20 ANDREW HULSEY: Sir, I -- I
21 need -- I need help.

22 911 OPERATOR (MALE): Did you
23 shoot him?

1 ANDREW HULSEY: I had to do -- I
2 feared for my life and I had to defend
3 myself.

4 911 OPERATOR (MALE): Is he
5 breathing?

6 ANDREW HULSEY: No, sir. I
7 rolled him over -- I checked to see if he
8 was breathing or not -- it is him and my
9 mother. I'm standing outside -- I'm -- I
10 can't believe this is happening.

11 911 OPERATOR (MALE): Who is he
12 now?

13 ANDREW HULSEY: It is my father
14 and my mother. I lived here with them
15 and...

16 911 OPERATOR (MALE) Did you
17 shoot both of them?

18 ANDREW HULSEY: They both
19 attacked me and -- please. I just need
20 emergency personnel. I -- I --

21 911 OPERATOR (MALE): What is
22 your name?

23 ANDREW HULSEY: I'm sorry, sir.

1 Just 445 Church Road Hartselle, Alabama
2 35640.

3 UNKNOWN: Do you want to get EMS
4 for me?

5 911 OPERATOR (MALE): Okay. What
6 is your name, sir.

7 ANDREW HULSEY: I do not feel
8 comfortable talking on the phone any more.
9 All right. I will -- I will be -- I'm
10 unarmed now. I do not have anything on
11 me. I have on a white shirt with tan
12 pants on and black boots. Just please do
13 not tell -- please tell officers arriving
14 and personnel that I am unarmed and I am
15 no danger. I'm just -- I'm just waiting
16 for personnel. Please send.

17 911 OPERATOR (MALE): Okay. I
18 need you to tell me your name.

19 ANDREW HULSEY: My name is
20 Andrew.

21 911 OPERATOR (MALE): Andrew
22 what?

23 ANDREW HULSEY: Hulsey.

1 911 OPERATOR (MALE): Coffee?

2 ANDREW HULSEY: Hulsey.

3 H-U-L-S-E-Y.

4 911 OPERATOR (MALE): And they
5 are not breathing?

6 ANDREW HULSEY: No, sir. They
7 are not.

8 911 OPERATOR (MALE): Where did
9 you shoot them at?

10 ANDREW HULSEY: I am at my own
11 home.

12 911 OPERATOR (MALE): I mean
13 where on their body did you shoot them?

14 ANDREW HULSEY: I don't -- I
15 can't tell. I'm not any good with this
16 sort of stuff.

17 911 OPERATOR (MALE): Do you want
18 to try to do CPR on them?

19 ANDREW HULSEY: No, sir. They
20 are not breathing at all. I don't know
21 CPR.

22 911 OPERATOR (MALE): I can
23 instruct it to you if you want to try.

1 ANDREW HULSEY: I can try. I
2 just don't want -- I just don't want
3 officers to get the wrong idea of coming
4 in. Please. Please. Instruct the
5 officers that I am unarmed.

6 911 OPERATOR (MALE): Okay. Are
7 you at them right now?

8 ANDREW HULSEY: I just got in.
9 What can I do?

10 911 OPERATOR (MALE): Okay. Can
11 you turn them on their back?

12 ANDREW HULSEY: I'm sorry, sir.
13 I can't do this. I can't.

14 911 OPERATOR (MALE): Okay. If
15 you don't want to do it go outside and
16 stand on the porch, okay?

17 ANDREW HULSEY: Well, sir, I have
18 lights on.

19 911 OPERATOR (MALE): Just stay
20 on the line with me until an officer gets
21 there with you, okay.

22 ANDREW HULSEY: Okay.

23 911 OPERATOR (MALE): Now, are

1 you outside yet?

2 ANDREW HULSEY: I am outside. I
3 am outside in a white shirt, tan pants and
4 black boots. And of course I have my cell
5 phone to my ear. This is my cell phone
6 number and...

7 911 OPERATOR (MALE): What kind
8 of gun did you have?

9 ANDREW HULSEY: I do not feel
10 comfortable divulging any more information
11 over the phone.

12 911 OPERATOR (MALE): You are not
13 going to tell me what kind of gun you had?
14 They are going to find out when they get
15 there.

16 ANDREW HULSEY: That is fine.
17 I'm -- all of my weapons -- all of the
18 weapons that I had on me are laying -- are
19 on my Jeep. It is a Jeep Liberty, black.
20 All on the hood of my vehicle, okay? I
21 see the officers. Please.

22 911 OPERATOR (MALE): Okay. Just
23 hold your hands up, okay?

1 ANDREW HULSEY: Okay. All right.
2 I still got the cell phone to my ear.

3 911 OPERATOR (MALE): Okay. Just
4 hold your hands up.

5 OFFICER ON THE SCENE: Come
6 towards me with your hands in the air.

7 ANDREW HULSEY: Yes, sir.
