Background

The City of Decatur and Morgan County were named as defendants in two civil actions – one in circuit court and one in federal court. Throughout the mediation going back to 2016, both the City and the County were treated as plaintiffs.








What is Mediation?

Mediation is a confidential process in which both parties agree to bring in a neutral third party to oversee the proceedings and to help work out an agreement.









The Goal of Mediation

To develop a settlement agreement that accomplishes the following:





Critical Components of the 3M Settlement

Planning for the Future

Today, 3M is working under an Interim Consent Order with ADEM which requires 3M to investigate and remediate any site where PFAS waste from the 3M plant site was disposed. According to ADEM Director Lance LeFleur, the structure of the agreement allows clean up to continue without delay and ensures 3M will pay the full cost of the cleanup.



To provide Americans, including the most sensitive populations, with a margin of protection from a lifetime of exposure to PFOA and PFOS from drinking water, EPA has established the health advisory levels at 70 parts per





What about Decatur's drinking water?

Decatur's drinking water *is* **SAFE**:

A report released in 2020 by Environmental Working Group (EWG) confirms DU's statements that drinking water supplied by Decatur Utilities is completely safe and meets or exceeds all state and federal regulatory standards.

Tests for these chemicals (PFOS and PFOA) in our water supply have been non-detect, or at near non-detectable levels. The highest value in any recent test was less than 5 parts per trillion combined level for both chemicals, which is near the minimum detection levels. EWG's test data reaffirms this, reporting 2.1 ppt for PFOS and 2.4 ppt for PFOA, a total of 4.5 ppt.

What about exposure through swimming?

In the summer of 2019, State Health Officer Dr. Scott Harris said the Alabama Department of Public Health has not received any reports of health hazards associated with people in the area shared by the old Brookhaven Middle School campus and Aquadome Recreation Center.
