AGREED ORDER GRANTING AMENDED MOTION TO TRANSFER VENUE


Electric Reliability Council of Texas, Inc. (“ERCOT”) filed its Amended Motion to Transfer Venue (the “Motion”) on March 8, 2021 objecting to venue in Denton County based upon two separate mandatory venue statutes. The City of Denton (the “City”) and ERCOT have agreed, as evidenced by the below signatures of the Parties’ counsel, that this case should be transferred to a District Court in Travis County, Texas.

After considering the Motion, the objections to venue, the pleadings and evidence on file with the Court, and the Parties’ agreement, the Court is of the opinion that the Motion should be GRANTED and enters the following order consistent with the Parties’ agreement:

IT IS ORDERED that ERCOT’s Amended Motion to Transfer Venue is granted, and that this case is hereby transferred to a District Court in Travis County, Texas.

IT IS FURTHER ORDERED that the clerk of this Court shall prepare a transcript of all papers and orders in this case, certify the transcript under the seal of this Court, and send the transcript and original papers to the clerk of the District Court assigned by the Travis County District Clerk.
