






Establishment of Lots Geers Addition - 1881

- Two Plats created the east side of Oakland Street: Geers Addition and W. M. Jagoe Addition.
- The Geers Addition extended from current McKinney Street to the future Holt Street, named on this map as a continuation of Congress Street
- Opened the area for residents of Freedman Town to move closer to town



Establishment of Lots Jagoe Addition - 1896


- Two Plats created the east side of Oakland Street: Geers Addition and W. M. Jagoe Addition.
- The Jagoe Addition added the upper left side of Quaker
- Jagoe and Geers disagreed on the name of the future Holt Street. Jagoe named the street Church Street and the future Wither Street as the continuation of Congress Street


Between 1881 and 1896, the west of Quaker was well-known as a residential enclave for leading families and organizations, like:

★ Oakland Street facing North - 1905




Denton - 1912





Oakland Street (to Holt St) 1921





"Respect every man, but fear none"

Hill and his wife, Ida, arrived in Denton in 1896 and bought property. A firm believer in saving money and owning land, Hill was aware that the white man could take it away. The proposed removal of Quakertown residents only substantiated these fears and Hill resented the racial implications that he and other blacks felt were the underlining cause for the move. But of the fifty-eight property owners involved, Hill was the only one openly to challenge the City's actions. Acting in accord with his motto "Respect every man, but fear none," **Hill sued the City**. Fearing reprisals against his family, he eventually dropped the suit.












1923 Black Denton Residences Former Quaker Area




