PLEASE VISIT jury.dentoncounty.gov TO:

- Complete the required juror questionnaire *at least 10 days prior to arrival* for jury service.
- AND Report any disqualification or allowed exemption.
- AND/OR Request a one-time reschedule of your jury service.
- SIGN UP for e-mail and text message communication regarding a cancellation of your service.
- ALSO Find answers to frequently asked questions (FAQ) and view posted notices of any cancellations.

PLEASE review your location of reporting to ensure you report to your appropriate juror location.

<u>DO NOT</u> bring <u>GUNS</u>, <u>KNIVES</u> or <u>WEAPONS</u> to the <u>COURTS BUILDING</u>. You will be required to enter through security. <u>Proper clothing is required</u>. <u>NOT PERMITTED: Shorts, sleeveless shirts/tank tops, or T-Shirts</u>

Failure to respond may subject you to a fine of \$100 to \$1,000. (Gov't Code Sec. 62.0141)

Your employer may not take adverse action against you for serving as a juror. (Civ. Prac. & Rem. Code, Ch. 122)
