Overview of GA-34 Executive Order

- GA-34 issued March 2, effective on Wednesday, March 10
 - If a Trauma Service Area (TSA) does <u>not</u> have high hospitalizations as defined in the order:
 - Businesses can reopen at 100% capacity
 - No state-wide mask mandate; however, businesses or other establishments may still limit capacity or implement additional safety protocols, including the wearing of a face covering, at their own discretion
 - If a Trauma Service Area (TSA) region has high hospitalizations as defined in the order, a <u>County Judge</u> in that region may use COVID-19 related mitigation strategies
 - However, County Judges may not impose jail time for not following COVID-19 orders nor may any penalties be imposed for failing to wear a face covering
 - If restrictions are imposed at a County level, those restrictions may not include reducing capacity to less than 50% for any type of entity
 - GA-34 supersedes any conflicting order issued by local officials



Overview of GA-34 Executive Order

- GA-34 rescinded most of the Governor's earlier executive orders related to COVID-19
 - Including the requirement for a county judge or mayor to approve an outdoor gathering of over 10 or more individuals

State's suspension of TOMA allowing for virtual public meetings was done outside
of an executive order, still is in place for now, and is anticipated to continue for
the foreseeable future

Extension of Local Disaster Declaration and Order

- Statewide orders from Governor Abbott are in effect
 - Local orders cannot supersede or conflict with state orders
- Current Local Disaster Declaration and Order in effect for the City of Denton through March 31, 2021:
 - 1. **Disaster Declaration** establishes a state of disaster, which is the basis for orders of Council, and is a prerequisite for state and federal disaster funding
 - 2. The Order of Council provides authority and enables certain measures to be taken for the City to respond to COVID-19
- Staff recommends to extend the Local Declaration and Order as drafted and presented in the back-up through June 30, 2021
 - To continue to be eligible to receive outside funding sources and provide flexibility to respond to the COVID-19 pandemic



Summary of Drafted Order for Council Consideration

• Staff drafted a Twelfth Order for Council consideration with the following provisions (slides 7 & 8) and attached the draft copy in the back-up for Individual Consideration

Continued Provisions:

- Authority for City Manager to adopt procedures and directives to protect employees & public
- Authority and flexibility for emergency response measures as allowed pursuant to Section 9-22
- No penalties for non-payment of utilities

Removed and Replaced:

- Local requirement for Businesses to have a Health & Safety Policy that incorporates the face covering and social distancing requirements of GA-29 (superseded by GA-34)
 - Replaced with: Strong encouragement for businesses and establishments to continue to
 follow and implement health and safety precautions and recommendations from the Centers
 for Disease Control and Prevention (CDC), as they may be amended or updated



Continued COVID Precautions in City Facilities

- Employees will continue to telecommute where feasible. Health screenings still required for employees who report on-site
- Facilities will remain partially open with some facilities being open by appointment only and some areas of open facilities being partially inaccessible
- Personal Protective Equipment/Face Coverings
 - PPE, including face coverings, will continue to be required for City employees, contractors, volunteers, and program participants (if required by the program)
 - Face coverings will be required of the public when entering a City facility. Children under 10 years of age and those whose health would be negatively impacted by a face covering are exempted
 - Employees have been issued guidelines regarding how to communicate this requirement
