SUBJECT: Prioritizing Military Excellence and Readiness: Initial Implementation Guidance for USAFA Cadets and OTS Trainees

On 8 May 2025, the Secretary of Defense reinstated policy directing individuals with a current diagnosis or history of, or exhibiting symptoms consistent with, gender dysphoria to be disqualified for military service.

As stated in reference (d), Exceptions to Policy granted pursuant to DAFPM 2021-36-01, *Accessions and In-service Transition for Persons Identifying as Transgender*, are rescinded and cadets shall comply with the standards of their sex as defined in reference (a).

United States Air Force Academy (USAFA) First Classmen and Officer Training School (OTS) trainees affected by this policy may graduate from the USAFA and OTS respectively, but shall not commission into the Air Force or Space Force consistent with reference (c),

paragraph 4. After graduation, these cadets and trainees will be placed on administrative absence.

Cadets and trainees affected by this policy are encouraged to apply for voluntary separation by 6 June 2025. Cadets and trainees shall be counseled that at the conclusion of the voluntary separation window involuntary separation processes will be initiated.

Pursuant to reference (c), paragraph 4.1.f, absent any other basis, cadets voluntarily separated under this policy will not be subject to monetary repayment of educational benefits (i.e., recoupment) nor subject to completion of a military service obligation. Cadets who do not choose voluntary separation may be required to repay educational benefits.
