 was seized.

You may wish to consult with an attorney before
 deciding what is best for you. However, if no petition
 or claim is filed within sixty (60) days of personal
 service, publication, or mailing of this Notice, which-
 ever is earlier, your interest in the property described
 above will be forfeited. All such requests, petitions
 and claims shall comply with the requirements for
 claims as set out in ***K.S.A. 60-4111*** of the ***Kansas
 Standard Asset Seizure and Forfeiture Act.***
