

RESOLUTION NO. 20-2025**A RESOLUTION AMENDING AND SUPPLEMENTING RESOLUTION NO. 052024 OF THE CITY OF DERBY, KANSAS, WHICH DETERMINED THE ADVISABILITY OF MAKING CERTAIN IMPROVEMENT IN THE CITY (SANITARY SEWER-PHASE 1 IMPROVEMENTS/COURTYARDS AT CROSSWATER SECOND).**

WHEREAS, the governing body of the City of Derby, Kansas (the "City"), adopted Resolution No. 05-2024 on April 9, 2024 (the "Prior Resolution"), which authorized pursuant to K.S.A. 126a01 et seq. certain sanitary sewer improvements to serve the following described improvement district:

Lots 1 through 3, Block 1; Lots 1 through 11; and Lots 14 through 16, Block 4; Lots 1 through 21, Block 5; and Lots 1 through 17, Block 6, Courtyards at CrossWater to the City of Derby, Sedgwick County, Kansas; and

WHEREAS, the Prior Resolution was recorded with the Register of Deeds of Sedgwick County, Kansas, and appears at DOC. #/FLM-PG: 30302751; and

WHEREAS, the City has received and filed a revised Petition proposing modifications of the estimated costs of the improvements and the improvement district, and the City hereby finds and determines that said revised Petition is sufficient and that it is necessary to make such modifications; and

WHEREAS, in order to make such modifications, the governing body of the City hereby finds and determines it necessary to amend and supplement Section 1 of the Prior Resolution, as hereinafter set forth.

THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF DERBY, KANSAS:

Section 1. Amendments. *Section 1* of the Prior Resolution is hereby amended to read as follows:

Section 1. Findings of Advisability. The governing body hereby finds and determines that:

(a) It is advisable to make the following improvements (the "Improvements"):

Construction of a lateral sanitary sewer, including necessary sewer mains and appurtenances to serve the area described as the Improvement District, all in accordance with City of Derby Standards and plans and specifications prepared or approved by the City Engineer.

(b) The estimated or probable cost of the proposed Improvements is: \$650,000, exclusive of interest on financing and administrative and financing costs; said estimated cost to be increased at the pro rata rate of 1 percent per

month from and after the date of adoption of the Prior Resolution.

(c) The extent of the improvement district (the "Improvement District") to be assessed for the cost of the Improvements is:

Lots 1 through 5, Block 1; Lots 32 through 38, Block 2; Lots 1 through 5 and Lots 16 through 21, Block 3; Lots 1 through 13, Block 4; and Lots 1 through 21, Block 5; Courtyards at CrossWater Second Addition to the City of Derby, Sedgwick County, Kansas.

(d) The method of assessment is: equally per lot (57 lots).

In the event all or part of the lots or parcels in the proposed Improvement District are replatted before assessments have been levied, the assessments against the replatted area shall be recalculated on the basis of the method of assessment set forth herein. Where the ownership of a single lot is or may be divided into two or more parcels, the assessment to the lot so divided shall be assessed to each ownership or parcel on a square foot basis.

(e) The apportionment of the cost of the Improvements between the Improvement District and the City-at-large is: 100% to be assessed against the Improvement District and 0% to be paid by the City-at-large.

Section 2. Repealer; Ratification. *Section 1* of the Prior Resolution is hereby repealed and the rest and remainder thereof ratified and confirmed.

Section 3. Effective Date. This Resolution shall be effective upon adoption. This Resolution shall be published one time in the official City newspaper and shall also be filed of record in the office of the Register of Deeds of Sedgwick County, Kansas.
