Your request for information was forwarded to me by our Division Director, Barry White. Unfortunately, we don't have any

documentation pertaining to the ownership of individual parcels within the Courthouse Square Historic District. For more contemporary districts we sometimes have this information on hand. However, Courthouse Square is a very early district, listed in 1980, so it's not surprising that some information is remiss. Generally the nomination for a National Register Historic District just includes an inventory and brief description of resources. I've attached this nomination, along with the local historic district designation, for your review.
