THANKSGIVING NOVENA TO ST. JUDE

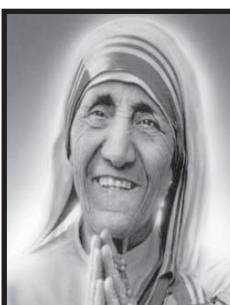
