MAYOR'S REPORT

City has received \$551,550.95 of 1,103,101.90 ARPA funds. The funds can be used for things such as water, sewer, broadband, housing. Department Heads will be asked to give input and ideas for possible uses.

The Logging and Heritage Festival will take place this Saturday, July 10 as a shortened 1-day event.

SERVICE AWARDS

Chief Mabry has been with the City of Marinette for 34 years serving the last 9 as Chief. Captain Corry has been with the City of Marinette for 32 years serving the last 5 as Captain.
