TAKE NOTICE that the Claimants, GAYADEEN SOOKRAJ and SHAMILA RAMDHANIE have commenced an action against you, the 1st and 2nd Named Defendants in the High Court of Justice, Supreme Court, San Fernando, Trinidad and Tobago by way of Amended Claim Form and Amended Statement of Case filed on the 10th December 2025 seeking the following reliefs:

- a. Special Damages in the sum of \$792,811.00.
- b. Alternatively, restitution for unjust enrichment in the sum of \$91,211.00 plus Special Damages (consequential damages) in the sum of \$701,600.00 totaling \$792,811.00.
- c. General Damages for breach of contract and/or unjust enrichment.
- d. Interest on Special Damages at the rate of 7.57% for the period January 2024 to February 2025 and continuing in accordance with the Commercial Banks Average Basic Prime Lending Rate for a period and continuing to accrue thereafter at a daily rate of \$164.43 or at such rate and for such period as the Court finds just. This Claim for Interest is made pursuant to Section 25 of the Supreme Court of Judicature Act Ch. 4:01 as amended.
- e. Further and/or alternative damages including exemplary damages.
- f. Costs.
- g. Further and/or alternative relief as the Honourable Court finds appropriate.

AND TAKE FURTHER NOTICE THAT

on the 23rd April 2026 the Honourable Mr. Justice Kevin Ramcharan ordered that:

- 1. Pursuant to Part 8.14 of the Civil Proceedings Rules 1998 (as amended), the validity of the Claim Form filed on 11th September 2025 and Amended Statement of Case, filed on the 10th December 2026 be extended for a period of eight (8) weeks from the date of the Order.
- 2. Leave is granted to the Claimants to serve both Defendants with the Claim Form filed 11th September 2025 and Amended Statement of Case filed 10th December 2025 by way of Advertisement in a daily newspaper of general circulation in Trinidad and Tobago, once per week for two consecutive weeks.
- 3. The time to enter an Appearance be twenty-eight (28) days from the last advertisement in the daily newspaper.

IF YOU INTEND to defend or admit this claim, you must within twenty-eight (28) days after the date of the last publication of the last advertisement, enter an Appearance to the Claim Form by filing the Appearance Form (Form 3) at any Court Office of the Supreme Court, Hall of Justice, Port of Spain; Supreme Court, Scarborough, Tobago or Supreme Court, Harris Street, San Fernando via the e-filing platform at <https://eservices.ttlawcourts.org/filing>; or alternatively at the Court Office (Telephone Number: 224-5182/ 628-8529/ 235-2988)

IN DEFAULT of you filing an Appearance, the Court may proceed to make any order it considers appropriate, including entering judgment against you.
