TAKE NOTICE, that the Claimant, **MICHAELA CHARLES**, of #6 D'arcy Avenue, Central Park, Balmain, in the Ward of Couva, has commenced legal proceedings against you, **MURIEL SYLVIA DILLON HEYWOOD**, Defendant, before the High Court of Justice, Supreme Court Sub-Registry, San Fernando, by way of a Claim Form and Statement of Case, Claim No. CV 2025- 02017 filed on 11th June 2025 in respect of a claim for Breach of Contract, in which the Claimant claims the following reliefs:

- (1) The sum of One Hundred and Six Thousand Four Hundred and Nineteen Dollars and Twenty-Eight Cents (\$106,419.28 TTD) in Compensatory damages;
