TAKE NOTICE that on the 08th day of August, 2025 an action was commenced against you the Defendant, **MS. MARLENE MORALES**, in the High Court of Justice by Claimant, the National Lotteries Control Board, in which the Claimant by way of Claim Form and Statement of Case Claim No. CV2025-03220 filed on the 08th August, 2025, claimed the following reliefs:

1. Special Damages in the sum of **Two Hundred and Forty-Six Thousand Five Hundred and Fifty-Seven Dollars and Sixty-One cents (\$246,557.61)**;
2. Damages for breach of contract and breach of agency inclusive of exemplary damages;
3. Damages for unjust enrichment and breach of Trust;
4. Interest;
5. Costs;
6. All necessary and consequential Orders, Directions, and Inquiries that this Honourable Court may Order;
7. Any other relief that the Honourable Court may deem just and expedient.

ALSO TAKE NOTICE it has been ordered on the 19th day of December, 2025 by the **Honourable Madam Justice Karen Reid** that: -

1. Time is extended for the Claimant to serve the claim upon the Defendant to the 31st day of March, 2026.
2. Permission is granted to the Claimant to serve the claim upon the Defendant by alternative means, namely, by way of advertisement published in a local newspaper in daily circulation in Trinidad and Tobago once per week for two consecutive weeks in a form to be approved by the Registrar, AND, by way of electronic mail to the Defendant's last known email address at marlenemorales@hotmail.com
3. The Claimant shall file an affidavit of service within fourteen (14) days of the date of last publication
4. The Defendant shall file an appearance within fourteen (14) days of the date of last publication.
5. There be no order as to costs.
