TAKE NOTICE that by Judgment in Default of Appearance against the Respondent/Judgment Debtor dated 20th February 2024 and entered on the 10th September 2024, it was ordered that the Respondent/Judgment Debtor pay to the Applicant/Judgment Creditor the sum of One Hundred and Seventy-Eight Thousand, Eight Hundred Dollars (\$178,800.00) for debt and costs to the date of the said judgment together with interest at a statutory rate of five percent (5%) per annum after the date of the said judgment to the date of payment.

TAKE FURTHER NOTICE that on the 24th June 202, the Honourable Mr. Justice Devindra Rampersad ordered, inter alia, that:-

1. Nasheena Cyrus also called Nasheena Noel (trading as Ten Ten Clothing), the Judgment Debtor, attend an oral examination before Master Ramrattan on the 22nd day of October, 2025 at 11:00 am via virtual hearing.
2. Nasheena Cyrus also called Nasheena Noel (trading as Ten Ten Clothing) to produce the following books and/ or documents:
 - a. Bank statements or other records relating to monies held by the Judgment Debtor in any account at any financial institution in Trinidad and Tobago or abroad;
 - b. Accounting records of the Judgment Debtor for the period 2021 to date;
 - c. Documents identifying assets owned by the Judgment Debtor in Trinidad and Tobago or abroad;
 - d. Documents identifying the income earned by the Judgment Debtor during the year 2021 to date;
3. The Court issue a financial position notice pursuant to Part 45.6 of the Civil Proceedings Rules 1998 (as amended);
4. This Application be dealt with without a hearing
5. The costs of this application and any oral examination be paid by the Judgment Debtor to the Judgment Creditor.

AND TAKE FURTHER NOTICE on the 22nd October 2025 Master Antoinette Alleyne ordered that:

1. The Judgment Creditor is to serve on the Judgment Debtor the order of the Honourable Mr. Justice Rampersad dated 24th June, 2025 and the financial position notice which was issued by the court on 24th June, 2025 on or before 14th November, 2025.
2. The Judgment Debtor is to complete a statement of her financial position in the practice form and serve on the Judgment Creditor on or before 5th December 2025.
3. The Judgment Debtor shall produce to the Judgment Creditor on or before 5th December 2025 the books and or documents set out at paragraph two (2) of the court's order dated the 24th June, 2025.
4. The Judgment Creditor is to indicate via a notice to the court and copied to the other side whether it remains necessary to proceed with an oral examination on or before 19th December, 2025.
5. Oral examination is adjourned to 12th January, 2026 at 9:30 am by virtual hearing.

AND TAKE FURTHER NOTICE that on the 12th February 2026, Master Antoinette Alleyne ordered that:

1. Permission is granted to the Applicant/Judgment Creditor to serve the Respondent/ Judgment Debtor NASHEENA CYRUS also called NASHEENA NOEL trading as TEN TEN CLOTHING with the draft attached as "B" which is made pursuant to the Orders of the Honourable Mr. Justice Devindra Rampersad dated 24th June 2025 and the Honourable Master Antoinette Alleyne dated 22nd October 2025 by advertising same in two (2) daily newspapers for two (2) consecutive weeks.
2. No order as to costs.
