TAKE NOTICE that the Claimant **GLEN GOBIN** of No. 1253 S.S. Erin Road, Batchiya Village, Penal in the island of Trinidad has commenced an action against you, **CHENNELE INDAR** the named Defendant at the High Court of Justice, Supreme Court, Sub-Registry, San Fernando, by way of a Fixed Date Claim Form and Affidavit in support, Claim Number **CV2025-01714** filed on the 26th May 2025 in which the Claimant claims the following reliefs:

1. An order that the Defendant do quit and deliver up possession to the Claimant the additional structures and/or attachments of the property situate at No 1253 S.S. Erin Road, Batchiya Village, Penal, namely that building measuring twenty (20) feet by twenty (20) feet used by the Defendant to operate a Poultry Depot;
2. An order that the Defendant do quit and deliver up possession to the Claimant the additional structures and/or attachments of the property situate at No 1253 S.S. Erin Road, Batchiya Village, Penal, namely that area of land measuring ten (10) feet by twenty (20) feet used by the Defendant as a Pluck Room to operate a Poultry Depot;
3. An order that the Defendant do quit and deliver up possession to the Claimant the additional structures and/or attachments of the property situate at No 1253 S.S. Erin Road, Batchiya Village, Penal, namely that area of land to the north of the Chattel House measuring thirty (30) feet by forty (40) feet used by the Defendant as Parking Facilities to operate a Poultry Depot;
4. Costs; and
5. Such further and/or other reliefs as the Honourable Court deems fit in the circumstances.

TAKE FURTHER NOTICE THAT on the 27th May, 2025 the Honourable Mr. Justice Frank Seepersad ordered inter alia that:

1. The Claimant be granted permission to serve the Fixed Date Claim Form and Affidavit in Support filed herein on the Defendant by way of publication of the proceedings in a daily newspaper in general circulation in Trinidad and Tobago on or before Twenty-eight (28) days of the date of this Order;
2. The hearing of the Fixed Date Claim is scheduled for **10th July, 2025 at 9:30 am** via Virtual Link.
3. There be no order as to costs.

AND ALSO TAKE NOTICE THAT on the 23rd June 2025, the Honourable Mr. Frank Seepersad further ordered inter alia:

1. The Claimant be granted permission to serve the Fixed Date Claim Form and Affidavit in support filed herein on the Defendant by way of publication of the proceedings in a daily newspaper in general circulation in Trinidad and Tobago be extended to 27th July, 2025.
2. The hearing of the Fixed Date Claim scheduled for 10th July, 2025 is vacated and rescheduled to **3rd September, 2025 at 9:30am via Virtual Link**.
3. There be no Order as to costs.

IF YOU INTEND TO DEFEND THIS ACTION you must state this within **EIGHT (8)** days after the date of the publication of the last advertisement, by completing and filing an Appearance to the Fixed Date Claim Form (Form 4) at any Court Office of the Supreme Court: the Waterfront Judicial Centre located at Tower D, International Waterfront Centre, 1A Wrightson Road, Port-of-Spain or Supreme Court, Harris Street, San Fernando or Supreme Court, Bacolet Street, Scarborough, Tobago (tel. 223-1060) or filing via the Judiciary of Trinidad and Tobago's e-filing platform via <https://eservices.ttlawcourts.org/filing/> or you may contact the Court at SCSFDO.Response@ttlawcourts.org for more information relative to the claim against you.

AND FURTHER TAKE NOTICE THAT IN DEFAULT of an Appearance to the Fixed Date Claim Form and Affidavit being filed for your attendance at the **Virtual Hearing** scheduled for **WEDNESDAY 3RD SEPTEMBER, 2025 AT 9:30 AM** the Court may proceed in your absence and make any order it considers appropriate including entering Judgment against you.
