2. An Order that Deed dated the 2nd May, 2000 and registered as No. DE 200000108879 be expunged and/or cancelled and/ or set aside from the records at the office of the Registrar General of Trinidad and Tobago
3. Further and/or other relief.

AND FURTHER TAKE NOTICE that an Order made on the 16th April 2026 by the Honourable Madam Justice Jacqueline Wilson, it was ordered that personal service of the Fixed Date Claim Form and Statement of Case and Amended Fixed Date Claim Form and Amended Statement of Case on the First Named Defendant, **PETRA CHARLES** be dispensed with and substituted service of the Fixed Date Claim Form and Statement of Case and Amended Fixed Date Claim Form and Amended Statement of Case be effected on the Defendant by advertisement in a daily newspaper of general circulation in Trinidad and Tobago once per week for two (2) consecutive weeks.

IF YOU INTEND to defend or admit the claim, you must state this by entering your Appearance, before the expiration of fourteen (14) days after the date of the second advertisement, by completing and filing Form 3- Appearance to Claim Form at the Registry at Waterfront Judicial Centre, Tower D, International Waterfront Centre, No. 1A Wrightson Road, Port of Spain, Trinidad, through the e-filing portal at <https://e-services.ttlawcourts.org>; or alternatively at the Court Office (Telephone Number: 224-5182/ 628-8529/ 235-2988). IN DEFAULT of you filing an Appearance or your Defence, the Court may proceed in your absence to make any order it considers appropriate, including entering judgment against you.
