**TAKE NOTICE** that a Claim Form and Statement of Case naming you, Shivonne Gangapersad as the Second Defendant and Kristy O’Connor as the Third Defendant, were filed by the Claimants herein before the High Court of Justice of Trinidad and Tobago on 22nd January 2026 for reliefs including Damages for breach of contract in the sum of Six Hundred and Twelve Thousand, Two Hundred and Seventy-Five Dollars (\$612,275.00); Damages for negligence; a Declaration that the Second and Third Defendants are personally liable for the acts and omissions carried out under the name of the First Defendant, SMG Valhalla Construction Ltd, a company which was struck off the Companies Register; Special Damages in the sum of Forty-Nine Thousand One Hundred and Twenty-Five Dollars (\$49,125.00); Interest; Costs; and Such further order or reliefs as the Honourable Court may deem fit in the circumstances.

**AND FURTHER TAKE NOTICE** that by virtue of the Order of the Honourable Mr. Justice Robin Mohammed dated 10th March 2026, fourteen (14) days’ time is granted for the entry of an appearance after the last advertisement.
