TAKE NOTICE that the Claimant, **RICHARD RAGOONANAN**, Landscaper of LP No. 176 Church Street, Las Lomas #1, Chin Chin Road, Cunupia in the Island of Trinidad in the Republic of Trinidad and Tobago has commenced an action against you **ANIL RAGOONATH** the named Defendant, at the High Court of Justice Trinidad and Tobago by way of Claim Form and Statement of Case filed on 12th August, 2025 in which the Claimant claims the following relief:

- A. Payment of the sum of One Hundred and Seventy-Three Thousand Dollars (\$173,000.00);
- B. Damages;
- C. Interest pursuant to Section 25 of the Supreme Court of Judicature Act Chapter 4:01 on all sums found due to the Claimant at such rate and for such period as the Court shall deem just;
- D. Cost;
- E. Such further and/or other relief as to the Court may be just.

TAKE FURTHER NOTICE THAT by order made on the 15th December, 2025 the Honourable Mr. Justice Seepersad ordered that:

- a. The Defendant be served with the Claim Form and Statement of Case filed on the 12th August, 2025 by an alternative method of service namely by way of advertisement in a local newspaper of daily circulation for once a week for two (2) **consecutive weeks**.
- b. That the time for entry of Appearance be extended to **Twenty-One (21)** days from the last day of advertisement and the time for the filing of the Defence be **Twenty-One (21)** days thereafter.
- c. That the Costs of this Application be Costs in the cause.

AND ALSO TAKE NOTICE that on the 12th January 2026, the Honourable Mr. Justice Seepersad further ordered that:

1. The time for service of the Claim Form and Statement of Case filed on the 12th August, 2025 on the Defendant is hereby extended to the 13th February, 2026.
2. There be no Order as to costs.

IF YOU INTEND TO DEFEND OR ADMIT THIS CLAIM

you must within **TWENTY-ONE (21) days** from the date of the publication of the last advertisement, enter an Appearance to the Claim Form by filing an appearance form at any Court Office of the Supreme Court: The Waterfront Judicial Centre located at Tower D, International Waterfront Centre, 1A Wrightson Road, Port of Spain or Supreme Court, No. 271 Naparima Mayaro Road, Princes Town or Supreme Court, Bacolet Street, Scarborough, Tobago (Tel: 223-1060) or filing via the Judiciary of Trinidad and Tobago e-filing platform <https://eservices.ttlawcourts.org/filing/new/index.php> or you may contact the Court at SCSFDO.Response@ttlawcourts.org for more information relative to the claim against you.
