**TAKE NOTICE** that on the 2nd May 2023 an Application was filed by the Applicant herein SELENA PURCELL in the Family Court, Princes Town

**AND TAKE NOTICE FURTHER** on the 09th May 2023, an Interim Protection Order was granted by Master Ramdass whereby it was ordered that inter alia that:

**THIS COURT ORDERS AS AN INTERIM ORDER** that with effect from the 9th May, 2023 and continuing until the matter is revoked, withdrawn, dismissed or a final protection order is made.

YOU, **SUAVEY BOBB**, THE WITHIN-NAMED RESPONDENT SHALL NOT ENGAGE IN THE FOLLOWING CONDUCT AND YOU **SUAVEY BOBB** SHALL COMPLY WITH THE FOLLOWING PROHIBITIONS AND CONDITIONS:

1. Not to physically abuse or threaten to abuse the Applicant;
2. Not to emotionally or psychologically abuse the Applicant by persistently intimidating her by the following:
  - (i) The use of abusive and threatening language and/or conduct;
  - (ii) The publication or dissemination of private messages, pictures, videos and/or audio;
3. Not to make any unwelcome or intimidatory contact with the Applicant by any means whatsoever including in person, verbally, by gesture, letter, telephone, text, social media or other electronic means;
4. The Respondent is at all times to remain one hundred (100) feet away from the Applicant and her premises located at LP #5 MAFEKING VILLAGE, MAYARO;
5. The Respondent is prohibited from posting videos and pictures, on any social media platform or forwarding either electronically or otherwise any pictures, audio or videos regarding the Applicant;
6. Not to cause or encourage another person to engage in any of the conduct mentioned above;
7. Not to otherwise engage in any conduct that would amount to Domestic Violence.

**THIS COURT ALSO ORDERS that:**

1. YOU, **SUAVEY BOBB**, shall not engage in any conduct that constitutes an offence under this Act.
2. IF YOU, **SUAVEY BOBB**, fail to comply with any of the terms of this Order you shall be liable to imprisonment and/or a fine pursuant to section 20 of the Act.

**AND TAKE NOTICE FURTHER** that as part of an Order made on the 2nd July 2024 by Master Ramdass, the Applicant was directed to effect substituted service of this Application by this advertisement in a daily newspaper of general circulation in Trinidad and Tobago **once weekly for two consecutive weeks**;

If you desire to defend this action, you must file and serve on the Applicant a response to the said Application at the court office of the Family Court, Princes Town, 271 Naparima Mayaro Road, Princes Town **through the e-filing portal** at <https://eservices.ttlawcourts.org> or appear at the next date of hearing;
