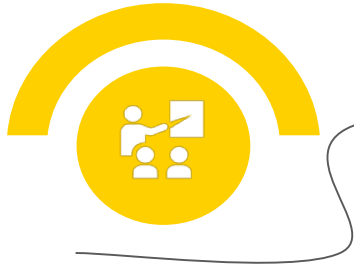

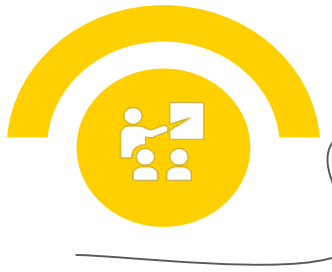

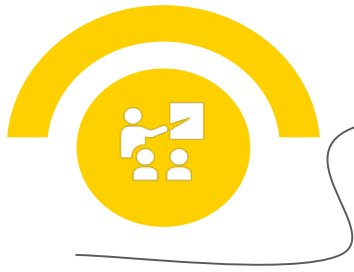


Instructional Framework

Instruction

Groupings:

- Students will be grouped alphabetically.
- Group A will receive new instruction/content on Mondays and Tuesdays.
- Group B will receive new instruction/content on Thursdays and Fridays.
- Teachers will prepare/provide students with materials/activities/instructions on where to access materials via Blackboard/Google Classroom on Tuesdays and Fridays for students to work on remotely while they are not in school. These activities should be project based/hands on whenever possible and be able to be completed with or without technology support.

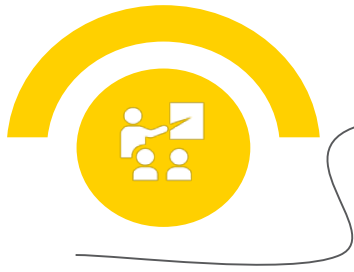

Instruction

Wednesdays:

- Additional cleaning will occur.
- PD/Planning/Remote Support for students and parents
- Teachers will be available for online support on Wednesdays, and potentially other designated times to answer questions for students and parents who are A/B and working 100% remotely.
- While students will be provided with devices as needed, schools and staff will be encouraged to provide hard copies of materials to take home for completion to mitigate connection/technology issues.

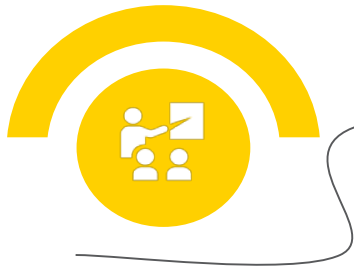

Virtual Option and Professional Development:

- Parents will have the 100% virtual options for as long as they feel it is necessary, but may switch
- PD will include: mental health training, virtual instruction training, supporting students in a remote environment, family support

On-going Evaluation

- Engage in weekly conference calls with local health officials and provide ongoing updates to parents
- Goal is to move to a four day face -to-face week by Oct. 16.
 - We will schedule a “planning day” for teachers when and if we move to a four day work week, or 100% virtual. We recommend the 19th becomes the 12th PD day and reserve the right to add the 20th a TWD if we go to 4 days of instruction.
 - If it is not advisable, we will stick with the AA/BB model
- We will be ready with a 24 -48 hour turnaround plan in the event that we go 100% virtual learning for students.



If we move to a four day face -to-face week:

- We will schedule a “planning day” for teachers when and if we move to a four day work week, or 100% virtual.
- Wednesdays will remain PD/Planning/Cleaning days in schools

Safety, Health & Wellness

- 6 ft. social distancing is the standard (where possible). Masks will be required.
- **Personal Protective Equipment (PPE)** will be provided to staff (mask and/or shields)
- Sanitation stations will be established in each school
- Parents will be provided with daily monitoring resources and are strongly encouraged to keep students home if ill
- We have ordered thermometers as a precaution.

Staff Safety and Human Resources:

- Employees who indicate they have increased risk or may require an accommodation will notify Human Resources.
- Human Resources will provide information to staff as it relates to leave policies and provisions.
- Employees may be eligible for leave under the Families First Coronavirus Response Act and the Family Medical Leave Act as well as the division Leave of Absence policy. HR will work with staff on eligibility and requirements on a case -by-case basis to meet requirements of the leave provisions while also ensuring continuity of learning .
