ELECTION INFORMATION

Welcome to the 2026 Frederick County primary election voters guide. Maryland's 2026 primary will be held June 23 from 7 a.m. to 8 p.m.

Early voting runs June 11 to 18, from 7 a.m. to 8 p.m. each day, including Saturday and Sunday.

In Frederick County, residents will vote on:

- County executive, County Council at large and by districts, state's attorney, clerk of the circuit court, register of wills, judge of the orphans' court, sheriff
- Frederick County Board of Education
- Governor / lieutenant governor, comptroller, attorney general, state senator by district, state delegates by district, judge of the circuit court
- 6th District representative in Congress
- Democratic Central Committee, Republican Central Committee

Races in which candidates run as a member of a political party are open only to those parties — i.e., enrolled Republicans vote in the Republican primary; enrolled Democrats vote in the Democratic primary. All registered voters, including those who are unaffiliated, are eligible to vote in the Board of Education race, which is nonpartisan.

Governance

■ Frederick County has a county executive and a seven-member County Council. There are two at-large seats on the council, who represent all residents. The remaining five council members are elected by districts.

■ Frederick County Board of Education members are elected at-large. Four of the seven seats on the board are up for election this year.

■ The entire Maryland General Assembly is up for election this year — all delegates and senators. Maryland is divided into 47 legislative districts for the Maryland General Assembly. Each district has one senator and three delegates.

Some districts are divided further. For example, District 2 has both District 2A, with two delegates who represent Frederick and Washington counties, and District 2B, which has one delegate who represents Washington County.

■ Maryland is divided into eight congressional districts. Frederick County is entirely within the 6th District.

Registration

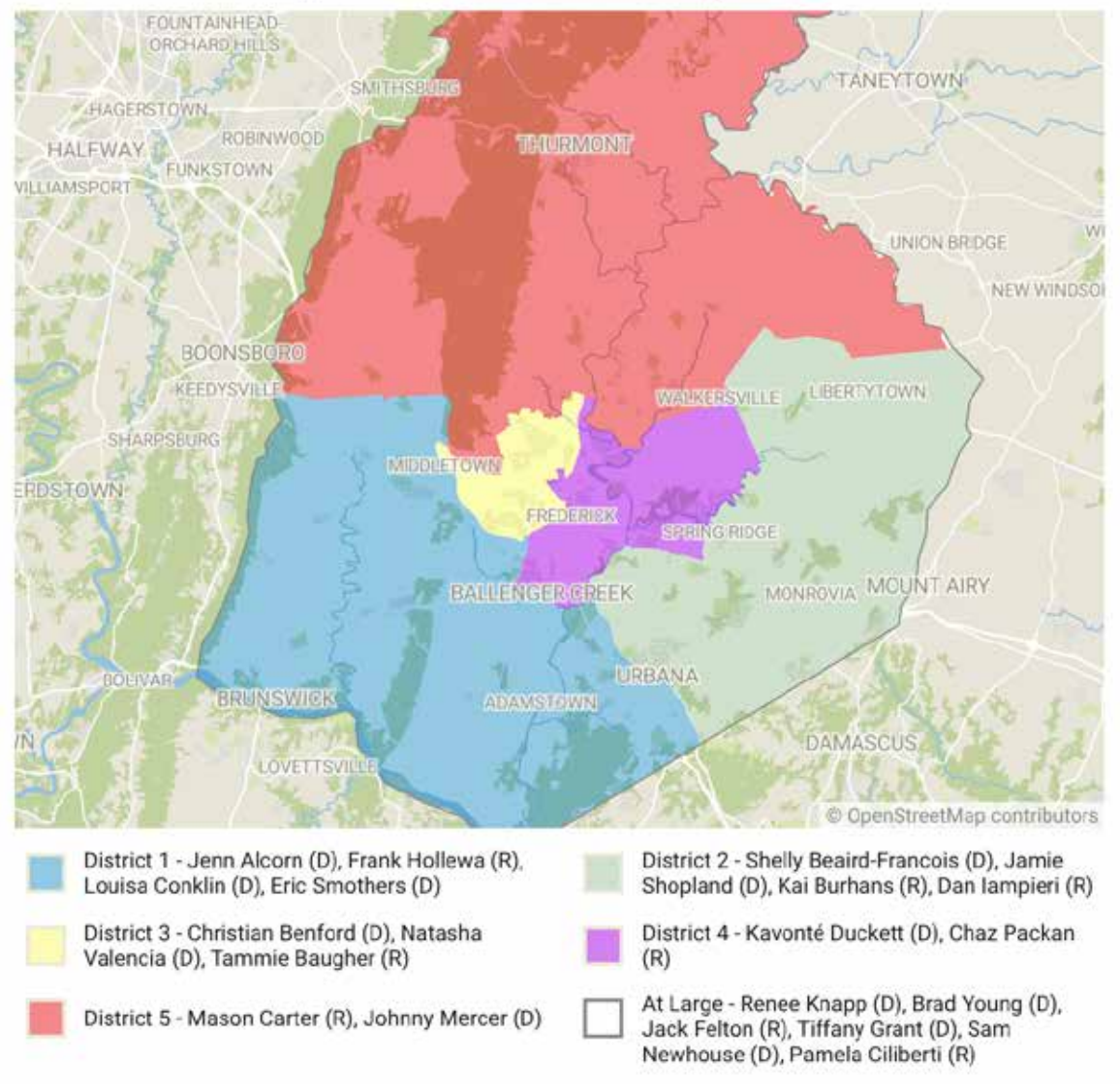
People may register to vote in Frederick County if they are:

- At least 16 years old (but they must be 18 to vote in an election)
- A U.S. citizen
- Live in Frederick County
- Are not disqualified as outlined by Maryland state law

Information about registering to vote is posted at frederickcountymd.gov/1648/Voter-Registration---RegisterMake-Change.

The deadline to register in advance, update a registration or change a party enrollment is 21 days before an election. People also may register or update

Candidate responses

The Frederick News-Post invited candidates in almost all contested races for county, state and federal elected offices to be part of this year's primary election guide.

The exceptions were judge of the orphans' court and the Democratic and Republican central committees.

The candidates for judge of the orphans' court and the unopposed candidates for other elected public offices will be invited to participate in the News-Post's voters guide for the general election.

For this guide, we sent questionnaires to 67 candidates on the primary ballot.

One said he has since withdrawn from the race (Daniel M. Krakower, for U.S. representative in the 6th District).

One candidate did not respond to several emails and had no phone number listed (L.D. Burkindine, for governor).

The other 65 entries in this guide are based on the candidates' full or partial responses.

Because of the number of candidates and the amount of information each provided, an excerpt of their responses is included in this guide. Their full responses will be posted in the online version of this guide at fredericknewspost.com.

VOTING OPTIONS

Voters have multiple ways to cast a ballot:

In person

In-person voting for the June 23 primary will be done at polling places across the county. Voters are assigned to a specific polling place based on where they live. They will be open for voting from 7 a.m. to 8 p.m.

Early voting

Early voting also is done in person, June 11 to 18. The polls are open from 7 a.m. to 8 p.m. each day, including Saturday and Sunday.

There are five early-voting polling places in Frederick County:

- Trinity Recreation Center, 6040 New Design Road, Frederick
- Urbana Regional Library, 9020 Amelung St.
- Thurmont Regional Library, 76 E. Moser St.
- Middletown Volunteer Fire Department Activities Building, 1 Fireman's Lane
- Libertytown Volunteer Fire Department Activities Building, 12027 South St.

Any registered voter in Frederick County may use any of the early-voting sites during the early voting period, regardless of where they live.

Mail-in ballots

Any registered voter may vote by mail-in ballot, without having to give a reason.

Mail-in ballots can be requested online (with a Maryland driver's license or MVA-issued ID card); by returning a form; or by visiting the Frederick County Board of Elections office at 8490 Progress Drive, suite 300, Frederick.

A mail-in ballot can be returned through the mail, hand-delivered to the Board of Elections office or at a ballot drop box. It must be postmarked on or before the day of the election.

COUNTY EXECUTIVE



Diane Fouché

Political party: Republican

Where you live: Thurmont

Current occupation and employers (may also list up to two previous jobs you've held); if retired, list your last job and employer:

Former director of the Office of Procurement and Contracting for Frederick County for 13 years. Prior to that, four years in Howard County procurement and nine years at Montgomery County Public Schools.

Political experience: No elected political experience.

1 - Why are you running for county executive?

Frederick County needs transparency and leadership. We need a leader who listens to people and makes decisions that serve the best interest of the county, not special interests, developers, or the governor. We need to have open, honest conversations in public; no more backroom deals. In 25 years of government, I've never witnessed the failures that we are currently seeing in our government and that's when I decided to get involved.

2 - What experience (work/political/other) prepared you for this role?

I served citizens for 25 years behind the scenes of government, ensuring fiscal responsibility and equal opportunity in contracting. Throughout my career, I remained apolitical and served elected officials, regardless of party affiliation. I've negotiated multimillion-dollar contracts, settled disputes, and achieved successful outcomes in every situation from construction to social programs. I know how government works, I see its failures, and I know how to make our government work for our citizens.

3 - Do you support: The growth of data centers in Frederick County? The current Critical Digital Infrastructure Overlay Zone? Holding a referendum on whether to overturn the CDI zone?

I don't support growth of data centers. We don't have infrastructure in place to accommodate the existing, let alone allow more to be built. They should have been required to provide their own cooling measures and electricity in a way that does not negatively impact residents. Ultimately, the current CDI is too large and doesn't serve our citizens. I support the referendum. It's the voice of citizens that our government refused to hear.



William J. (Jeff) Holtzinger

Political party: Republican

Where you live: Braddock

Political experience: Mayor, city of Frederick, 2006-2010. Unsuccessful run for mayor in 2013

1 - Why are you running for county executive?

As a lifelong county resident, I don't like the direction county government has gone in the last 12 years. The size of county government has grown substantially. Real property taxes are increased every year without any corresponding benefit to residents. Growth has also not been well managed and now strains our public infrastructure. I bring the experience that will allow me to better manage growth and streamline county government without reducing services.

2 - What experience (work/political/other) prepared you for this role?

I have over 30 years of experience as a civil engineer and attorney. The majority of my experience has involved working with local government issues. While most of my experience has been in the private sector, I have been the Frederick city engineer, Brunswick city engineer and a part-time water and sewer engineer for Frederick County. I also was mayor of Frederick. In those roles, I tackled a number of pressing public infrastructure issues.

3 - Do you support: The growth of data centers in Frederick County? The current Critical Digital Infrastructure Overlay Zone? Holding a referendum on whether to overturn the CDI zone?

I am not against data centers per se. However, the centers may not be the revenue-generating panacea anticipated by county government. Moreover, the county should have understood all the impacts of the centers, including water supply demand and electric demand, and the impact on county residents before any decisions to proceed. Same applies to the overlay. Making deals then asking questions is not a sound public process. Public referendum should be allowed to proceed.

1 - Why are you running for County Council?

Frederick County has given me so much: my education, my community, my family. After I lost my husband, Lt. Stew Alcorn, to occupational heart disease in 2021, I found a renewed desire to serve. I'm running because I believe county government should be practical, compassionate, and focused on getting real results, not on party politics. I want to help keep Frederick County a wonderful place for working families, seniors, farmers, and future generations.

2 - What experience (work/political/other) prepared you for this role?

More than 20 years in hospitality and human resources taught me to listen, problem-solve, and lead through complexity. As a Leadership Frederick County graduate and longtime volunteer with the Chamber, Mental Health Association, Blessings in a Backpack, and FCPS programs, I understand our community's needs from the ground up. Advocating for survivor families of fallen first responders at the local, state, and federal levels sharpened my ability to navigate government on behalf of others.

3 - Do you support: The growth of data centers in Frederick County? The current Critical Digital Infrastructure Overlay Zone? Holding a referendum on whether to overturn the CDI zone?

I support data centers only in appropriately zoned industrial areas with strict environmental and infrastructure standards — they can expand our commercial tax base and reduce pressure on homeowners. I support the CDI overlay boundaries. The overlay doesn't authorize construction; each project must still go through a rigorous public approval process where community voices are heard and evaluated. The question of a referendum is currently being litigated. Ensuring residents have a primary voice remains my priority.

1 - Why are you running for County Council?

I decided to run for County Council because it became clear to me that a handful of developers are driving the growth and development strategy of our community. I believe the role of local government is to stand up for resident needs and put a check on big monied interests, like developers and big corporations. My top campaign priorities are to fully fund our schools and make our lives more affordable, especially housing.

2 - What experience (work/political/other) prepared you for this role?

I have 20+ years of work experience in non-profits and private companies. Before running, I was on the Frederick County Democratic Central Committee. I'm a practicing Quaker. In my work and community, I do not shy away from speaking up when I think it's the right thing to do. Our county needs elected representatives on the council who will speak up, advocate and fearlessly dissent on behalf of residents when it's called for.

3 - Do you support: The growth of data centers in Frederick County? The current Critical Digital Infrastructure Overlay Zone? Holding a referendum on whether to overturn the CDI zone?

I do not support the growth of data centers in Frederick County. I do not support the current Critical Digital Infrastructure Overlay Zone. I believe the County Council was wrong to support the expansion of the CDI site recommended by the Planning Commission. I support the ballot referendum, which would allow voters to have a say on the issue, and helped gather signatures. I expect an overwhelming vote against data center expansion in November.



Eric Smothers

1 - Why are you running for County Council?

My experiences from previous jobs and my current position give me insight in how county government should work. As a Brunswick councilman, I understand the housing and growth issues, water, and sewer issues and controlling our growth. I understand the need to attract small and large businesses. Helping our senior population with resources as they age in place. Continue to fund schools and upgrade older facilities in a more timely fashion.

2 - What experience (work/political/other) prepared you for this role?

I've been a member and officer of our Frederick County Volunteer Fire and Rescue Association for years, past president of the Maryland State Fire Fighters Association, past president of our Regional Emergency Services Council for Frederick/Washington Counties, past chairman for our State Emergency Services Council, previous member of our State Emergency Services Board, and member of our State Fire Commission Board. 3 - Do you support: The growth of data centers in Frederick County? No The current Digital Infrastructure Overlay Zone? Yes Holding a referendum on whether to overturn the CDI zone?

No. I don't believe in expanding data centers outside the current zones or the overlay. The infrastructure is already laid out in the current area. It's within a heavily used industrial area that already had the infrastructure in place. The referendum should have taken place long before building the data centers started. I think the current referendum was hastily put together.

The current Critical Digital Infrastructure Overlay (CDI) Zone needs stronger safeguards to address energy demand, environmental impacts, and community concerns. I support revisiting and revising the CDI framework with stricter standards and transparency. If those changes are not implemented, I would support giving residents a voice through a referendum to reconsider or overturn the CDI zone.

1 - Why are you running for County Council?

Frederick County is at a crossroads. Families are feeling the strain of rising housing costs, crowded schools, traffic, and growth that often outpaces infrastructure. In District 2, we see both Frederick's opportunity and its growing pains. I'm running to bring thoughtful leadership that plans ahead preserving farmland, investing in education and transit, expanding housing options, and ensuring growth decisions are made with residents instead of happening to them.

2 - What experience (work/political/other) prepared you for this role?

My work in digital technology at Amtrak strengthened my ability to manage complex systems that converge physical and digital infrastructure, improve efficiency, and plan for long-range infrastructure needs. My previous work in government focused on constituent services and protecting consumers. As chair of Frederick County's Special Education Citizens Advisory Committee, I've worked directly with parents and school leaders to solve difficult challenges collaboratively.

3 - Do you support: The growth of data centers in Frederick County? The current Critical Digital Infrastructure Overlay Zone? Holding a referendum on whether to overturn the CDI zone?

I support targeted data center development in appropriate locations, but I oppose expanding into Priority Preservation Areas or productive agricultural land. The Planning Commission's recommendation strikes a more balanced approach that I support. I'm also proud to have earned the Sierra Club endorsement, reflecting shared priorities around environmental stewardship, and using our resources wisely. We should not make irreversible decisions based on speculative tech demand projections.

3 - Do you support: The growth of data centers in Frederick County? The current Critical Digital Infrastructure Overlay Zone? Holding a referendum on whether to overturn the CDI zone?

The CDI overlay overall has a lot of good intentions to keep us from becoming Loudoun County north. However, the process overall felt rushed and not enough public input was heard. I would look to establish more regulations towards the CDI overlay, like air quality monitors and supporting legislation requiring small modular reactors (SMRs). I do support the people's right to referendum for issues they feel have not met their standards.

1 - Why are you running for County Council?

I'm running to protect the community we love and ensure that its future is planned responsibly. My priorities are to help neighbors fight the MPRP, slow data center sprawl, advocate for smart budget decisions, support our schools and ensure our future is responsible and well-planned. I will listen and be a fierce advocate for our local community and the county we all call home. This campaign is about protecting what matters and planning what's next.

2 - What experience (work/political/other) prepared you for this role?

I'm the owner of a small local business and will bring over two decades of leadership, business, and financial background to the County Council. My life of service didn't begin with this campaign. I've been a volunteer chaplain, Little League coach, and school volunteer. Professionally, I've served as president of my trade association, led legislative committees, and fought to protect homeowners rights. I've also been a legal intervenor in the MPRP case.

3 - Do you support: The growth of data centers in Frederick County? The current Critical Digital Infrastructure Overlay Zone? Holding a referendum on whether to overturn the CDI zone?

I would have voted against the CDI overlay. Data centers should be as far away as possible from residential neighborhoods and they should never be placed on preserved land. I signed the referendum to put the CDI overlay on the ballot in 2026. Let the people decide. There's an organized effort to take this decision out of voters' hands. I'm in favor of reconfiguring the CDI overlay into something resembling the Planning Commission recommendation.

I do not support further expansion of data centers in Frederick County. The Dec. 23 vote grossly added more land to the overlay zone, despite residents and subject-matter experts voicing their concerns around effects to agricultural land, natural resource utilization, and utility hikes. I proudly voiced my opposition to the expansion and supported the referendum. I do not believe major land use decisions should be made on the premise of potential revenue.

No! The 287(g) program has been banned in Maryland. I'd follow the guidance of Maryland's attorney general, by only honoring criminal warrants signed by a judicial officer and not honor administrative warrants signed by a bureaucrat. Cooperation with ICE would mirror that of cooperation with other federal agencies like the FBI, ATF, U.S. Marshals, DEA, IRS, Postal Inspectors, etc. Sheriff's deputies would not act as ICE agents or perform the duties of ICE agents.

FCPS must be more transparent in all aspects of working with families, especially in how it spends taxpayer dollars, responds to serious incidents involving staff and students, and supports families navigating the IEP process to secure services their children need.

3 – What is the most important issue in this race? How specifically would you address it?

The school system's budget transparency must be strengthened. While detailed budget documents exist, they're often difficult for the public to understand. The superintendent should clearly explain the difference between mandated and discretionary spending, and provide more accessible, plain-language breakdowns of how taxpayer dollars are used. Citizens deserve to understand not only how money is spent, but also why the budget continues to grow due to factors beyond inflation, including enrollment, state mandates, and staffing costs.

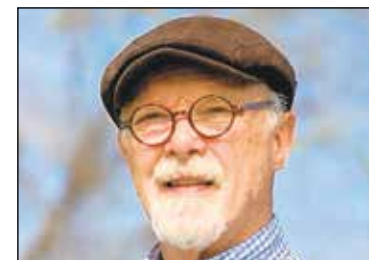

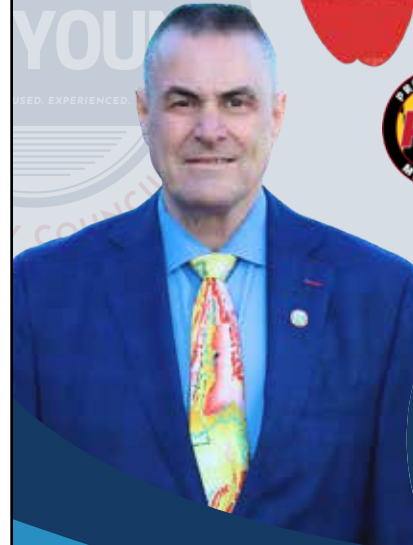
