On June 19, 2013, at approximately 2147 hrs, deputies responded to the area of Reels Mill Road at the railroad crossing for a suspicious situation / missing person. Cpl. Watkins arrived first and made contact with the complainants, Shawna Rebecca Lentz W/F [REDACTED] John Harold Lentz II W/M [REDACTED] and John Harold Lentz 3rd W/M [REDACTED]. Shawna called 911 after they located the vehicle that her mother was driving, a blue 2000 Ford Expedition, Maryland registration 630M500 at that location, unoccupied. Shawna advised dispatch that they had not heard from Teresa Lynn Lentz W/F [REDACTED] since around noon. Mrs. Lentz was running errands around Frederick to include depositing checks at BB&T / PNC banks and stopping at the Goodwill to donate item(s). She spoke with her husband, Mr. Lentz, sometime around 1330 hrs when she was going to the bank. Mr. Lentz advised that she was headed back to their residence to change vehicles afterwards and then was planning to go to Wegman's grocery store off of Rt. 26.

Mr. Lentz advised that he and his wife are business owners of a small electric company. He advised that she handles all of the office and scheduling information and he and his son complete the work. On this date Mr. Lentz and his son were responding to job sites. He advised that they were in Montgomery County during the afternoon. Mr. Lentz stated that he attempted to contact his wife via text messages and by phone with negative results during the afternoon and evening hours. Shawna had also been attempting to contact her mother with no success during that time either. She left their residence located at [REDACTED] Frederick, Maryland and began looking for Mrs. Lentz around 1830 hrs. Mr. Lentz and his son were at softball practice until approximately 1900 hrs, at which time they spoke with Shawna and joined in searching for Mrs. Lentz. Shawna checked Wegman's grocery store and other areas that she felt her mother may have gone to that day. At approximately 2145 hrs they located their vehicle parked along the railroad tracks on Reels Mill road, approximately 10 feet off the roadway.

When they approached the vehicle they noticed that Mrs. Lentz was not inside. They stated that they saw her cell phone sitting on the front passenger seat. They also noticed that her purse was lying on the front passenger floorboard and appeared as it had been overturned. Also in the vehicle were the keys in the ignition. After assessing the situation, Shawna contacted the Sheriff's office to report the incident. Deputies arrived shortly afterwards and began speaking with them on-scene. They advised that they opened the driver's side door and looked underneath the seat of the vehicle. All of the family members advised that she would not leave the keys in the ignition and her purse and phone in the vehicle unsecured.

Cpl. Angleberger arrived and spoke with deputies on the scene. Dfc. Deckhut and Cpl. Angleberger followed the Lentz's to their residence on [REDACTED]. CID was contacted and Det. Elrod responded to the residence. A quick check of the residence and garage yielded no further information regarding the whereabouts of Mrs. Lentz. Cpl. Angleberger had Mr. Lentz fill out a missing person's report. The Lentz's showed both deputies a to do list of items that Mrs. Lentz had written for herself. Nothing in the residence had been moved or displaced according to the family. They were able to access Mrs. Lentz's computer and check if any emails had been sent or received that may help aid in locating her with negative results. Dfc. Elrod inquired if he may seize the computer for further analysis, which Mr. Lentz agreed. None of the family members could provide any further information about the whereabouts of Mrs. Lentz. They advised that they had contacted all of the family members and friends that might know where she may have gone or had contact with her. Cpl. Angleberger and Det. Elrod returned to the scene of the vehicle on Reels Mill road. Cpl. Dewees and Sgt. Byers from CID also responded to the scene. Besides the items in the vehicle, a woman's shoe of a similar size as Mrs. Lentz's was located outside the driver's side of the vehicle. Deputies on the scene were also able to briefly look at the phone on the driver's seat and noticed the numbers 91 left in the dialing out function as the phone had been left on. Sheriff's office K9 officers and Maryland State Police air scent dogs and a bloodhound responded to the scene to conduct a track. Trooper 2 also checked the area surround the railroad tracks on Reels Mill road.

SUPPLEMENTAL REPORT: June 20, 2013

On June 20, 2013 at 0600 hours, Det. McCallion received a call from Sgt. Byers in reference to a critical missing person. Sgt. Byers advised Det. McCallion to respond to the Sheriff's Office for further briefing. At that time, Det. McCallion was assigned to review the victim's cellular records.

Later that morning, Det. McCallion spoke with Cole Brown, Civilian Search Manager Special Operations Division who was requesting the victim's cellular records at the scene. Brown requested the records to plot the locations of the victim's cellular phone. The review is as followed:

- At 1332 hours, the victim makes a call to [REDACTED]. This call is communicating with a tower located at 9602 A Baltimore Road Frederick, Maryland. This address is within a short distance from the victim's residence of [REDACTED]. This call last fifty-eight seconds.

- From that time until 1610 hours, the victim's cellular phone does not dial or receives any calls. However, with the smart cellular phones, the cellular phone is continuing to communicate with the nearest site tower every few moments, as to refresh the system. From 1335 hours to 1402 hours, the cellular phone is refreshing. At 1402 hours to 1457 hours, the cellular phone stops refreshing. The only way in which the cellular phone stops refreshing/communicating with the site tower is when the phone is turned off. The last site tower location the cellular phone refreshes/communicates with is located at 7396 Grove Road. At 1457 hours the cellular phone is turned back on and refreshes/communicates with the tower located at 6243 Jefferson Pike.

- The cellular phone begins to travel eastbound at that time, and eventually communicates with at site tower located at 11026 Fingerboard Road. This tower is within the range of the Reels Mill Road area.

Brown completed a detailed map that shows which site towers the victim's cellular phone is communicating with. The map will be submitted as an attachment to this report once received.

Mr. Yox said that Kyle informed him that yesterday he received a donation from Teresa Lentz. Mr. Yox said that Kyle said that one of the dock workers remembered the brown lazy boy chair. Det. Ollie told Mr. Yox that he would contact Kyle for more information.

Det. Ollie contacted Kyle at the Goodwill store on Buckeystown Pike and he informed Det. Ollie that Thomas Allan Ashe W/M [REDACTED] handled Mrs. Lentz's donation of clothes and the brown lazy boy chair. Det. Ollie spoke to Thomas over the speaker phone so that Det. Davies

could hear the conversation. Deckhut observed a grocery list and coupons on the table in the kitchen area. Dfc. Deckhut knew through the initial contact with the family that one of the errand that the victim Teresa was supposed to do was go to the grocery store. Once Det. Elrod arrived at the residence, Dfc. Deckhut responded back to the scene on Reels Mill Rd.

Once back at Reels Mill, Dfc. Deckhut was instructed to drive around the area in an attempt to locate the victim. Dfc. Deckhut drove Reels Mills Rd to Ball Road. Dfc. Deckhut took Ball road to Ijamsville Road. Dfc. Deckhut continued onto Ijamsville Road to Fingerboard Road. Dfc. Deckhut drove towards Urbana. Dfc. Deckhut checked the area around the BB&T Bank in Urbana for any sign that the victim was there. It was not know yet, which BB&T Bank she went to. Dfc. Deckhut then drove Worthington Blvd to Reels Mill and back to the scene. Dfc. Deckhut did not discover anything at that time.

Dfc. Deckhut was then instructed to block Reels Mill Rd at the one lane bridge to prevent any further traffic coming into the scene.

Dfc. Deckhut photographed the exterior the vehicle to document its position.

Dfc. Deckhut opened the passenger side door of the victims vehicle while wearing latex gloves. Dfc. Deckhut removed the papers from the passenger seat of the vehicle. The papers were two deposit slips. One deposit slip was for the PNC bank located on Monocacy Blvd and the other was for BB&T. These were collected at 0025, placed in a brown bag, would later be photocopied and provided to investigators, and the originals placed on property as evidence. Dfc. Deckhut also reached inside the vehicle from the drivers side. Dfc. Deckhut was wearing latex gloves. Dfc. Deckhut turned the ignition key forward to confirm that the vehicle still had gas. The gauge showed that the vehicle had just below a quarter tank of gas. Dfc. Deckhut then turned the key to the off position. Dfc. Deckhut would then collect the womans shoe near the drivers side door. The shoe was recovered and placed in a brown bag at 0121 hours. The shoe would later be placed on evidence.

Dfc. Deckhut assisted Sgt. Byers with taking some basic measurements of the vehicles position. The center of the front passenger side tire was exactly 12 feet from a rail lying next to the train tracks. Sgt. Byers measured the point on the rail to be 12 inches from the end. The center of the rear passenger tire was 22.3 feet (268 inches) from the fixed train rail. Sgt. Byers selected the exact point. Dfc. Deckhut measured 10 feet between the center of each of the passenger side tires.

I then spoke with the victim's husband who explained the series of events that led to the FCSO being called. Those details are explained in the initial report.

I immediately began requesting additional resources to the scene. I first contacted FCSO K-9 units and an MSP bloodhound K-9 unit. I ensured the scene was secured. I directed Cpl. Angleberger and DFC Deckhut to respond to the residence with the family members to conduct a search of the premises. I also instructed several units to begin roving patrols on the surrounding roadways and areas between where the vehicle was located and the victim's residence a short distance away. I contacted Detective Elrod and briefed him on the situation. Detective Elrod was requested to respond to the residence and begin interviewing the family.

Once on scene the MSP bloodhound team initiated a track. That track was unsuccessful and did not yield any useful evidence or leads. I then began requesting the search management team through MSP K-9 First Sgt. Fogle who was on the scene. This team includes personnel to help manage a search operation and related resources to include air scent K-9 units. I also requested an MSP helicopter to respond to the area to assist in the search. I made notification to the on call Patrol Operations Commander, Lt. Hibbard, who advised he would be responding. I made contact with the CID supervisor, Sgt. Byers, at the request of Detective Elrod and advised him of the need to involve additional investigators. Requests were also made for night vision and thermal imaging equipment to assist in the search operation.

Once the requested resources began arriving on scene I assisted Lt. Hibbard and the search management team in managing the search efforts. We continued to relay information to the investigative team as information was developed. I remained on scene in this capacity until relieved by Sgt. Cline at approximately 0700 hours on 6/20/13.

On June 21, 2013, I, Theresa Hiegel of the Victim Services Unit, contacted Michelle Pentony with Heartly House. Michelle Pentony stated she would have a staff member check to see if Teresa Lentz had ever been a client of Heartly House. A few moments later, I received a message from a Heartly House employee, Katherine Robinett, stating Heartly House did not have a record of Teresa Lentz contacting them.

Additionally, I accompanied Detective Davies to Planet Fitness on Rt. 40. It was believed by family members that Teresa Lentz may have had her work out bag in the vehicle based on surveillance videos retrieved from the banks. While at Planet Fitness, we met with General Manager Tahlullah Barger. Ms. Barger pulled up Teresa Lentz's account and stated that the last time Ms. Lentz swiped in at the gym was April 18, 2011 and she had not utilized Planet Fitness for 794 days.

Detective Davies and I then responded to the home of the Lentz Family at [REDACTED]. Detective Elrod was already present at the family home. While in the home, the Lentz family showed us a bag which they believe could have been in the front seat of Teresa Lentz's vehicle. Mr. John Lentz Jr. stated he also had the same bag. He provided this bag to us. This bag appeared to have black paneling and did not appear to be the bag in the surveillance videos. The family said that Teresa Lentz had not been to the gym for a least a year.

Other family members were also present to include Janet and John Kendall (John Lentz Jr.'s sister and brother-in-law), Cyndi Lake (John Lentz Jr.'s sister), and also Pastor Jenny from Mt. Caramel United Methodist Church. These family members stated that Teresa Lentz had made a to-do list for the day on Wednesday which included a grocery list and a bulleted point to fill the Explorer up with gas. The list was left on the kitchen table with coupons for Wegmans and also a receipt for gas points. A photo was taken of this list and emailed to Detective Elrod. It appeared to the family that Teresa Lentz was planning on returning home to retrieve her grocery list and coupons after running her other errands. The family reported that she typically shops at Wegmans or the Giant off of Rt. 26.

Shawna Lentz and John Lentz Jr. were reviewing different mail with Detective Elrod. Shawna Lentz located a bill for a life insurance policy for Teresa Lentz. This bill stated payment was due on June 27, 2013. Shawna Lentz provided this information to Detective Elrod. The family stated Teresa Lentz's main personal area was in their office. Teresa Lentz was mostly responsible for mail and bills. There were different piles of mail and bills throughout the home which were opened by Shawna Lentz and reviewed.

John Lentz Jr. and Shawna both stated there was a LinkedIn account which Teresa Lentz created under the name "Terri" Lentz. Shawna stated this is not unusual for her to use the name Terri. However, John Lentz Jr. found it odd that there were two email notifications that someone from their church music group had found her on LinkedIn and had made contact with her through this account on June 5, 2013, and also June 19, 2013. John Lentz Jr. stated June 19, 2013 was the day they came home from vacation. John Lentz Jr. was suspicious of this activity and stated he was not aware or had not "authorized" her to have a LinkedIn account. The family also reported that Teresa Lentz has a Facebook account, but stated she was not very active on this account.

During these conversations, multiple media representatives kept arriving at the family home and appeared to be taking photos of the home, cars, and property. The family stated they were struggling because they did not want the media continually at their home, but they wanted to get the word out about Teresa Lentz's disappearance so the media would continue to cover the story for more possible leads. On 6/22/13 at appx 1030 hrs I received at my desk a phone call from a woman who identified herself as Patricia (Cole) J. Murphy [REDACTED] older sister of Teresa Lentz. Patricia said that something has struck her as strange that she wanted us to know about.

Patricia said that her father Charles Cole has dementia and lives on [REDACTED] with his wife Cecelia (Patricias step mother). On Wednesday evening, the night Teresa was reported missing, Cecelia posted a note on Facebook at about 2059 hrs that while she was out for her usual evening walk she thought that Charles had received a phone call from Diana (Patricia daughter) because Charles talked about being on the phone with someone, but apparently Charles could not accurately describe who called or the content of the conversation. Patricia checked with Diana and the call was not from her. Patricia thought that the call might be significant because it apparently left Cecilia with the impression that it was from a female that Charles is familiar with. She said that Teresa often visited and took her dad out on Thursdays. Patricia believed that Cecilia normally walked after dinner, so the call may have been sometime between 1800 and when the note was posted to Facebook at 2059. Cecilia and Charles phone that the call would have come in on is [REDACTED] and Patricia was hopeful that investigators could determine where that call came from.

Patricia said that her father Charles called her last night (6/21) feeling like he needed to do something to help, and wanted to look around the Indian Springs area for some reason. She said family members took Charles out in the car and looked around the area, checking ditches and such.

Patricia also said that about 2 months ago she noticed Teresa wearing different rings and commented how nice they looked. Teresa told her that they were their (deceased) mother wedding ring and engagement ring. Patricia was not sure if Teresa might have had them on at the time of her disappearance, but thought she might have, and that they might turn up in a pawn shop or for sale somewhere. She described the rings as yellow gold with a slightly raised square style stone in an "old style" setting, and a plain yellow gold band. She did not know of any pictures of the rings, but thought she would recognize them if she saw them. She said that she thought that some people around Frederick believed that her family had a lot of money but they really dont, possibly alluding to a financial motive if there is a crime involved.

She also was curious if anyone had interviewed Teresa husband John by himself, away from other family members. She said that they did not like Shawnas (Terasas daughter) boyfriend Andrew Arias, but could not elaborate on specifically why. Apparently she thought that their disapproval of him was significant enough to mention to me. I told her that every little bit of info helps and she should not hesitate to share anything she thought might be useful.

I stopped by the hotel and spoke with staff members and guests that were out walking around. I showed the picture of Teresa Lentz to several of the staff and guests. Cindy Hoy (DOB [REDACTED]) who is an employee at the Days Inn told me that she spoke to a lady that looks exactly like Lentz this morning. Cindy told me that she is 100% certain this was Lentz. Cindy told me that the lady she believes is Lentz walked from near the intersection of Grove Rd. and Industry Lane into the hotel parking lot. The lady was walking with another woman described as a white female, mid to late 30's blonde hair. The lady (Lentz) asked Cindy for a cigarette. Cindy does not smoke so she did not have any cigarettes. The lady (Lentz) and the blonde hair female walked towards building B and continued in the direction of Rt. 85. Cindy could not provide any clothing description or other identifying features.

Cindy is certain that this was Lentz. I explained that Lentz is currently a missing person. Cindy did not seem to have any prior knowledge of this investigation which has been in the news.

I contacted Cpl. McFarland, Sgt. Benner and Detective Davies informing them of this information. Cpl. McFarland and I searched the immediate area speaking with people walking around. We could not find any further information regarding Lentz's whereabouts. Cpl. McFarland and I searched a wooded area behind the old Gold's Gym building directly underneath the water tower. We had observed several tents within the woods. We found two tents in which people are living inside. We also found one enclosed structure (makeshift house) that was locked. We did not make contact with anyone living in the woods.

I later returned at approximately 1115hrs to follow up with the Days Inn front desk. I acquired a guest list for the entire hotel. While I was getting this list I was approached by Debbie Smith (DOB [REDACTED]) who was standing in the lobby. Debbie asked to see the picture and stated that she had been living at the hotel for about 2 months. Debbie immediately stated, "I know Teresa, I went to school with her. Her husband's name is John and I think they live on Bartonsville Road." Debbie told me that she had not seen Teresa in several years but went to high school with her. Debbie then stated, "Well, now that I think about it that may have been her standing near the pool here at the hotel. That was about 1 week ago." Debbie stated the woman she observed was wearing blue jeans and a light blue tshirt. Debbie could not be certain that Lentz was the one she had observed. An employee then pulled me aside and told me Debbie has been going through a tough time and she may be making things up to get attention.

I contacted Cpl. McFarland who advised that Detectives Elrod and Dement were on their way to the Days Inn. We then assisted them with going door to door showing the flyer and checking rooms for Lentz. I checked the following rooms:

ASSIST WITH CRITICAL MISSING:

On June 24, 2013 Det. Mariotti was assigned to assist with this investigation. Det. Mariotti contacted Forensic Scientist Supervisor Jason Befus of the Maryland State Police to ascertain if their laboratory could conduct a presumptive blood test for the blood collected by Dfc. Tim Grove from the guardrail on Cont#33509. Det. Mariotti briefed Jason with the known facts of this investigation.

Jason advised the MSP laboratory could conduct a test to confirm it is blood however not differentiate whether it was human or animal blood. Jason advised to send a known sample of DNA from the victim i.e. a toothbrush and send it along with the blood swab to compare, if the swab was actually blood. Jason stated if they were able to extract enough DNA from the blood swab then they could compare it to the known DNA from the victim. Jason also emailed Det. Mariotti the Biology Evidence Submittal form to complete and submit for approval.

Det. Elrod is one of the lead detectives in this case and has had contact with the Lentz family. Det. Mariotti asked Det. Elrod to obtain Mrs. Lentz toothbrush from their residence to send to the MSP laboratory at which time Det. Mariotti will complete the necessary paperwork to have the evidence analyzed.

Det. Mariotti was also assigned to follow-up with incoming leads. On June 24, 2013 at approximately 1115hr Det. Mariotti made contact with Harold Paul Tellock 2/M [REDACTED] via public service [REDACTED]. Det. Easterday advised that Teresa Lentz of [REDACTED] was reported missing on 06/19/13, her vehicle, dark blue Ford Expedition with Mountain Top Electric lettering on the side, was found by the family at Reels Mill Rd at the rail road tracks and the vehicle was unlocked with the keys still in the ignition. Sgt. Easterday further advised that there was a single female shoe outside of the vehicle, and that there was a cell phone on the passenger's seat, and a purse was on the passenger's floor board. Sgt. Easterday advised that when the cell phone found inside of the vehicle was viewed it had the digits 91 dialed in.

Contact was made with John Lentz 2nd, John Lentz 3rd, and Shawna Lentz at [REDACTED] at about 2300 hours on 06/19/13. I spoke to them in the dining room. I was advised by John Lentz 2nd and John Lentz 3rd that they had last seen Teresa Lentz at their [REDACTED] on 06/19/13 at about 1200 hours when they stopped by to pick up tools. They advised that everything seemed fine with her and that she did not say she was going to another location other than the bank to make deposits, Good Will to make donations, and grocery shopping. They advised that her grocery shopping list was left on the table, which she would have taken with her. A copy of that that grocery list was obtained and submitted with this report. I asked John 2nd, John 3rd, and Shawna Lentz that last time that they spoke to Teresa Lentz. I was advised that John Lentz 2nd had spoken to Teresa Lentz by cell phone on 06/19/13 and everything was fine. I asked several more detailed questions in order to obtain information from the family about friends, family, associates, hobbies, interest, expressed interest, places she likes to go. I was advised that Teresa Lentz attends the Mt. Carmel Church and is active in the band at the church. I was advised that she attends the Mt. Carmel Church softball games with her husband and son. I was advised that she likes to read and plays computer games on her laptop computer. After speaking with the family about Teresa Lentz I learned that they were a close knit family, that members of the family always knew where each was, and that Teresa's social life consisted of her family and Church activities. Her family expressed that her not being accounted for and missing was very unlike her. They advised that the family does actives together and are almost always home in the evening for dinner, which Teresa missed. They advised that they had recently been camping at Fort Wahley that past weekend and that everything seems fine. I asked them questions about anything unusual around that home. They checked and did not see anything out of place. It was noted that all of Teresa's hygiene items were accounted for. It was also noted that Teresa had two wedding rings. One of which was account for.

I went over social media with the family. I was advised that Teresa had an email account with Comcast and that she was on Face Book. John 2nd, John 3rd, and Shawna advised that Teresa had a laptop computer. Shawna Lentz was able to figure out what the password for Teresa's laptop computer was. I viewed that computer, HP Laptop DX, with the family's permission. I checked the internet activity and did not find anything unusual. I checked the router internet activity for that computer and did not find anything unusual. I viewed the contents on the computer and found very little documents none of which were helpful in this investigation. I asked the family how long she had the computer and they said about five years. They advised that she uses it to play games. It was noted that computer was very impersonal. It only had a few family pictures and very few documents related to Teresa. The family advised that each member had their computer. I viewed Teresa Lentz Comcast email account and only found that she had an accepted message on Linken from a Christopher Mortorff on 06/19/13 everything else in the email account was either junk mail or related to the Mountain Top Electric business. I checked Teresa's Facebook account and did not obtain any information for this investigation. Her facebook account had no postings by her. I was advised that she lets Facebook friends post to it, but

does not actively use it. John Lentz 2nd signed a consent form for me to Search and Seize that computer. The computer was submitted to the FCSO Property Section on 06/20/13.

All of the banking and credit card information for John Lentz 2nd and Teresa Lentz was obtain. All of their banking information was given to Det. Skelley during this investigation to check and monitor.

While speaking with the family it was determined that they last saw Teresa Lentz at [REDACTED] on 06/19/13 at about 1200 hour. Had phone contact with her on 06/19/13 at about 1330 hours and found her vehicle at the rail road tracks on Reels Mills Rd at 2147 hours. John Lentz 2nd and John Lentz 3rd advised that Mountain Top Electric is a family business and Teresa is the office manager. They advised that the office is located at their home. I asked that family about Teresa medical and mental history. I was advised that she never seen any doctors for any mental disorders and did not have any life threatening medical issues. They advised that her last doctor's visit was related to any arm injury and that was awhile back. I asked the family if Teresa had ever tried to hurt herself or attempt suicide and they advised no. I asked then if Teresa had made any statements about committing suicide or hurting herself and they said no.

I spoke to John Lentz 2nd privately regarding Teresa. He advised that their relationship was good and that they had sex that morning. He advised that they do argue on occasion but it was minor disagreements. He advised that there had not been a change in Teresa's behavior. After speaking with him I did not obtain any information or indication that he knew where Teresa was.

I also spoke to John Lentz 3rd and Shawna Lentz and was not able to obtain any information that would indicate where Teresa was.

Shawna Lentz advised that on 06/19/13 she was at work in Montgomery County all day. She advised that she last communicated with Teresa on 06/19/13 at 1134 hours and everything seemed fine. She advised that when she returned home from work that evening Teresa was not home and she had not been answering any of the text messages. Shawna advised that she communicated this to her family and then began to check stores that Teresa may have been. Shawna advised that she met back with her father and brother at about 2100 hours and they all decided to get into one car and drive around the area together. Shawna advised that they located the dark blue Expedition that Teresa drives on Reels Mill Rd at the rail road tracks. Shawna stated that her father and brother checked the car, while she called the Police. This was at 2147 hours on 06/19/13, which was confirmed from her cell phone and from the calls for service. Shawna was asked about where they found the vehicle and she stated that her father and brother looked at it and she did not disturb anything. She stated that Teresa was not there.

I spoke to John Lentz 2nd and John Lentz 3rd. They advised that on 06/19/13 he was with his father all day. He advised that they started the morning off at a job in Wormins Mill at about 9:30. He advised that they took 270 north to the Clarksburg exit, Rt. 121, to Rt. 355 north bound. He advised that they traveled Rt. 355 into Frederick City to go to Rosemont Ave.

John Lentz was provided with my contact information and the case number.

After leaving [REDACTED] I responded to Reels Mill Rd and the rail road tracks. Contact was made with Lt. Hibbard, Sgt. Byers, and Cpl. DeWees. They were briefed on my interview with the family. I then responded to FCSO Patrol. The dark blue Ford Expedition was towed back to FCSO Patrol by Marks Equipment Service Inc and stored in the Evidence Bay. Cellebrite was completed on Teresa's phone and Verizon was contacted for historical information on the phone. The Cellebrite information revealed that Teresa had been in contact with a Zack Reeves. Zach Reeves would be contacted on 06/20/13 by Det. Davies and I. Det. Davies will complete a supplement on that contact. The historical data regarding Teresa's cell phone did not put her in any other places on 06/19/13 other then Frederick, MD. That information would be used by several investigators during this investigation in an effort to located Teresa.

While at Patrol I was advised that a search of the Ford Expedition was completed by Sgt. Byers and Cpl. DeWees and they did not located a wallet in the purse. Contact was made with the family and I was advised that there would have been a brown wallet in Teresa's purse. I was also advised by Sgt. On the morning of 06/20/13 I responded back to [REDACTED] and recontacted the family. The family and I went through a massive about of financial documents. I did not find any information in those documents that would provide any leads to this investigation. I also walked through that home and the property with John Lentz 3rd and did not find any information or make any observations that would help in this investigation. I then talked with several neighbors and did not obtain any information or leads.

On 06/21/13 and 06/22/12 I spent the duration of the day following up on Tips provided by the public in reference to this case with negative results. That information was documented in a supplement.

He advised that the Izaak Walton League is located on Reels Mill Rd a very short distance from where Teresa's vehicle was found. Mr. Pickens advised that they had a shooting range with video surveillance that runs on a constant basis's. Mr. Pickens provided me with copies of the video from the Izaak Walton League for 06/19/13 from 1300 hours to 2330 hours.

On 06/25/13 I contacted 9 Car and Truck Rental companies in Frederick. I was advised that Teresa Lentz or Teresa Cole had not rented a vehicle from them. They checked pervious history and for 06/19/13 to 06/25/13. They also advised that she had not returned any vehicles.

On 06/25/13 at approx. 2130 hours I was contacted by Sgt. Byers and informed that Teresa Lentz had walked into a Wawa located in Spotsylvania County, VA. I was further advised that she told the clerk to call 911 and report to the police that she was abducted. I was advised that Teresa asked to use the phone at Wawa in Spotsylvania County to call her family. While enroute to Spotsylvania County Sheriff's Office, 9119 Dean Ridings Lane, Spotsylvania, VA 22553, she was interviewed by Agent Treadway of the FBI and Spotsylvania County Sheriff's Office Detectives for the report that she was abducted from Frederick County, MD taken by her abductor to Spotsylvania County, VA and held against her will for six days. During the interview Teresa provided her accounts of the abduction to Agent Treadway and Det. Harris. Reference Spotsylvania County Sheriff's Office Case Number 13-69492 and the attached FBI Report by Agent Tread was for details on their interview with Teresa regarding her abduction. Sgt. Byers and Det. Davies conducted a second interview with Teresa. During this interview they indicated several discrepancies in Teresa story about her accounts in Frederick County, MD. During the interview Teresa admitted to Sgt. Byers and Det. Davies that she fabricated the story of being abducted. Teresa admitted that she was not abducted and staged the scene found at Reels Mill Rd and the rail road tracks. She advised that she had saved up about \$600 and on 06/19/13 she had purchased a bicycle from Kmart in Frederick, MD. She advised after staging the scene at Reel Mill Rd she began to ride the bicycle eventually ending up in Spotsylvania County a few days later. She used the \$600 she saved up to purchase the bicycle and sustain her while missing. She advised that she stayed in motels two nights paying with cash and outdoors the other nights. Teresa took us to locations in Spotsylvania County that night where we located her belongings which she discarded. We located her bicycle and credit cards and drivers license, which she cut. She also advised that she cut her hair while she was missing. When asked why she decided to go missing she stated that she wanted to get away for awhile. Teresa appeared to be in good health and did not need medical attention. Teresa was reunited with her family who responded to Spotsylvania County Sheriff's Office and returned home to Frederick, MD with them.

All items belonging to the Lentz family that were seized will be returned and a supplement completed on the return.

No charges against Teresa Lentz are being sought regarding this case.

Teresa Lentz was removed from NCIC as a missing person and a copy of that removal was submitted to FCSO Records.

Joe Miller was sent an email to resolve the missing person locate flyer.

On the 20th of June 2013 at approximately 0600 hours, Detective Michael Davies was contacted (call-out status) by the Frederick County Sheriff's Office / Frederick County Bureau of Investigations (FCBI) Sgt. Eric Byers. Det. Davies was requested by Sgt. Byers to respond to the Law Enforcement Center (LEC) as deputies are currently working a possible critical missing / abduction case. Upon arrival, Det. Davies met with Sgt. Byers and other members of the FCBI. Along with other detectives, Det. Davies was briefed by Det. Elrod on the information he had initially received on this date from the complainants, John and Shawna Lentz. The victim has been identified as the wife and mother, Teresa Lynn Cole Lentz, [REDACTED] 2/f). Det. Davies obtained the following facts, details and chain of events as they allegedly occurred and were reported to Det. Elrod.

Det. Davies learned that on June 19, 2013 at approximately 2147 hrs, deputies responded to the area of Reels Mill Road at the railroad crossing for a suspicious situation / missing person. Cpl. Watkins arrived first and made contact with the complainants, Shawna Rebecca Lentz W/F [REDACTED] John Harold Lentz II W/M [REDACTED] and John Harold Lentz 3rd W/M [REDACTED]. Shawna called 911 after they located the vehicle that her mother was driving, a blue 2000 Ford Expedition, Maryland registration [REDACTED] at that location, unoccupied. Shawna advised dispatch that they had not heard from Teresa Lynn Lentz W/F [REDACTED] since around noon. Mrs. Lentz was running errands around Frederick to include depositing checks at BB&T / PNC banks and stopping at the Goodwill to donate item(s). She spoke with her husband, Mr. Lentz, sometime around 1330 hrs when she was going to the bank. Mr. Lentz advised that she was headed back to their residence to change vehicles afterwards and then was planning to go to Wegman's grocery store off of Rt. 26.

Mr. Lentz advised that he and his wife are business owners of a small electric company. He advised that she handles all of the office and scheduling information and he and his son complete the work. On this date Mr. Lentz and his son were responding to job sites. He advised that they were in Montgomery County during the afternoon. Mr. Lentz stated that he attempted to contact his wife via text messages and by phone with negative results during the afternoon and evening hours. Shawna had also been attempting to contact her mother with no success during that time either. She left their residence located at [REDACTED] Frederick, Maryland and began looking for Mrs. Lentz around 1830 hrs. Mr. Lentz and his son were at softball practice until approximately 1900 hrs, at which time they spoke with Shawna and joined in searching for Mrs. Lentz. Shawna checked Wegman's grocery store and other areas that she felt her mother may have gone to that day. At approximately 2145 hrs they located their vehicle parked along the railroad tracks on Reels Mill road, approximately 10 feet off the roadway.

When they approached the vehicle they noticed that Mrs. Lentz was not inside. They stated that they saw her cell phone sitting on the front passenger seat. They also noticed that her purse was lying on the front passenger floorboard and appeared as it had been overturned. Also in the vehicle were the keys in the ignition. After assessing the situation, Shawna contacted the Sheriff's office to report the incident. Deputies arrived shortly afterwards and began speaking with them on-scene. They advised that they opened the driver's side door and looked underneath the seat of the vehicle. All of the family members advised that she would not leave the keys in the ignition and her purse and phone in the

vehicle unsecured.

Cpl. Angleberger arrived and spoke with deputies on the scene. DFC Deckhut and Cpl. Angleberger followed the Lentz's to their residence on Bartonsville Road. Det. Elrod of FCBI was contacted and responded to the residence. A quick check of the residence and garage yielded no further information regarding the whereabouts of Mrs. Lentz. Cpl. Angleberger had Mr. Lentz fill out a missing person's report. The Lentz's showed both deputies a to do list of items that Mrs. Lentz had written for herself. Nothing in the residence had been moved or displaced according to the family. They were able to access Mrs. Lentz's computer and check if any emails had been sent or received that may help aid in locating her with negative results. Det. Elrod inquired if he may seize the computer for further analysis, which Mr. Lentz agreed. None of the family members could provide any further information about the whereabouts of Mrs. Lentz. They advised that they had contacted all of the family members and friends that might know where she may have gone or had contact with her. Cpl. Angleberger and Det. Elrod returned to the scene of the vehicle on Reels Mill road. Cpl. Dewees and Sgt. Byers from FCBI also responded to the scene. Besides the items in the vehicle, a woman's shoe of a similar size as Mrs. Lentz's was located outside the driver's side of the vehicle. Deputies on the scene were also able to briefly look at the phone on the driver's seat and noticed the numbers 91 left in the dialing out function as the phone had been left on. Sheriff's Office K-9 officers, Maryland State Police air scent dogs and a bloodhound responded to the scene to conduct a track. Trooper 2 also checked the area surround the railroad tracks on Reels Mill Road.

Det. Davies learned that a consent to seize the vehicle and phone was obtained by Det. Elrod from Mr. Lentz. The vehicle was towed back to the Sheriff's Office to be processed. Cpl. Angleberger conducted checks around the area. Dispatch was provided the information and a general broadcast was completed at approximately 0230 hrs. Cpl. Angleberger had Mrs. Lentz entered into NCIC as a missing person, NIC # M611414415 by PIS Howes. Several deputies and investigators remained on-scene throughout the night. At this time, it is unknown whether Mrs. Lentz left the vehicle at the location on her own or if she had been taken from the location by someone else. A photo of Mrs. Lentz was included with the missing person's report.

On the morning of the 20th, Det. Davies and Det. Elrod were initially tasked with contacting a contact that was located on Teresa's phone records. The phone number showed several contacts to Teresa phone the day before her disappearance. The phone number was identified and owned by Zachery Joel Reeves, (██████████ 2/m). Det. Davies and Det. Elrod responded to their residence located at ██████████. Det. Davies interviewed Zachery and his mother, Marie as they are both familiar with Teresa. They advised that Zachery use to bowl on the same league as Teresa and her husband, John. Zachery did acknowledge that he did call and speak with her one the day in question. Zachery could not advise if she was acting different than normal. Zachery advised he has not seen Teresa since May 17, 2013 when they all attended a bowling banquet.

On June 20, 2013, Det. Davies responded to the Lentz residence with Det. Elrod. Det. Davies observed the grocery list that was left behind by Teresa. Next, Det. Davies reviewed all of their financial documents, bank and credit card statements. Through a review, it was determined that the cards have not been used since Teresa's disappearance. All numbers have been reordered and documented. Several other detectives have been assigned to conduct surveillance (a flag implemented) on Teresa's bank accounts for activity.

On the 21st of June 2013, Det. Davies and Teresa Hiegel of the FCSO Victim Services Unit responded to Planet Fitness on Rt. 40. It was believed by family members that Teresa Lentz may have had her work out bag in the vehicle based on surveillance videos retrieved from the banks. While at Planet Fitness, we met with General Manager Tahlullah Barger. Ms. Barger pulled up Teresa Lentz's account and stated that the last time Ms. Lentz swiped in at the gym was April 18, 2011 and she had not utilized Planet Fitness for 794 days.

Det. Davies and Hiegel then responded to the home of the Lentz Family at ██████████. Det. Elrod was already present at the family home. While in the home, the Lentz family showed us a bag which they believe could have been in the front seat of Teresa Lentz's vehicle. Mr. John Lentz Jr. stated he also had the same bag. He provided this bag to us. This bag appeared to have black paneling and did not appear to be the bag in the surveillance videos. The family said that Teresa Lentz had not been to the gym for a least a year.

Other family members were also present to include Janet and John Kendall (John Lentz Jr.'s sister and brother-in-law), Cyndi Lake (John Lentz Jr.'s sister), and also Pastor Jenny from Mt. Caramel United Methodist Church. These family members stated that Teresa Lentz had made

a to-do list for the day on Wednesday which included a grocery list and a bulleted point to fill the Explorer up with gas. The list was left on the kitchen table with coupons for Wegmans and also a receipt for gas points. A photo was taken of this list and emailed to Det. Elrod. It appeared to the family that Teresa Lentz was planning on returning home to retrieve her grocery list and coupons after running her other errands. The family reported that she typically shops at Wegmans or the Giant off of Rt. 26.

Shawna Lentz and John Lentz Jr. were reviewing different mail with Det. Elrod. Shawna Lentz located a bill for a life insurance policy for Teresa Lentz. This bill stated payment was due on June 27, 2013. Shawna Lentz provided this information to Det. Elrod. The family stated Teresa Lentz's main personal area was in their office. Teresa Lentz was mostly responsible for mail and bills. There were different piles of mail and bills throughout the home which were opened by Shawna Lentz and reviewed.

John Lentz Jr. and Shawna both stated there was a LinkedIn account which Teresa Lentz created under the name "Terri" Lentz. Shawna stated this is not unusual for her to use the name Terri. However, John Lentz Jr. found it odd that there were two email notifications that someone from their church music group had found her on LinkedIn and had made contact with her through this account on June 5, 2013, and also June 19, 2013. John Lentz Jr. stated June 19, 2013 was the day they came home from vacation. John Lentz Jr. was suspicious of this activity and stated he was not aware or had not "authorized" her to have a LinkedIn account. The family also reported that Teresa Lentz has a Facebook account, but stated she was not very active on this account.

During these conversations, multiple media representatives kept arriving at the family home and appeared to be taking photos of the home, cars, and property. The family stated they were struggling because they did not want the media continually at their home, but they wanted to get the word out about Teresa Lentz's disappearance so the media would continue to cover the story for more possible leads. After speaking with Sgt. Bailey, it was determined that the Lentz family would respond to the Frederick County Sheriff's Office to make a statement to the various news media.

At 13:30 hours, the Lentz family arrived at the Frederick County Sheriff's Office and delivered a statement to various media outlets. Following this release of information, John Lentz Jr. asked if anyone had looked into camp sites in the area. John Lentz Jr. stated his brother-in-law, Paul Cole, provided him information that there was a camp site around the area of Teresa Lentz's vehicle. Cpl. Dewees confirmed that they had also received this information and looked into this campsite.
