### What to bring to your VITA tax appointment:

- Government-issued photo ID (not expired) for taxpayer and spouse
- Spouse must be present if married filing jointly
- Social Security card or ITIN for each family member
- Birth dates for taxpayer, spouse, and all dependents
- W-2 forms for all jobs worked
- Pension, annuity, or IRA distributions: 1099-R or RRB-1099
- Social Security benefits: SSA-1099
- All 1099 forms for other income: 1099-INT, 1099-DIV, 1099-G, etc.
- Self-employment income: 1099-K, 1099-NEC, 1099-MISC; a list of business-related income and expenses
- Education expenses (1098-T) and student loan interest paid (1098-E)
- Health Savings Account form: 1099-SA
- Health insurance form 1095-A for Marketplace Insurance (ACA)
- Child care provider name, address, tax ID, and amount charged
- Home mortgage interest, real estate taxes, medical expenses, charitable contributions, etc. (if itemizing deductions)
- Any other tax-related documents received
- Copy of prior-year returns, if available
- Bank account information for direct deposit, including a blank check, if available
- IRS Identity Theft PIN (if IRS sent notification PIN is required to file)
- VIN number if you have an auto loan on a car purchased in 2025
- Information about tips and overtime
