Congressman McCarthy,

You are no doubt aware of the recent reporting regarding Representative Marjorie Taylor Greene's ludicrous social media posts and activity in which she endorsed calls for the execution of President Barack Obama, House Speaker Nancy Pelosi, Secretary Hilary Clinton, and other colleagues you serve beside in the United States Congress. Even prior to these recent revelations, it was well known that Ms. Greene indulged in and propagated the bizarre and dangerous so-called "QAnon" conspiracy theory, which alleges that many of your Democratic colleagues and fellow Americans are pedophilic cannibals.
