NARRATIVE:

1 ON 10/09/2020 AT APPROXIMATELY 0030 HOURS I WAS MERGING ONTO HWY 316 EB FROM BUFORD DR WHEN I NOTICED A BLACK SUV TRAVELING EB ON
2 HWY 316 AT A VERY HIGH RATE OF SPEED WHILE WEAVING THROUGH MULTIPLE LANES OF TRAFFIC. I WAS ABLE TO CATCH UP TO THE VEHICLE AND
3 PACED IT FROM CEDARS RD AND HWY 316 UNTIL HWY 316 AND LOGANVILLE HWY. DURING THIS TIME I WAS ABLE TO MAINTAIN THE SPEED OF THE
4 VEHICLE IN QUESTION AND MY PATROL CAR AT 93 MPH TO PERFORM A SPEED PACE TEST ON HWY 316 EASTBOUND IN 55 MPH ZONE. MY READING WAS
5 SEEN BY MYSELF ON BOTH MY DASH SPEEDOMETER AND GARMIN GPS WHICH IS LOCATED AND MOUNTED TO MY PATROL VEHICLE. DURING THIS TIME I
6 WITNESSED THE BLACK SUV DISPLAYING NEW JERSEY TAG N18MPE SWERVING IN AND OUT OF TRAFFIC WITH OTHER VEHICLES PRESENT. MULTIPLE
7 TIMES I WITNESSED THE BLACK SUV GO OVER THE WHITE LINE OF THE RIGHT SIDE OF THE ROAD ON RIGHT LANE OF TRAVEL EVEN ENTERING
8 EMERGENCY LANE AND GRASS AREA. I WITNESSED THE BLACK SUV OVERTAKE VEHICLES WHILE ENTERING THE EMERGENCY LANE, UTILIZING THE
9 GRASS SHOULDER AND ONCE AGAIN ENTER THE LEFT LANE OF TRAVEL WHILE MAINTAINING A SPEED ABOVE 85 MPH. AT NO TIME DURING THE
10 VEHICLES ATTEMPT TO OVERTAKE AND PASS OTHER VEHICLE AS WELL AS CHANGE LANES WAS A LEFT OR RIGHT TURN SIGNAL INDICATOR USED.
11 SPEEDS WERE MAINTAINED ABOVE 85 MPH THROUGHOUT AS WELL AS RECKLESSNESS OF THE DRIVER THROUGH MULTIPLE CONSTRUCTION ZONES
12 ON HWY 316. DURING THIS TIME WHILE FOLLOWING THE BLACK SUV COMMUNICATION WITH GWINNETT COUNTY RADIO I ANNOUNCED TO THEM I WAS
13 ON FTO AND REQUIRED A GCSO FTO TO BE ENROUTE WITH ME. DEPUTY DAVIS (SO 523) WAS ENROUTE TO ME. DEPUTY DAVIS WAS BEHIND ME
14 SHORTLY THEREAFTER. I ALSO ANNOUNCED MY MOVING LOCATION AND ASKED FOR ADDITIONAL GCPD ZONE UNITS TO BE ENROUTE. DUE TO MY
15 MOVING LOCATION I WAS ADVISED THAT BARROW COUNTY SO WOULD PICK UP THE VEHICLE ONCE IT CROSSED INTO THEIR JURISDICTION AND DUE TO
16 THE HIGH RATE OF SPEED GCPD WOULD NOT BE ABLE TO MAKE CONTACT BEFORE WE CROSSED JURISDICTIONAL LINES. BARROW SO PICKED UP
17 RIGHT BEFORE CARL BETHLEHEM RD AND HWY 316. BARROW COUNTY SO INITIATED THE STOP. FINAL STOP WAS HWY 316 AT SMITH CEMETERY.

19 DURING MY APPROACH OF THE VEHICLE I COULD SMELL A STRONG ODOR OF MARIJUANA EMITTING FROM THE VEHICLE. IT WAS THEN DETERMINED
20 THE VEHICLE WAS OCCUPIED FIVE TIMES BY FOUR BLACK MALES AND ONE WHITE FEMALE. EACH OCCUPANT WAS ASKED TO EXIT THE VEHICLE. THE
21 DRIVER WAS PLACED UNDER ARREST WHO I HANDCUFFED, CHECKED FOR FIT AND DOUBLE LOCKED BEHIND HIS BACK BEFORE BEING PLACED IN THE
22 REAR OF PATROL VEHICLE 518. DEPUTY K. DAVIS APPROACHED MY PATROL VEHICLE TO WATCH THE SUBJECT IN THE REAR OF MY VEHICLE WHILE I
23 CONCLUDED MY INVESTIGATION. THE OCCUPANTS OF THE VEHICLE ADVISED THEY PLAYED BASKETBALL FOR UGA. DUE TO THE NATURE OF THE STOP
24 AND THE FACT THE OCCUPANTS STATED THEY WERE STUDENT ATHLETES OF UGA AND FROM OUT OF STATE, MYSELF AND BARROW COUNTY
25 DEPUTIES FELT IT APPROPRIATE TO NOTIFY THE UGA ATHLETICS DEPARTMENT. ALL OCCUPANTS OF THE VEHICLE ADVISED THEY HAD BEEN SMOKING
26 MARIJUANA IN THE VEHICLE AT THAT TIME. A SEARCH WAS PERFORMED BY BARROW COUNTY DEPUTIES. MULTIPLE "ROACHES" OF MARIJUANA WERE
27 FOUND IN THE VEHICLE. DUE TO THE NATURE OF THE TRAFFIC STOP AND MYSELF AND BARROW COUNTY DEPUTIES WE FELT IT NECESSARY TO
28 CONTACT UGA ATHLETICS DEPARTMENT AND NOTIFY THEM WE HAD 3 OF THEIR MEN'S BASKETBALL PLAYERS DETAINED (UGA) AND 1 MEN'S
29 BASKETBALL PLAYER UNDER ARREST. MY POINT OF CONTACT FOR UGA ATHLETICS IS HEATHER MCCORMICK (UGA DIRECTOR OF OPERATIONS MEN'S
30 BASKETBALL). I NOTIFIED MCCORMICK OF THE INCIDENT INVOLVING HER PLAYERS. I THEN SPOKE WITH JAKE THELEN. THELEN (ASST BASKETBALL
31 COACH). BARROW COUNTY DID NOT WANT TO ARREST ON THE MISDEMEANOR AMOUNT OF MARIJUANA AND FELT IT BETTER TO RELEASE THE
32 INDIVIDUALS TO THE ASSISTANT COACH WHO WAS THEN INBOUND TO GET HIS PLAYERS AND THE FEMALE. MR. KIER WAS THEN TRANSPORTED TO THE
33 GWINNETT COUNTY JAIL AND RELEASED TO THE ADMISSIONS DEPUTIES ON DUTY. MR. KIER WAS GIVEN COPIES OF HIS CITATIONS. THIS INCIDENT WAS
34 CAPTURED ON BOTH AXON BODY CAMERA AND IN CAR REAR PASSENGER CAMERA.
