Sealed Bids for the construction of **"Miscellaneous Street Improvements [FY2027] for City of Hammond"** will be received by the Mayor & City Council of the City of Hammond at the City Hall Annex, 312 East Charles Street; Hammond, LA 70401, until **10:00 a.m. (CDT) Thursday, September 17, 2026**, at which time the Bids received will be publicly opened and read. The Project consists of:

Mill (about 4,300 SY) and overlay the 200-700 blocks of N. Hazel St. with about 490 TN of 2" th. asphaltic concrete; remove/replace about 20 SY of 8" th. pavement to facilitate the removal and replacement of about 36 LF of 15" RVPCP pipe and 1 EA Type VIII catch basin (200 block); install thermoplastic pavement markings on Hazel Street from W. Morris north to W. Dakota (including centerline striping, stop bars, and RR markings); install about 880 LF of barrier curb over 300 SY of 8" th. (x 2.5'W) PCC shoulders on N. General Pershing from Western Ave. to the SLU Lab School; haul in/grade/compact about 70 TN of limestone; sawcut pavements (1,080 LF); misc. sitework; traffic control; and work as called for on the drawings, indicated on the Bid Form, or reasonably implied.

Contract Term: 90 calendar days; Construction Cost Estimate: \$230,000.00

Bids will be received for a single prime Contract. Bids shall be on a unit price basis as indicated in the Bid Form.

Printed copies of the Bidding Documents may be obtained from the Issuing Office during the hours indicated above upon payment of a deposit of \$50.00 for each set. Bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within ten (10) days after receipt of Bids (September 28, 2026) will receive a full refund (\$50.00). Non-Bidders will receive a refund of \$25.00 for documents returned in good condition within the time limit indicated above. Checks for Bidding Documents shall be payable to "Spangler Engineering, LLC". Upon request and receipt of the document deposit indicated above the Issuing Office will transmit the Bidding Documents via delivery service. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

A pre-bid conference will be held at 10:00 am on Thursday, September 10, 2026, at the Office of the Engineer; 214 Southwest Railroad Avenue; Hammond, LA 70403. Attendance at the pre-bid conference is highly encouraged but is not mandatory.
