The Ouachita Parish School Board met in regular session on Tuesday, May 12, 2020 at twelve (12:00) o'clock noon at its regular meeting place, the Ouachita Parish School Board office.

President Hicks called the meeting to order and welcomed visitors and guests to the meeting.

The roll was called and the following members were present: Tommy Comeaux, Shere May, Scotty Waggoner, Jerry R. Hicks, Harold McCoy, Dabo Graves and Greg Manley. There were none absent.

The Pledge of Allegiance to the American Flag was led by Mr. Graves, Board member.

The Invocation was given by Mr. Manley, Board member.

On motion by Shere May, seconded by Scotty Waggoner, the Board unanimously approved the Minutes of April 28, 2020 as written.

On motion by Scotty Waggoner, seconded by Dabo Graves, the Board amended the Agenda to add Item No. 5. under IX. Business [Bid No. 45-20] Report on Woodchips at various locations by Bobby Jones. Motion carried unanimously by all members present.

On motion by Greg Manley, seconded by Shere May, the Board unanimously approved the amended Agenda as presented.

Under his Personnel Report, Dr. Coker announced that he is appointing current Assistant Principal of Robinson Elementary Valerie Williams

revenues in the General Fund of 78% and 64% in expenditures, which is expected. Ms. Mekus pointed out that the M&O Sales Tax revenue fund is 61.4% with expenditures of 83.9% which are right on budget for the year. The analysis of the fund balance reveals an estimated ending fund balance in the General Fund of \$18.8 million and right now we are at \$41.6 million, the difference being that the summer salaries are going to come out at the end of the year bringing us back to our estimated budget figure. The School District No. 1 M&O is ending the March 31 period with \$18.1 fund balance and an estimated budget of \$19.8 million. As projects get finished, it is expected this figure will change some. Ms. Mekus announced that she is excited that our sales tax collections remain flat for the year. She commented that, with all the uncertainty in the economy and business closings going on the past few months due to the Covid-19 Pandemic, we have been anxiously awaiting the results of our sales tax collections that are coming in and are very pleased that they remain flat. As Ms. Mekus reassured the Board that the collections will continue to be monitored for the rest of the year, Scotty Waggoner moved, seconded by Shere May, that the Board approve the 2019-20 Interim Financial Report for the Period ended March 31, 2020 as presented by Business Director Regina Mekus. Following a brief moment allowed for public comment by President Hicks, motion carried unanimously by all members present.

Purchasing Agent Bobby Jones announced that he received one bid from a vendor on [Bid No. 45-20] for Woodchips to be used at various locations, but has not accepted the bid because he needs more certification from the vendor on the bid product to meet requirements. Mr. Jones expects to hear from the vendor today. Once he receives confirmation from the vendor, he will proceed with awarding the bid. He reminded the Board that they gave him permission at the previous meeting to accept the bid that meets specifications. Whereby, Harold McCoy moved, seconded by Dabo Graves, that the Board accept the qualifying bid recommended by Mr. Jones for [Bid No. 45-20] for woodchips at various locations in the district. President Hicks allowed a brief moment for public comment and motion carried unanimously.

Upon the recommendation of the Supervisor of Safety/Construction Kenneth Slusher, Greg Manley moved, seconded by Dabo Graves, to accept the low bid from Gentry Construction, Inc. in the amount of \$149,927 for the repair of specified items listed on the bid proposal submitted that were damaged during a storm on April 12, 2020 at Sterlington High School. The damaged poles and lights were excluded from the bid and will be replaced by in-house personnel. Public discussion was allowed for a brief moment by President Hicks and motion unanimously carried by all members present.

Supervisor of Safety/Construction Kenneth Slusher announced that work on paving the parking lots at the Central Office and Edgewood (WMHS) will start tomorrow and will finish by Friday. They plan to do some touch up work on badly needed areas in the parking lot at Student Support Services and finish by Friday also. The contracts for drainage work at Woodlawn are currently being processed with plans to obtain signatures next week and will start the project after contracts are signed. In conclusion, Mr. Slusher reported that the band and choir room project at Woodlawn is being delayed due to the high ground water filling up the footings as soon as the footings are dug. The contractor and architect say that the river has to go down before the ground water table will go down.

On the recommendation of Purchasing Agent Bobby Jones, Tommy Comeaux moved, seconded by Shere May, that the Board grant permission to bid the following items: 1) Copy Paper [Bid No. 47-20] and 2) Paperback Books [Bid No. 7-21]. President Hicks offered a brief moment for public comment and motion carried unanimously by all members present. The next Board meeting will be held on June 9, 2020 at 12:00 noon.

Dr. Coker received an announcement from our governor that he is allowing everyone to stop the quarantine order on April 15 and authorized full operation of our school board facility with 25% capacity requiring everyone to wear masks and gloves and practice safe distancing. The superintendent also reported that there are no other positions to be filled at this time.

Amy Tynes with Allen, Green & Williamson, LLP, Certified Public Accountants, presented their Comprehensive Annual Financial Report on Internal Control over Financial Reporting and on Compliance and Other Matters Based on an Audit of Financial Statements Performed in Accordance With Government Auditing Standards that have been audited, in accordance with the auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in Government Auditing Standards issued by the Comptroller General of the United States of financial statements of the governmental activities, each major fund, and the aggregate remaining fund information of Ouachita Parish School Board as of and for the year ended June 30, 2019, which collectively comprise the School Board's basic financial statements. and have issued their report thereon dated March 31, 2020. However, not all deficiencies were identified that might be material weaknesses or significant deficiencies and therefore, material weaknesses or significant deficiencies may exist that have not been identified; but no deficiencies in internal control were identified that were considered to be material weaknesses. Although, certain deficiencies in internal control, described in the accompanying Schedule of Findings and Questioned Costs as items 2019-002 and 2019-003 that were considered to be significant deficiencies by the firm are being addressed. Whereby President Hicks called for a motion and Greg Manley moved, seconded by Dabo Graves, that the Board approve the Year Ended June 30, 2019 Audit Report of Financial Statements regarding the operations of the Board as presented by Ms. Tynes. President Hicks offered a brief moment for public comment, and motion unanimously carried by all members present.

Due to the delay in construction of the new Boley Elementary School, Board attorney Elmer Noah, along with Superintendent Coker, recommended that the Board consider an extension of the Boley Elementary Lease Agreement from The Assembly Church. Dr. Coker stated that our goal in June is to have a permission to bid for Boley. That is what we are working on and we are thinking that by the time that happens, it will take at least 18 months to complete construction on the school. The Assembly agrees to work with the Ouachita Parish School Board in leasing their building for Boley students for an additional period of 18 months commencing in July 2020 and expiring in January 2022 with an option to continue the lease on a month-to-month basis as needed. Following discussion, Tommy Comeaux moved, seconded by Shere May, that the Board approve extending the present lease agreement up to 18 additional months with an option to continue the lease beyond the 18-month period on a month-to-month basis if the school is not ready for occupancy by the end of the lease's term. President Hicks paused for a brief period for public comment and motion unanimously carried by all members present.

Business Director Regina Mekus presented the monthly 2019-20 Interim Financial Report for the Period ended March 31, 2020. It was reported the General Fund revenues were \$115.5 million for the year. A fund balance of \$94.3 million in expenditures was approved, giving us a current ending fund balance of \$41 million. As the Board approves the salaries for the 9, 10 & 11 month workers, we will see that fund balance decrease, but is considered right on track for the current year. District #1 M&O is ending the March 31, 2020 year to date period with an \$18.1 million fund balance for the year. The 1968 Sales Tax (1/2 cent) has a current fund balance of 5.8 million with the 1995 Sales Tax (1/2 cent) reporting a fund balance of \$3.2 million. Ms. Mekus reported that the West Ouachita Sales Tax (1cent) ending fund balance is \$8.4 million and noted that the Board closed on the sale of the School Board property to the Ouachita Parish Police Jury the first of May and that revenue is not reflected in this report. The Capital Projects Funds on the Eastside Construction Bonds 2015 as of March 31, 2020 has a remaining fund balance of \$119,886 and, as the projects are completed, the account is expected to be zeroed out by the end of the year. The Westside Construction Bonds 2015 fund balance has already zeroed out for the year, but prior to this, the remainder of those funds were used to complete ongoing projects. A comparison of accumulated revenues and expenditures over the prior year period was acknowledged showing

On February 18, 2020 the Louisiana Department of Health and (LDH) performed a detailed inspection and engineering evaluation of our water system called a sanitary survey. During this sanitary survey, they identified one or more significant deficiencies in our system. As our customers, you have a right to know what happened and what we are doing to correct this situation. According to EPA'S Ground Water Rule we were required to correct the deficiency for deficiencies) or work with the State of develop a plan to correct the deficiency (or deficiencies). However, we failed to correct the deficiency or contact the State before the established deadline and have therefore violated a requirement of the Ground Water Rule.

#### What should I do?

There is nothing you need to do. You do not need to boil your water or take other corrective actions. If a situation arises where the water is no longer safe to drink, you will be notified within 24 hours.

#### What does this mean?

This is not an emergency. If it had been an emergency, you would have been notified within 24 hours.

This significant deficiency has the potential to result in lack of proper treatment and oversight of the water system. Inadequately treated or inadequately protected water may contain disease causing organisms. These organisms can cause symptoms such as diarrhea, nausea, cramps, and associated headaches. While we have not detected any evidence of contamination or other health threats related to our source water, we are still committed to correcting the deficiency to eliminate the threat of contamination

#### What was done?

BATON ROUGE - Lawmakers agreed Tuesday on a \$34 billion state budget that provides hundreds of millions for businesses hurt by the COVID-19 shutdown but freezes \$60 million in pay raises for state employees and cuts funding for colleges that also are struggling financially.

As a 30-day special session was nearing an end, the House agreed to a Senate proposal to temporarily set aside the pay raises for in November whether tax collections had rebounded enough to provide them.

If the economy remains stagnant or depressed, the money will be used to fill holes in the budget.

In addition to nearly \$800 million in federal coronavirus aid money and the money saved on pay raises, lawmakers also will use \$90 million from the state's rainy-day fund to plug budgetary holes.

# **Court strikes down** La. admitting privileges law

The U.S. Supreme Court has ruled in favor of the abortion facility June Medical Services in June Medical Services v. Russo, striking down a Monroe lawmaker's law that required abortion service providers have admitting privileges at a nearby hospital.

State Sen. Katrina Jackson, D-Monroe, who sponsored the original legislation, referred to the Supreme Court's decision as a "tragic" one that prioritized the interests of for-profit abortion businesses instead of the health and safety of women.

"Together with my colleagues, both Democrats and Republicans and women and men, we passed the Unsafe Abortion Protection Act to protect the health and safety of women in Louisiana," Jackson said. "While today's decision is not what we wanted, we will never stop working to put the women of Louisiana above the interests of the abortion businesses."

# La. poised to approve \$250 hazard payments

Workers who were on the "front lines" of the COVID-19 pandemic will receive \$250 in one-time "hazard pay" under legislation the Louisiana House of Representatives approved Monday.

only monetary benefit directed to individuals. To be eligible, a worker has to have made \$50,000 or less last year and worked at least 200 hours outside their home between March 22 and May 14.

The program is reserved for occupations considered part of the essential infrastructure during the public health crisis when most people were encouraged to stay home, including health care workers, first responders, grocery store employees and many more.
