Former Warhawk dies from cancer

ULM L Club Hall of Famer month and get a week off. Every Jeff Blackshear, one of the great offensive linemen in program history, died Saturday, Aug. 31 after a lengthy illness. Blackshear was 50.

"He was an awesome player, an unbelievable specimen" said Tag Rome, an assistant coach when Blackshear played at ULM. "He was 6-7, 360. But you saw what a gentle giant he was as he grew up as a man. He was a real tender-hearted guy. Everybody liked him a lot."

Blackshear returned to the ULM campus on Sept. 22, 2018, for his induction into the school's athletic Hall of Fame. He was an All-America player under former coach Dave Roberts from 1991-92 and spent nine seasons playing in the NFL.

"I couldn't have picked a better school with the offense and the players that Coach Roberts had there," Blackshear said prior to his induction.

First diagnosed with pancreatic cancer in January 2014, Blackshear's battle against the disease lasted more than five years. When he was contacted early in 2018 about his selection to ULM's Hall of Fame, Blackshear said, "This is good for my soul."

Blackshear was up front about his condition then and grateful that ULM thought enough of him to recognize him as an all-time great.

"I'm not trying to keep it a secret," he said. "I want people to know. I want people to pray for me and my family. I'm still battling it. I get chemo three times a Florida State Saturday.

Monday, and then a week off.

"(The induction) was really something I was looking forward too. I didn't want anything to happen to me where I was gone, and my wife and kids were there to accept the award."

Selected by Seattle in the eighth round of the 1993 NFL Draft, Blackshear played professionally from 1993 until 2002 with four teams, including the Seahawks, Baltimore Ravens, Kansas City Chiefs and Green Bay Packers.

He started 96 of his 128 NFL games and had a 57-game starting streak for the Ravens from 1996-99.

In 1992, Blackshear became a key cog in a powerhouse offense that piled up 4,985 yards and scored 388 points while claiming the Southland Conference Championship and finishing ranked No. 1 in the final regular-season poll.

Blocking for future NFL running backs Roosevelt Potts and Greg Robinson, Blackshear was a first-team All-America guard by Kodak and NFL Draft Report and second-team selection by The Associated Press and Football Gazette.

"He was a natural pro," Rome said. "He played the guard position and nobody could handle him. He was a good teammate too. His teammates respected him "

ACT No. 444

HOUSE BILL NO. 243 BY REPRESENATIVE MIGUEZ A JOINT RESOLUTION

Proposing to amend Article VII, Section 21(D)(2) and (3) of the Constitution of Louisiana, relative to ad valorem tax exemptions; to authorize an exemp tion for certain property destined for the Outer Continental Shelf; to pro vide for certain definitions; to provide for an effective date; to provide for submission of the proposed amendment to the electors; and to provide for related matters.

Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members elected to each house concurring, that there shall be submitted to the electors of the state of Louisiana, for their approval or rejection in the manner provided by law, a proposal to amend Article VII, Section 21(D)(2) and (3) of the Constitution of Louisiana, to read as follows:

§21. Other Property Exemptions

Section 21. In addition to the homestead exemption provided for in Section 20 of this Article, the following property and no other shall be exempt from ad valorem taxation:

(D)

(2) Raw materials, goods, commodities, and other articles being held on the public property of a port authority, on docks of any common carrier, or in a <u>public</u> <u>or private</u> warehouse, grain elevator, dock, wharf, or public storage facility in this state for export to a point outside the states of the United States. For purposes of this Paragraph, "being held" shall include raw materials, goods, commodities and other articles stored in Louisiana for maintenance with a destination to the Outer <u>Continental Shelf.</u>

* * *

(3) Goods, commodities, and personal property in public or private storage while in transit through this state which are moving in interstate commerce through or over the territory of the state or which are in public or private storage within Louisiana, having been shipped from outside Louisiana for storage in transit to a final destination outside Louisiana, whether such destination was specified when transportation began or afterward. For purposes of this Paragraph, "storage while in transit" shall include goods, commodities and personal property stored in Louisiana for maintenance with a destination to the Outer Continental Shelf. view such plans for compliance with the requirements of this Subparagraph and to assure that the expenditure plans will support excellence in educational practice. No funds may be distributed to any school or school system a <u>recipient entity</u> until its plan has received both legislative and departmental approval as provided by law.

Section 2. Be it resolved by the Legislature of Louisiana, two-thirds of the members elected to each house concurring, that there shall be submitted to the electors of the state of Louisiana, for their approval or rejection in the manner provided by law, a proposal to repeal Article VII, Section 10.8(C)(3)(d) of the Constitution of Louisiana.

Section 3. Be it further resolved that this proposed amendment shall be submitted to the electors of the state of Louisiana at the statewide election to be held on October 12, 2019.

Section 4. Be it further resolved that on the official ballot to be used at the election, there shall be printed a proposition, upon which the electors of the state shall be permitted to vote YES or NO, to amend the Constitution of Louisiana, which proposition shall read as follows:

Do you support an amendment to provide for appropriations from the Education Excellence Fund for the Louisiana Educa tional Television Authority, Thrive Academy, and laboratory schools operated by public postsecondary education institu tions? (Amends Article VII, Section 10.8(C)(3)(b), (c), and (g); Repeals Article VII, Section 10.8(C)(3)(d))

HOUSE BILL NO. 428 BY REPRESENTATIVE DWIGHT A JOINT RESOLUTION

Proposing to add Article V, Section 35 of the Constitution of Louisiana, relative to the jurisdiction of the Board of Tax Appeals; to provide a remedy for payment of unconstitutional taxes; to authorize the legislature to extend the juris diction of the Board of Tax Appeals; to provide for submission of the pro posed amendment to the electors; and to provide for related matters. Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the electors of the state of Louisiana, for their approval or rejection in the manner provided by law, a proposal to add Article V, Section 35 of the Constitution of Louisiana, to read as follows:

§35. Remedies for Taxpayers

Section 35. The remedies required by Article VII, Section 3(A) of this Constitution shall extend to any unconstitutional tax paid by a tax payer. The Board of Tax Appeals is continued, subject to change by law enacted by two-thirds of the elected members of each house of the legis lature. It shall have jurisdiction over all matters related to state and local taxes or fees or other claims against the state as provided by Chapter 17 of Title 47 of the Louisiana Revised Statues of 1950, as amended, sub ject to change by law. The legislature may extend the jurisdiction of the Board of Tax Appeals, by a law enacted by a two-thirds vote of the elected members of each house of the legislature, to matters concerning the constitutionality of taxes, fees, or other matters related to its jurisdic tion which jurisdiction may be concurrent with the district courts concern ing such matters.

Section 2. Be it further resolved that this proposed amendment shall be submitted to the electors of the state of Louisiana at the statewide election to be held on October 12, 2019.

Section 3. Be it further resolved that on the official ballot to be used at the election, there shall be printed a proposition, upon which the electors of the state shall be permitted to vote YES or NO, to amend the Constitution of Louisiana, which proposition shall read as follows:

Do you support an amendment to protect taxpayers by requir ing a complete remedy in law for the prompt recovery of any unconstitutional tax paid and to allow the jurisdiction of the Board of Tax Appeals to extend to matters related to the con stitutionality of taxes? (Adds Article V, Section 35)

(c) Appropriations may be made for independent public schools which have been approved by the State Board of Elementary and Secondary Education or any city, parish, or other local school system, <u>laboratory schools approved by the State Board of Elementary and Secondary Education and operated by a public post-secondary education institution</u>, and for alternative schools and programs which are authorized and approved by the State Board of Elementary and Secondary Education but are not subject to the jurisdiction and management of any city, parish, or local school system, to provide for an allocation for each pupil, which shall be the average statewide per pupil amount provided in each city, parish, or local school system pursuant to Subsubparagraphe (d) and <u>Subsubparagraph</u> (e) of this Subparagraph.

(g) Each recipient-school or school system <u>entity</u> shall annually prepare and submit to the state Department of Education, hereinafter the "department", a prioritized plan for expenditure of funds it expects to receive in the coming year from the Education Excellence Fund. The plan shall include performance expectations to ensure accountability in the expenditure of such monies. The department shall re-

Section 1. §21. Other Property Exemptions

Section 21. In addition to the homestead exemption provided for in Section 20 of this Article, the following property and no other shall be exempt from ad valorem taxation:

(O)(1) Notwithstanding any provision in this constitution to the contrary, and in accordance with procedures and conditions provided by law, the City of New Orleans may exempt properties comprised of no more than fifteen residential units located within Orleans Parish from ad valorem taxes for the purpose of promoting and encouraging affordable housing. The exemption may provide an exemption from ad valorem tax for the total assessed value of the property, or a portion thereof, or may grant the right to pay ad valorem taxes based upon the assessed valua

tion of the property for the year prior to the commencement of the ex emption. Properties used as rentals for periods of less than thirty days shall not be eligible for any ad valorem tax exemption pursuant to this Paragraph.

(2) Notwithstanding any provision of this constitution to the contrary, any decrease in the total amount of ad valorem tax collected by the taxing authority as a result of an ad valorem tax exemption granted pursuant to this Paragraph shall be absorbed by the taxing authority and shall not create any additional tax liability for other taxpayers in the taxing district as a result of any subsequent reappraisal and valuation or millage ad justment. Implementation of an exemption authorized in this Paragraph shallneither trigger nor be cause for a reappraisal of property or an ad justment of millages pursuant to the provisions of Article VII, Section 23(B) of this constitution.
