AN ORDINANCE AMENDING ORDINANCE NO. 8048 WITH RESPECT TO THE EMERGENCY TELEPHONE SERVICE CHARGES IMPOSED IN THE COMMUNICATIONS DISTRICT OF THE PARISH OF OUCHITA, STATE OF LOUISIANA FOR THE PURPOSE OF ESTABLISHING, MAINTAINING AND OPERATING A 911 EMERGENCY TELEPHONE SYSTEM IN SAID DISTRICT; AND, FURTHER PROVIDING WITH RESPECT THERETO.

WHEREAS, on November 9, 1986, the voters of the Communications District of the Parish of Ouachita, State of Louisiana, -- a district with boundaries coterminous with the boundaries of Ouachita Parish -- approved a proposition authorizing said District to levy an emergency telephone service charge not to exceed 5% of the tariff rate for local telephone service within the District;

WHEREAS, following said election the Ouachita Parish Police Jury, in its statutory capacity as the Governing Authority of the Communications District adopted Ordinance No. 8048 levying a service charge of 3% of the tariff rate for local telephone service, with the proceeds of said service charge being dedicated for the purpose of establishing, maintaining and operating the 911 emergency communications system;

WHEREAS, thereafter, as more emergency 911 calls began to be made from wireless phones, the Louisiana Legislature adopted La. R.S. 33-9109 (Acts 1999, No. 1029) authorizing communications districts to levy a charge of not more than eighty-five cents per month on mobile telephones. Ouachita among state grant-eligible parishes

The Louisiana Housing Corporation (LHC) recently released a \$42 million Community Development Block Grant (CDBG) Notice of Funding Availability (NOFA).

These CDBG funds will be combined with Low-Income Housing Tax Credits (LIHTC) and bond-financed mortgage proceeds.

The Piggyback Resilient Mixed-Income (PRIME) NOFA is specifically designed to develop resilient multifamily properties in areas that were greatly impacted by the 2016 floods according to the U.S. Department of Housing and Urban Development. Eligible parishes include and are limited to Acadia, Ascension, East Baton Rouge, Lafayette, Livingston, Ouachita, St. Tammany, Tangipahoa, Vermilion, and Washington. Projects located in Special Flood Hazard Areas are not allowed.

PRIME will be administered in partnership with the Louisiana Office of Community Development (OCD). All projects will be required to incorporate resilient construction practices that use materials and techniques that increase a structure's ability to withstand adverse weather conditions.

In addition to incorporating resilient construction practices, all projects must also be newly-constructed multifamily developments for mixed-income occupancy. All projects must be completed by March 31, 2022. It is projected that five to eight developments will be funded through the PRIME NOFA.

Edwards vows to oppose tax cut efforts

Louisiana Gov. John Bel Edwards next year plans to oppose possible efforts to cut taxes so the state can afford to spend more money on education, the governor said Wednesday.

Last week, in a virtual replay of the controversy from the last budget cycle, a state House of Representatives Republican leader blocked adoption of a new revenue forecast, this time citing a dispute with State Treasurer John Schroder over the use of the unclaimed property fund. That move likely will prevent the governor from delivering to the legislature by the February deadline an official executive budget that by law

is supposed to be based on the official projection typically adopted in December.

Instead, Edwards, a Democrat who just won a hard-fought reelection campaign, expects to repeat the approach he took to the last budget cycle, issuing a budget proposal rather than an official executive budget as defined by law.

"We won't have any choice but to proceed in a fashion that's very similar to what we did earlier this year," he said. "This is just the second time this has ever happened since the REC was created."

In voting to block the estimate, Rep. Cameron Henry, the Republican House appropriations chairman who is moving over to the state Sen-

ate for the next term, suggested Edwards could repeat that process, though some Republicans blasted those efforts at the time.

Edwards' proposal would be based on the projections of the administration's top economist, which was the more conservative estimate presented to the Revenue Estimating Conference, he said. That projection would allow for an additional \$168 million in general fund spending for the current fiscal year and \$103 million for the following year, compared to the last official REC projection adopted in April.

Edwards said "investing in education at every level" is his top priority. That would entail continuing the effort begun in

the last legislative session to raise teacher pay to the regional average while spending more on early childhood and higher education.

Edwards held his traditional end-of-the-year news conference last Wednesday.

He said he plans to issue an emergency declaration as part of the state's effort to recover from recent severe weather, which killed one person in Louisiana and caused significant property damage, particularly in Rapides Parish.

Edwards also plans to extend the executive order he issued after the November cyberattack against state government in order to assist New Orleans city government in its response to a more recent attack.

Metro Narcotics arrests WM couple for dealing

Ouachita Parish Metro Narcotics Unit agents arrested a West Monroe couple on several drug dealing charges last week after authorities completed a 15-month investigation of the couple's activities.

Agents executed the search warrant at the home of Landon Hill, 29, and Desirea Nichole Hatfield, 21, of 113 Stonecliff Drive, West Monroe.

Inside the home, they found

more than 2,000 Xanax pills, half a pound of marijuana, digital scales, packaging material, LSD, mushrooms, and a loaded handgun.

Hill admitted he sold the drugs for profit.

He claimed the handgun belonged to his deceased grandfather and admitted he should not have kept it.

During questioning, Hatfield told agents she was aware of

the marijuana inside the house but not the pills.

She said she had sold drugs in the past.

According to Hill, Hatfield previously took Xanax to customers on his behalf.

The couple's infant child was inside the house.

Hatfield and Hill were booked on distribution of Xanax, conspiracy to distribute drugs, possession of Xanax with intent to

distribute, possession of marijuana with intent to distribute, and possession of a drug in the presence of a juvenile.

Hill also was charged with distribution of Adderall, three counts of distribution of Xanax, possession of LSD, possession of mushrooms, possession of a firearm in the presence of drugs, and possession of a firearm by a convicted felon.
