Randall then scored to put the Vikings up 22-0.

Randall added a 5-yard run for his third TD

of the night to put the Vikings up 28-0..

The final Vidalia touchdown came on an errant punt snap with Chatman recovering the ball in the end zone for the touchdown. Green ran in the conversion.

"That was a good team win," Faircloth said. "We really needed that to give us more motivation."

Green finished with 167 yards rushing on the night to go over the 1,00-yard mark for the season.

LSU-Tech hoops to meet Saturday

BATON ROUGE – Heading into a charity exhibition contest on Saturday, Coach Will Wade took the opportunity to visit with the media and discuss several topics concerning his 2019-20 LSU men's basketball team.

Coach Wade thanked the many fans who came to the PMAC as part of the TAF tailgate to watch the team practice on Saturday before the LSU-Auburn football game and thanks those who have helped make the season ticket purchase total for the season, the highest in over 20 years.

Among other things the Coach was asked about regarded style of play, the NBA draft process for those that left and those that returned for another season on the

team, the scheduling aspect for this season and other topics regarding players and coaching style.

LSU will travel to Ruston on Saturday for a 4 p.m. exhibition game at the Thomas Assembly Center against Louisiana Tech. The game is an NCAA-approved charity event to help raise money for the relief effort from the tornado this spring in Ruston that among other things did tremendous damage to several facilities on the LA Tech campus. There will be no television for the event, but Chris Blair and John Brady will broadcast the game on the affiliates of the LSU Sports Radio Network beginning at 3:45 p.m. on Saturday.

NSU's Pough earns two weekly honors

Ja'Quay Pough's monster day at Incarnate Word on Saturday made him the first Northwestern State defensive player to record at

least 20 tackles in a game since the 2014 season.

That performance also made him the first Demon to earn

weekly Southland Conference and Louisiana Sports Writers Association honors during the 2019 season.

Pough on Monday was named Southland Conference Defensive Player of the Week on Monday morning after recording 21 tackles, 1.5 tackles for loss and one sack in Northwestern State's 44-41 overtime victory against then-No. 20 UTW. Southland Conference players of the week are chosen by voting conducted among the conference's football sports information directors.

Later Monday, Pough picked up LSWA Defensive Player of the Week honors in a vote of statewide media members. Pough totaled 12.5 of a possible 20 points as he earned the first LSWA honor of his career.

With 11 solo tackles and 10 assists, Pough, a junior linebacker from Sherman, Texas, became the first Demon to total at least 20 tackles in a game since Marion Chapman recorded 20 against Sam Houston State on Oct. 18, 2014.

The 21 tackles are the most by a Southland Conference player this year and lifted Pough's season total to a team-leading 70.

Pough's award is the first weekly Southland Conference award for a Northwestern State defender since Peyton Guidry earned the honor for the final week of the 2017 season. Guidry also was the most recent Demon to earn LSWA Defensive Player of the Week acclaim, picking up the award for his performance against Stephen F. Austin in the 2017 season finale.

Pough and the Demons return to action Saturday at 4 p.m. when they face McNeese in Lake Charles.

The Federal Emergency Management Agency (FEMA) hereby gives notice to the public of its intent to reimburse eligible applicants for eligible costs for emergency work and to repair and/or replace facilities damaged by river flooding occurring between May 10, 2019 to June 17, 2019. This notice applies to the Public Assistance (PA) and Hazard Mitigation Grant (HMGP) programs implemented under the authority of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. §§ 5121-5207.

Under a major disaster declaration (FEMA 4462-DR-LA) signed by the President on September 19, 2019, Amendment 1 signed on October 17, 2019, the following parishes have been designated adversely affected by the disaster and eligible for PA: Assumption, Caldwell, Catahoula, Concordia, East Carroll, Franklin, Iberville, Ouachita, Pointe Coupee, Rapides, St. Martin, St. Mary, Terrebonne, West Feliciana. Additional counties may be designated at a later date. All parishes in the State of Louisiana are eligible for HMGP.

This notice concerns activities that may affect historic properties, activities that are located in or affect wetland areas or the 100-year floodplain, and critical actions within the 500-year floodplain. Such activities may adversely affect the historic property, floodplain or wetland, or may result in continuing vulnerability to flood damage.

Presidential Executive Orders 11988 and 11990 require that all federal actions in or affecting the floodplain or wetlands be reviewed for opportunities to relocate, and evaluated for social, economic, historical, environmental, legal and safety considerations. Where there is no opportunity to relocate, FEMA is required to undertake a detailed review to determine what measures can be taken to minimize future damages. The public is invited to participate in the process of identifying alternatives and analyzing their impacts through this notification.

FEMA has determined that for certain types of facilities there are normally no alternatives to restoration in the floodplain/wetland. These are facilities that meet all of the following criteria: 1) FEMA's estimate of the cost of repairs is less than 50 percent of the cost to replace the entire facility, and is less than \$100,000; 2) the facility is not located in a floodway; 3) the facility has not sustained major structural damage in a previous presidentially declared flooding disaster or emergency; and 4) the facility is not critical (e.g., the facility is not a hospital, generating plant, emergency operations center, or a facility that contains dangerous materials). FEMA intends to provide assistance for the restoration of these facilities to their pre-disaster condition, except that certain measures to mitigate the effects of future flooding or other hazards may be included in the work. For example, a bridge or culvert restoration may include a larger waterway opening to decrease the risk of future washouts.

For routine activities, this will be the only notice provided. Other activities and those involving facilities that do not meet the four criteria are required to undergo a more detailed review, including the study of alternate locations. Subsequent public notices regarding such projects will be published if necessary, as more specific information becomes available.

In many cases, an applicant may have started facility restoration before federal involvement. Even if the facility must undergo detailed review and analysis of alternate locations, FEMA will fund eligible restoration at the original location if the facility is functionally dependent on its floodplain location (e.g., bridges and piers), or the project facilitates an open-space use, or the facility is an integral part of a larger network that is impractical or uneconomical to relocate, such as a road. In such cases, FEMA must also examine the possible effects of not restoring the facility, minimize floodplain/wetland impacts, and determine both that an overriding public need for the facility clearly outweighs the Executive Order requirements to avoid the floodplain/wetland, and that the site is the only practicable alternative. The State of Texas and local officials will confirm to FEMA that proposed actions comply with all applicable state and local floodplain management and wetland protection requirements.

FEMA also intends to provide HMGP funding to the State of Louisiana to mitigate future disaster damages. These projects may include construction of new facilities, modification of existing, undamaged facilities, relocation of facilities out of floodplains, demolition of structures, or other types of projects to mitigate future disaster damages. In the course of developing project proposals, subsequent public notices will be published if necessary, as more specific information becomes available.

The National Historic Preservation Act requires federal agencies to take into account the effects of their undertakings on historic properties. Those actions or activities affecting buildings, structures, districts or objects 50 years or older or that affect archeological sites or undisturbed ground will require further review to determine if the property is eligible for listing in the National Register of Historic Places (Register). If the property is determined to be eligible for the Register, and FEMA's undertaking will adversely affect it, FEMA will provide additional notices. For historic properties not adversely affected by FEMA's undertaking, this will be the only notice.

As noted, this may be the only notice regarding the above-described actions under the PA and HMGP programs. I've done a lot of research and we still have land available we have 14 acres from the old sewer pond that's grown up. Citizen asked what are you going to do. Are you going to burn or dump. Mayor stated that it is going to be a place to deposit limbs for the citizen of Ridgecrest, there will be no burning. We plan on putting up a fence with a locked gate. We

have to get a permit. It's not going to happen overnight but it will happen. Saturday Ferriday will be here to pick up limbs that need to be moved off of the streets. We pay for the gas and the workers hourly pay. The main canal behind Vidalia Drive will be cleaned out. I will receive bids the work. Deb Barrett ask when will we do the canals. The Mayor stated that is what I'm working on now Vidalia Drive first then down Ferriday Drive. We are going to get it sprayed for weeks then get it cleaned out. Bolyer ask to add Police Chief on agenda. No motion made. Chief did say that the Principal of Concordia Parish Academy and she has a set of swings for the town. Mayor- I've got one more thing I would like to talk about. I would like to thank the President of the Police Jury, Jimmy Wilkerson for getting us the water for the Ridgecrest citizens. We stayed on the phone for 2 days getting it. It was stopped the first time and Jimmy did a lot of work getting it for us this time. He's working on getting us another load this week. Hopefully we will have another load delivered Friday and then we will deliver it to our citizens. The criteria for the water, is elderly and physically disabled. Jimmy Wilkerson stated that he did talk to the Governor this afternoon. He's going to try to get 32 palates and get them at one time. They will only do for 90 days. Mayor and board thanked Jimmy for his help. New business RCAP is a resource group like LRWA they have money to loan and that would be the 3rd resource for the water loan. We've gotten started on it. With RCAP you don't have to put reserve money into accounts and it would be a lot cheaper to get money from them if we are turned down for the grant. They will lend \$700,000. It is strictly a loan. It is something the board would have to do. He came down and I got him started with the paperwork, the budget and audit. He's throwing some numbers together and will come before the board and present it. Then the board will have to make a decision. This will be an option if we don't get the grant. Old Business-None. Bolyer makes motion to adjourn. 2nd by Lawrence. All yeas. Adjourned at 7:18 p.m.

Public Hearing and Meeting opened by Mayor at 7:00 P. M. Invocation by Alderwoman Bolyer. Pledge of Allegiance. Roll Call, Alderwoman Bolyer here, Alderwoman Humphries here, Alderwoman Barrett here. Mayor we have a quorum. Public Comments on Hearing. – None. Public Hearing Closed. Public comments on addenda items. - None. Mayor asked for motion to approve minutes for August. Motion made by Bolyer, 2nd by Humphries. All yeas. Mayor asked for motion to approve financials form Jerri Sue Tosspon. Motion made by Humphries, 22nd by Bolyer. All yeas. Motion to approve Clerk's financials for September. Motion made by Bolyer, 2nd by Humphries. All yeas. Mayors Report – Vidalia ditches. It finally dried out so we got to move out the dirt today. They moved about 20 loads today on the first half there is about 20 more left. There is about 40 to 60 loads on the second half. Once they get all of the ditches cleaned out and the bottom dug out they will go back with a bush hog w to cut the grass on both banks and cut the trees hanging over the bank. Connie Adair ask who is doing the work. Mayor-Curtis Nelson is doing the work. Connie Adair – How much is it going to cost the town. Mayor- 26,400. Adair – Where is it coming from. Mayor – Out of the street department. Tabitha Harris asked if Concordia Parish owned the ditch. Mayor – No it belongs to the Village of Ridgecrest. The ditch had tires, bicycles, BB guns. Harris – The ditch is looking great. Mayor – We're getting there. We called the state to make sure we could get the funds out of the Street account and we were told we could or we called Silas Simmons our auditor and they said the funds could be used for that because it is drainage for the street. Adair-How can that be drainage from the streets. Mayor – Drainage from rain water on the streets to the ditches. Concordia Parish Police Jury is going to clean the main ditch in the back. When you cross over the bridge he is going to do that on the other side of Ferris' house. Where they are taking the dirt to from the ditches on the 14 acres the town owns. The ditch that we are cleaning out comes from Vidalia Drive from a culvert under the road into a culvert under Mr. Durhams house then it drains into that ditch. Tabitha Harris stated that a couple of citizens mentioned a ditch the town owns behind Apple Street. Alderwoman Barrett said she went by there the other day and the town has cleaned the ditch. Mayor – We have cleaned all of the ditches in the town to get the water off of the streets. Of course we haven't had any rain but it has to be done when it is dry. It will be coming back. A citizen that lives at 100 Vidalia Drive asked if we are going to do anything else to the ditches. His ditch has a wash out where there is a leak. Mayor – We have the dirt now that we can put in it now. New Business – Temporary connections for Landlords. This is a topic to talk about not to be voted on. I had a couple of landlords ask me about this. In the Alderman's packages there is a proposal for temporary connections. To cut on water now it is a \$175.00 deposit now to cut it on a \$50.00 connections fee then the first months bill flat rate \$59.00 just to clean up a rent house when a tenant moves out. If the board would consider the rates of \$25.00 connection fee for 1000 gallons and 10 days then \$25.00 fee to cut it off. Anything over 10 days or 1000 gallons then the regular rates would apply. This is just a suggestion. It's something to discuss if you would like to add it to the agenda we can. Bolyer ask if it would be fair to the residents of Ridgecrest to do it that way. Mayor – Well not really. Barrett – just wanted to clarify that it was for landlords and not tenets of the rent houses. Mayor – Correct. Barrett – I think they need some help so that they can keep their rental property up, I think this is perfect. Mayor – We have a man that has bought several houses and has completely redone them inside and out. It has improved the look of the neighborhood and value of the houses. That in turn brings in new residents. Discuss it and decide if you would like to put it on the agenda and vote on it. Old Business – LCBDBG Grant. I would like everyone aware that we have been invited to complete a full application for the grant. There are 60 applicants left we came in at number 17 with a rating of 47. The tie in to Ferriday gives us 4 points that makes a total score of 51 and 50 is the top so we have a good chance of getting it. April is the month that they will decide who receives the grant. Oliver Schultz will apply for the grant for us. He went to school to find out what changes they have made to the application. Discussion of the amended ordinance for the reconnection fees Alderwoman Barrett – I'm not really happy with the fees for the reconnection fees. This amount of \$100 for reconnection you have to understand that we have senior citizens people on fixed income this is a poor neighborhood. This is not a rich neighborhood that people can just sling up \$100 for reconnection fee. I can see a percentage of the bill for a reconnect fee plus is they write a NSF check there is a \$30 fee plus that. The bank doesn't even charge you a \$100 fee plus NSF fee. This is ridiculous. Bolyer – JCP charges us a fee if they have to come out here and reconnect it. I believe it's \$54.50 per hour to come if we don't have anybody in the town to cut on the water. Barrett- We have an employee that can cut on the water and they can wait until he can get there. This is what is wrong with Ridgecrest now. Nobody wants to help anyone anymore. I had to pay a little old ladies water bill the other day. Boyler – I know I've paid some ones taxes before. Barrett – Something has to be done, we have to do something to help the people. There was someone that got there water cut off and there is no way she can pay \$100. There is 85% out here that can't pay it. The only one who didn't vote for it was Veller Ray Carroll. Dorothy Evans asked if the town was still notifying people when their bill is due Mayor – Since I have been here. Barrett well can the other worker call. Mayor – Yes she was going to be cut down but she can come in and call. Adair – If somebody want to pay while they are still cutting it off can he go and pay. Mayor – No they have to be cut off but we can look into being able to do that. Barrett – I think the town should go back to having curtesy calls. Well are we going to be able to change this. Mayor – You will have to change the ordinance. Bolyer – There was already a charge it was just an increase. Motion to adjourn made by Bolyer 2nd by Humphries. All yeas. Adjorned 7:38 P.M.
