WHEREAS, in compliance with the aforesaid constitutional and statutory authority and said special election of April 24, 2021, it is the desire of this Governing Authority to provide for the levy and collection of the Tax and to provide for distribution of the proceeds thereof and other matters in connection therewith as hereinafter provided in this ordinance;

NOW, THEREFORE, BE IT ORDAINED by the Parish School Board of the Parish of Ouachita, State of Louisiana (the "Governing Authority"), acting as the governing authority of School Sales Tax District No. 1 of the Parish of Ouachita, Louisiana (the "District") thereof, that:

SECTION 1. Imposition. Pursuant to the authority of a special election held in School Sales Tax District No. 1 of the Parish of Ouachita, Louisiana, on April 24, 2021, the Tax is hereby levied upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property, and upon the lease or rental of tangible personal property and on the sales of services in the District, as defined by law. The Uniform Local Sales Tax Code, as enacted by Act 73 of the 2003 Regular Session of the Louisiana Legislature and as it may be amended, shall apply in the assessment, collection, administration and enforcement of the Tax, the provisions of which are hereby incorporated by reference.

SECTION 2. Rate of Tax. The Tax is levied at the rate of one-half of one percent (1/2%) of the sales price of each item or article of tangible personal property when sold at retail in the District, the Tax to be computed on gross sales for the purpose of remitting the amount of tax due to the District, and to include each and every retail sale. The Tax is levied at the rate of one-half of one percent (1/2%) of the cost price of each item or article of tangible personal property when the same is not sold but is used, consumed, distributed, or stored for use or consumption in the District, provided there shall be no duplication of the Tax. The Tax is levied at the rate of one-half of one percent (1/2%) of the gross proceeds derived from the lease or rental of tangible personal property, as defined by law, where the lease or rental of such property is an established business, or part of an established business, or the same is incidental or germane to the said business, or of the monthly lease or rental price paid by lessee or rentee, or contracted or agreed to be paid by lessee or rentee to the owner of the tangible personal property. The Tax is levied at the rate of one-half of one percent (1/2%) of the amount paid or charged for taxable services, as defined by law, performed in the District.

SECTION 3. Effective Date. The Tax shall be effective on January 1, 2023.

SECTION 4. Term. The Tax shall remain in effect for ten (10) years (January 1, 2023 through December 31, 2032).

SECTION 5. Purposes. The proceeds of the Tax shall be used for the purposes set forth in the proposition approved by the voters in the special election held in the District on April 24, 2021, authorizing the Tax, which proposition is set forth in the preamble hereto.

SECTION 6. Vendor's Compensation. For the purpose of compensating the dealer in accounting for and remitting the Tax levied by this ordinance, each dealer shall be allowed one percent (1%) of the amount of Tax due and accounted for and remitted to the District's collector in the form of a deduction in submitting its report and paying the amount due by the dealer, provided the amount due was not delinquent at the time of payment, and provided the amount of any credit claimed for taxes already paid to a wholesaler shall not be deducted in computing the commission allowed the dealer hereunder.

SECTION 7. Exclusions and Exemptions. The Governing Authority adopts the following optional exemptions and exclusions:

The tax imposed and levied by this article shall not apply to the sale, use, lease or rental of machinery and equipment purchased, used, leased, or rented by a manufacturer for use in a plant facility predominately and directly in the actual manufacturing for agricultural purposes or the actual manufacturing process of an item of tangible personal property, which is for ultimate sale to another and not for internal use at one or more fixed locations within the authority. For purposes of this paragraph, "machinery and equipment", "manufacturer", "manufacturing", "manufacturing for agriculture purposes", "plant facility", and "used directly" shall have the same meaning as defined in R.S. 47:301(3)(i)(ii)."

Further, there shall be excluded from taxation charges for the furnishing of repairs to tangible personal property when the repaired property is delivered to the customer in another state either by common carrier or the repair dealer's own vehicle, however, as to aircraft, delivery may be by the best available means, Offshore areas shall not be considered another state for the purpose of this Paragraph."

Other than the foregoing, the Governing Authority adopts none of the optional exclusions or exemptions allowed by State sales and use tax law, nor does this Governing Authority adopt any exclusions or exemptions authorized by legislation enacted under Article VI, Section 29 (D)(1) of the Constitution of the State of Louisiana of 1974, that are not allowed as an exclusion or exemption from State sales and use tax. Included within the base of the Tax is every transaction, whether sales, use, lease or rental, consumption, storage or service, with no exclusions or exemptions except for those mandated upon political subdivisions by the Constitution or statutes of the State of Louisiana, including the Act.

ORDINANCE

An ordinance providing for the continued levy within School Sales Tax District No. 1 of the Parish of Ouachita, Louisiana, effective January 1, 2023, of a one-half of one percent (1/2%) sales and use tax upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and on sales of services in said District, providing for the assessment, collection, payment thereof and the dedication of the proceeds of said tax and the purpose for which the proceeds of the tax may be expended, such tax having been authorized at a special election held in said District on April 24, 2021.

WHEREAS, under the provisions of Article VI, Section 29 of the Constitution of the State of Louisiana of 1974, and other constitutional and statutory authority and an election held on April 24, 2021, the Parish Parish School Board of the Parish of Ouachita, State of Louisiana (the "Governing Authority"), acting as the governing authority of School Sales Tax District No. 1 of the Parish of Ouachita, Louisiana (the "District"), is authorized to levy and collect within the District from and after January 1, 2023, a onehalf of one percent (1/2%) sales and use tax (the "Tax"), upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and upon the sale of services as defined in applicable statutory authority, pursuant to the following proposition which was approved at said election held on April 24, 2021: SCHOOL SALES TAX DISTRICT NO. 1 PROPOSITION

(1/2% SALES TAX RENEWAL)

Shall School Sales Tax District No. 1 of the Parish of Ouachita, Louisiana (the "District"), be authorized to continue to levy and collect a tax of one-half of one percent (1/2%) (the "Tax") (an estimated \$8,356,644 reasonably expected at this time to be collected from the levy of the Tax for an entire year), for a period of ten (10) years from and after the termination of its current authorization on December 31, 2022, upon the sale at retail, the

SECTION 8. Interest on Unpaid Amount of Tax Due. As authorized by La. R.S. 47:337.69, the interest on unpaid amounts of the Tax which are due shall be at the rate of one and one-fourth percent (1-1/4%) per month. SECTION 9. Delinquency Penalty. The delinquency penalty, as provided by La. R.S. 47:337.70, shall be five percent (5%) per month on the unpaid amount of the Tax due for each thirty-day period, not to exceed five thirty-day periods.

SECTION 10. Penalty for False, Fraudulent or Grossly Incorrect Return. The penalty as authorized by La. R.S. 47:337.72 shall be fifty percent (50%) of the amount of the Tax found to be due.

SECTION 11. Negligence Penalty. The penalty as authorized by La. R.S. 47:337.73 shall be five percent (5%) of the unpaid amount of the Tax found to be due, or ten dollars (\$10.00), whichever is greater.

SECTION 12. Penalty for Insufficient Funds Check. The penalty as authorized by La. R.S. 47:337.74 shall be an amount equal to the greater of one percent (1%) of the check or twenty dollars (\$20.00).

SECTION 13. Attorney Fees. The collector is authorized to employ private counsel to assist in the collection of any taxes, penalties or interest due under this ordinance, or to represent him in any proceeding under this ordinance. If any taxes, penalties or interest due under this ordinance are referred to an attorney at law for collection, an additional charge of attorney fees, in the amount of ten per centum (10%) of the taxes, penalties and interest due, shall be paid by the tax debtor.

SECTION 14. Penalty for Costs Incurred. As provided by R.S. 47:337.75, and under the circumstances set forth therein, a penalty shall be added to the amount of Tax due in an amount as itemized by the Collector to compensate for all costs incurred in making an examination of books, records or documents, or an audit thereof, or in the holding of hearings or the subpoenaing and compensating of witnesses.

SECTION 15. Distraint Penalty. The penalty as provided by R.S. 47:337.76 in cases where the distraint procedure is used in the collection of the Tax shall be ten dollars (\$10.00).

SECTION 16. Limits on Interest, Penalty and Attorney Fees. Should the interest, penalties or attorney fees herein, or the combined interest, penalties and attorney fees, be declared to be in excess of limits provided by other law, including relevant jurisprudence, then the maximum interest, penalties and attorney fees allowed by such other law shall apply.

SECTION 17. Collector. The Tax levied by this ordinance is authorized to be collected by a "Collector" which term shall mean the City of Monroe.

SECTION 18. Powers of Collector. The Collector is hereby authorized, empowered and directed to carry into effect the provisions of this ordinance, to appoint deputies, assistants or agents to assist it in the performance of its duties, and in pursuance thereof to make and enforce such rules as it may deem necessary.

SECTION 19. Agreement to Collect Tax on Vehicles. With regard to the collection of the Tax on any motor vehicle, automobile, truck, truck-trailer, trailer, semi-trailer, motor bus, home trailer, or any other vehicle subject to the vehicle registration license Tax, this Governing Authority, acting through the President of this Governing Authority, is authorized to enter into an agreement or agreements with the Vehicle Commissioner, Department of Public Safety and Corrections, for the collection of the Tax on such vehicles, as provided by R.S.47:303(B).

SECTION 20. Revenues of Tax. All taxes, revenues, funds, assessments, moneys, penalties, fees or other income which may be collected or come into the possession of the Collector under any provision or provisions of this ordinance relating to the Tax shall be promptly deposited by the Collector for the account of the District in the special fund established and

If any or more of the provisions of this ordinance shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this ordinance, but this ordinance shall be construed and enforced as if such illegal or invalid provisions had not been contained herein. Any constitutional or statutory provision enacted after the date of this ordinance which validates or makes legal any provision of this ordinance which would not otherwise be valid or legal, shall be deemed to apply to this ordinance.

SECTION 22. <u>Uniform Sales Tax Controlling</u>. If any provision of this ordinance shall be in conflict with the provisions of the Uniform Local Sales Tax Code, the provisions of the Uniform Local Sales Tax Code shall be controlling.

(b) Definitions. The terms used in this section shall be defined in the same manner as they are defined in R.S. 40:961, and in 40:966.1 through 40:996.7, as from time-to-time amended.

(c) Penalties.

(1) Possession of marijuana:

(A) On a first conviction for violation of this section with regard to marijuana, tetrahydrocannabinol, or chemical derivatives thereof, the offender shall be punished as follows:

WHEREAS, the Issuer now desires to issue its Sales Tax Bonds (the "Bonds") in one or more series, on a taxable or tax-exempt basis, to be payable solely from and secured by an irrevocable pledge and dedication of the avails or proceeds of the Net Revenues of the Tax, all in accordance with Part II of Chapter 4 of Subtitle II of Title 39 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority (collectively, the "Act"), for the purpose of making capital improvements and paying the costs of issuance of the Bonds; and

WHEREAS, upon delivery of the bonds provided for herein, the Issuer will have no outstanding bonds or other obligations of any kind or nature payable from or enjoying a lien on any portion of the Net Revenues of the Tax herein pledged, other than the Issuer's outstanding Sales Tax Bonds, Series 2015 and Sales Tax Bonds, Series 2018; and

WHEREAS, the Issuer desires to make formal application to the State Bond Commission for approval of the issuance of the Bonds and further to employ special bond counsel in connection therewith:

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Aldermen of the City of West Monroe, State of Louisiana (the "Governing Authority"), acting as the governing authority of the City of West Monroe, State of Louisiana (the "Issuer"), that:

SECTION 1. Preliminary Approval of the Bonds. Preliminary approval is given to the issuance of not exceeding \$17,000,000 aggregate principal amount of Sales Tax Bonds, in one or more series, on a tax-exempt or taxable basis (the "Bonds"), of the Issuer, pursuant to Part II of Chapter 4 of Subtitle II of Title 39 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority, to be issued for the purpose of making capital improvements and paying the costs of issuance of the Bonds. The Bonds will be payable from and secured by an irrevocable pledge and dedication of the Net Revenues of the Tax. SECTION 2. Employment. This Governing Authority finds and determines that a real necessity exists for the employment of special counsel in connection with the issuance of the Bonds, and accordingly, Foley & Judell, L.L.P., of New Orleans, Louisiana, as Bond Counsel, is hereby employed to do and perform work of a traditional legal nature as bond counsel with respect to the issuance and sale of said Bonds. Said Bond Counsel shall prepare and submit to this Governing Authority for adoption all of the proceedings incidental to the authorization, issuance, sale and delivery of such Bonds, shall counsel and advise this Governing Authority as to the issuance and sale thereof and shall furnish its opinions covering the legality of the issuance of the Bonds. The fee of Bond Counsel for each series of bonds shall be fixed at a sum not exceeding the fee allowed by the Attorney General's fee guidelines for such bond counsel work in connection with the issuance of revenue bonds and based on the amount of said Bonds actually issued, sold, delivered and paid for, plus "out-of-pocket" expenses, said fees to be contingent upon the issuance, sale and delivery of said Bonds. The Mayor is hereby authorized and directed to execute, and this Governing Authority hereby agrees to and accepts the terms of, the engagement letter of Bond Counsel appended hereto. A certified copy of this ordinance shall be submitted to the Attorney General of the State of Louisiana for his written approval of said employment and of the fces herein designated, and the Finance Director is hereby empowered and directed to provide for payment of the work herein specified upon completion thereof and under the conditions herein enumerated without further approval of this Governing Authority.

SECTION 3. State Bond Commission. Application is hereby made to the State Bond Commission, Baton Rouge, Louisiana, for approval of the issuance and sale of the Bonds and for consent and authority to proceed with the issuance and sale of the Bonds as provided above, and Bond Counsel is directed to make application to the State Bond Commission in accordance with the foregoing on behalf of the Governing Authority.

By virtue of applicant/issuer's application for, acceptance and utilization of the benefits of the Louisiana State Bond Commission's approval(s) resolved and set forth herein, it resolves that it understands and agrees that such approval(s) are expressly conditioned upon, and it further resolves that it understands, agrees and binds itself, its successors and assigns to, full and continuing compliance with the "State Bond Commission Policy on Approval of Proposed Use of Swaps, or other forms of Derivative Products Hedges, Etc.", adopted by the Commission on July 20, 2006, as to the borrowing(s) and other matter(s) subject to the approval(s), including subsequent application and approval under said Policy of the implementation or use of any swap(s) or other product(s) or enhancement(s) covered thereby.

SECTION 4. <u>Appointment of Municipal Advisor</u>. The Issuer hereby retains Argent Advisors, Inc., to act as its Municipal Advisor ("MA") pursuant to the provisions of the Dodd-Frank Wall Street Reform and Consumer Protection Act and the rules promulgated thereunder by the Securities and Exchange Commission. The Issuer hereby acknowledges that it is represented by the MA and will rely upon the advice of the MA with respect to the Bonds. The fee to be paid the MA shall be payable solely from the proceeds of the Bonds when and if issued, and the amount thereof shall be subject to the approval of the State Bond Commission. The Mayor is hereby authorized and directed, in his discretion, to execute any contract the MA may require with respect to the engagement

SECTION 5. <u>Underwriter/Placement Agent.</u> Stifel, Nicolaus & Company, Incorporated of Baton Rouge, Louisiana (the "Underwriter"), is hereby appointed as underwriter/placement agent in connection with the sale and delivery of the Bonds, any compensation to be subsequently approved by the Issuer and to be paid from the proceeds of the Bonds and contingent upon the agent unless the Bonds; provided that no compensation shall be due to said underwriter/placement agent unless the Bonds are sold and delivered.

BEEKEEPER: Weeks will give presentation on July 24

Weeks is expected to deliver a talk and presentation on beekeeping on Saturday, July 24, at 11 a.m. in the Discovery Place at the Union Museum of History and Art in Farmerville. The museum is at 211 N. Main St.

Visitors to Weeks' presentation can try a variety of honey as well as view an observation hive showing live bees.

At her farm, Weeks and her son, Wyatt, harvest and distribute honey to local stores as part of a private co-op with other area beekeepers.

"That keeps me busy enough," she said. "There are many guys who produce a lot of honey but don't want to bottle it, and we don't want them to sell it out of the state, so I buy drums from them."

Harvesting honey is only one part of her honeybee farm: a major part of her farm is rearing the Minnesota Hygienic queen bee, first developed as a disease-resistant line of queen bees at the University of Minnesota.

"I don't want to work my bees too hard for honey because I raise the queens and bees," Weeks said. "The demand for a queen bee is pretty high. They will buy a queen bee when they need to split their hive. A hive will naturally grow big and split on its own, which is what we call a swarm. When that happens, the beekeeper loses half of his bees. So to keep his bees, you make an artificial split."

The demand for a disease-resistant queen bee is high because mites and beetles and other pests introduced in the 1980s decimated the honeybee population across the country.

"Before then, beekeepers didn't have pests," Weeks

said. "My neighbor's father had 50 hives but he's now struggling to keep two or three because we have mites and beetles and pests. Our bees are having to catch up and learn to be resistant to those pests."

Jim Davis, with the Ruston Bee Club, is a hobbyist beekeeper with about 30 beehives. He told The Ouachita Citizen he buys his queen bees from Weeks because her disease-resistant line are the "best around."

"Most people don't know there are different breeds or good lines of bees," Davis said. "She breeds and tests her bees to know if they're hygienic, which means they're more naturally more disease resistant. When I buy a queen from Amy, it's a Minnesota Hygienic queen so all her offspring are hygienic, too."

During the interview last week, Weeks donned

her beekeeper's veil and dropped handfuls of wood chips into her smoker to calm the bees as she worked near them.

"When you smoke them, from a biological standpoint, they think the forest is on fire so they go into the hive and eat honey," Weeks said. "When they're eating honey, they're too busy to sting me. The smoke also masks the alarm pheromone and keeps them under control."

Weeks opened a beehive to capture a queen bee and place the queen bee inside a plastic cage: a whistle-shaped plastic container with a rod stuffed with candy.

"The queen will eat through the candy, which will take a few days, and the bees will get to know her through her pheromones," Weeks said. "Otherwise, if she was introduced as

her beekeeper's veil and a stranger, the other bees dropped handfuls of wood would kill her."

> Besides rearing queen bees, Weeks also sells bees in a starter beehive kit, called a "nuc," short for a "nucleus hive."

> Weeks is a graduate of the University of Georgia Master Craftsman Beekeeper Program, is member and past president of Hill Country Beekeepers, and member of the Louisiana Beekeepers Association.

She sells queens, nucleus bee colonies, raw local honey, and beeswax. Weeks also mentors new beekeepers and is available for speaking engagements on queen rearing, beginning beekeeping basics, Africanized honey bees, and Apitherap.

When Weeks began keeping bees, she visited local bee clubs and found only a handful of people in attendance.

"There were only eight,

and I thought, 'Man, if the knowledge dies with them, that would be the end of all that learning," Weeks said. "They were great to learn from. All but one or two of them have passed away now."

Two beekeeping clubs in the area now have many members, with many of them new to the hobby or profession of beekeeping. Weeks is a member of each the clubs listed below.

"Our bee club is much bigger now because so many people are interested in bees," she said.
