## **ORDINANCE NO. 22-4267**

## AN ORDINANCE ADOPTING A PLAN OF REAPPORTIONMENT FOR THE BOARD OF ALDERMEN OF THE CITY OF BASTROP, LOUISIANA BASED ON THE 2020 DECENNIAL CENSUS COUNT

WHEREAS, the United States Bureau of the Census completed an official decennial count of the number of citizens residing in the City of Bastrop, Louisiana in 2020; and

WHEREAS, the Mayor and Board of Aldermen of the City of Bastrop, Louisiana, based on a change in the official population of the City of Bastrop revealed by the decennial count for the ten year period ending 2020, find that a redistricting of the five aldermanic districts within the City is necessary and proper, to adjust and equalize the population makeup of the five electoral districts that comprise the Board of Aldermen, to preserve the legal principal of one man, one vote applicable to representative government in the City of Bastrop, Louisiana.

Section 1: BE IT ORDAINED that in accordance with Federal and State Law, the boundaries of the Bastrop Board of Alderman districts are hereby redistricted so as to provide for population equality among the districts as near as reasonably practicable by the adoption and ratification of the document attached hereto and made a part thereof.

Section 2: BE IT FURTHER ORDAINED that the Bastrop Board of Aldermen Districts as redistricted in Section 1 above shall become effective for the qualification and election of candidates for the Bastrop Board of Aldermen in the 2023 election, and for all purposes upon the assumption of office by the members elected to the Bastrop Board of Aldermen.

Section 3: BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4: BE IT FURTHER ORDAINED that this reapportionment plan be sent to the United States Department of Justice "DOJ", the Secretary of State Louisiana Department of Elections, and the Morehouse Parish Registrar of Voters.

Section 5: This ordinance was introduced at the November 10, 2022 meeting of the Mayor and Board of Aldermen.

Section 6: A public hearing was held on December 15, 2022, at 5:00 P.M. prior to the adoption of this ordinance.

Section 7: After the adoption of this ordinance, it shall be published once per week during three consecutive weeks in the official journal of the City of Bastrop and shall become effective ten (10) days following the final date of publication.

# **Echols breaks ground on The Hotel Monroe**

Several government and business figures joined state Rep. Michael Echols earlier this week to break ground on The Hotel Monroe, a boutique hotel which is expected to open mid to late 2024.

The project, which is expected to cost more than \$25 million, is a capital investment with several financing and capital partners including Sherwin Williams Co., Stonehenge Capital, Caldwell Bank & Trust, Cross Keys Bank and Echo Development.

"We're going to have a great place to have fun

when you come into downtown Monroe," said Echols, R-Monroe. "We've got a little bit more blood, sweat and tears to put into this thing, but some really exciting things in our future."

The city of Monroe earlier this year awarded \$2.5 million toward the project and created a tax increment financing (TIF) district at the two lots located on Walnut Street. Echols can use the \$2.5 million to develop the two lots and must pay back the money over a 20-year period per the terms of the TIF agreement. To generate revenue, a two-percent hotel occupancy tax could be levied at the hotel.

Christie Echols, they had and Echols bought the two buildings in 2013. For much of that time, Cook, Doug-

las, Farr, Lemons (CDFL), an architecture firm based in Mississippi, has worked with Echols to make plans for the hotel.

"It's a special project," said CDFL Vice President Newell Watkins. "It's rare that you get to work with someone with as much vision and passion as Michael Echols. This is the kind of project that architects and designers live for."

## **Boley Elementary named 'Comeback Campus'**

The state Department of Education named 41 schools throughout the state earlier this month, including Boley Elementary in West Monroe, as "Comeback Campuses," meaning the schools performed at higher levels in reading and math than before the pandemic.

Boley is the only Comeback Campus in Ouachita Parish.

All Comeback Campuses increased the percentage of students scoring mastery level in reading and math and decreased the percentage of

students scoring unsatisfactory. During the 2018-2019 school year, Boley received an 86.2 performance score and in the 2021-2022 school year received a score of 93.

"Was I excited we did so well? Yes, I was," said Boley principal Sandy Bates. "But was I surprised? No. Because I know how hard these teachers and students work every day."

Boley Elementary not only struggled through the pandemic like other schools, but also suffered a fire in 2019 which rendered the school's building unusable.

"I felt sure that Boley would recover from the fire because of the outpouring support received from the community, the school district and the dedication of our faculty," said Tommy Comeaux, Ouachita Parish School Board member. "COVID was an altogether different obstacle, too many unknowns."

After the fire, Boley students and teachers used a vacant nursing home as a school.

While attending school in a nursing home came with its challenges, Bates said it also contributed to the students' improvement in reading and math.

"Two patient rooms made

up a classroom," Bates said. "It was harder for us to do group work and activities. I was very concerned when moving into the nursing home. But to be honest, one of the reasons for our increase was the smaller class sizes. We were able to individualize a lot more with smaller class sizes."

Bates said the teachers and tutors also contributed to the high test scores.

"We have a lot of consistency," Bates said. "We have a lot of high expectations. And one thing that I'm proud of is my teachers' individualized instruction. They look at each child's test scores or

diagnostic scores from the beginning of the year and they see where they're struggling."

Boley also began utilizing tutors about a year ago, all of whom are certified teachers who have either retired or resigned but came back to tutor in reading and math.

"The success of Boley and all the other schools in our district is contributed to dedicated parental support, diligent work by administrators, teachers and central office support staff along with some awesome students," Comeaux said. "Their faith and determination kept us moving forward."

Bates said Boley Elementary had been a part of her life for a long time, with her father being the former assistant principal. In fact, Bates was the school's mascot at when she was 5 years old.

"Boley has just always been in my blood," Bates said. "I was so excited when I became principal of a school that meant so much to my family. But as the years went on and we had the fire and everything, it just became a part of me. We have struggled through it all and come out on top and I could not be happier or more proud of the success we've shown."


