



Reconstruction of Lift Station "G-1". Estimated total cost = \$850,000 of which \$600,000 is from LA Capital Outlay funding through the Ouachita Parish Police Jury and \$250,000 is the estimated local match by the WOSD No. 5.

L & A, Inc. Project No. 21E050.00 - Elimination of package sewer treatment plant serving Country Heritage Estates subdivision and construct a new pump station and force main along Avant Road to the existing WOSD No. 5 pump station at Greenfields Subdivision. This project to be funded with funds from the LA Water Sector Commission, the OPPJ and the WOSD No. 5. Due to the estimated cost of this project being considerably more than the projected funds to be received from the Water Sector Commission, we are considering funding this project with LA Capital Outlay funding.

L & A, Inc. Project No. 22E032.00 - Gravity Line Extension along US 80 from Steep Bayou to Vancil Road. This project will consist of construction a 10' gravity sewer line from Line No. IA0000 on US 80 near Steep Bayou to Vancil Road. This will eliminate the two force mains that are currently located along this section of roadway. The estimated cost of this sewer line is \$1,000,000 of which \$750,000 will be funded by LA Capital Outlay Funds and \$250, 000 will be the required matching funds to be provided by the WOSD No. 5.

The meeting was called to order by Chairman Brian Shoemaker with the following board members present: Ted Parker, Timothy Williams, Lawrence Robinson, Billy Shepherd, and James Cunningham. Also present was the Board's secretary-treasurer, Deb Williams.

Each member was mailed a copy of the minutes from the October 11, 2022, regular meeting as well as the minutes for the September 21, 2022, and November 17, 2022, special meetings for review. Motion was made by Mr. Parker to accept the minutes as written. Motion passed following a second by Mr. Shepherd.

Mr. Shoemaker asked Mrs. Williams to review the information received from AT&T regarding new VIPER equipment. Mrs. Williams distributed a summary of the quotes that had been received from Ms. Donna Pair at AT&T to date. AT&T has submitted a quote of \$482,000 to purchase the VIPER equipment which includes maintenance and support for five years. The cost of "text to 911" capability would be an additional \$25,000. The purchase would also require additional internet service capability and Mr. Shoemaker is waiting for a quote for that from Ms. Pair. The current monthly bill paid to AT&T for maintenance of approximately \$3,500 would not be impacted by any decision regarding the new VIPER equipment, according to Ms. Pair. The second quote from AT&T for lease of the equipment was \$10,885 per month for 60 months (for a total of \$653,000). Ms. Pair has not yet provided the quote for the 3rd possible option of using AT&T as a hosting service and paying a monthly fee to AT&T for that service as opposed to purchasing or leasing the equipment.

The quote for purchase of the equipment included cost for both the Morehouse Parish Sheriff's Office and the Bastrop Police Department. The board discussed the need for having equipment at both locations and the cost savings of having equipment at only one location. Mr. Parker suggested that the board get a committee together to meet with the sheriff, the mayor, and others before a decision is made on how to proceed with the new equipment. Mr. Shoemaker agreed with that plan.

Mr. Shoemaker notified the board that Mr. Shepherd's, Mr. Robinson's, and Mr. Reed's terms expired in November. Mr. Parker made a motion that the terms of these board members be renewed through November 2026. Motion passed following a second by Mr. Williams.

Mr. Parker made a motion that the current officers be reinstated for 2023 - Mr. Shoemaker, Chairman, Mr. Williams - Vice Chairman, and Mrs. Williams - Secretary/Treasurer. Motion passed following a second by Mr. Shepherd. Mrs. Williams reminded the board of the required ethics course to be

completed by December 31, 2022.

Mrs. Williams distributed and reviewed the 2022 revised budget and the 2023 proposed budget that had been prepared by Joshua Legg, CPA. Upon review of the budgets, Mr. Williams made a motion that the revised 2022 budget and the proposed 2023 budget be approved. Motion passed following a second by Mr. Parker.

Atmospheric sciences professor to give talk at ULM

Lynn LeBlanc, professor emeritus of atmospheric sciences at University of Louisiana-Monroe, plans to give a talk on Feb. 16 in Biedenharn Recital Hall at

LeBlanc, who was part of the atmospheric sciences program at ULM for several decades, plans to share the history of the program and how it has evolved.

LeBlanc to come back and share a wealth of knowledge with our students and faculty," said ULM advancement officer Missy Amy.

The format for the talk will be interview-style, conducted by KTVE/KARD chief meteorologist Jarod Floyd. Floyd is an alumnus of the ULM atmospheric sciences program.

"To sit down and discuss one of the most successful careers "It is an honor for Dr. in meteorological history is an absolute privilege. Dr. LeBlanc is truly one of the founders of weather forecasting as we know it today. He's also been responsible

for teaching meteorologists that serve the public daily across the country, and across the world."

Floyd described LeBlanc as one of the kindest people and brightest minds he had ever met.

"He has an amazing talent to explain very complicated material in such a patient manner," Floyd said. "I think most students under him have spent their entire careers trying to make him proud. That's how highly we think of him."

LeBlanc joined the faculty at ULM in 1983 as an

assistant professor of atmospheric sciences and Director of the Climatic Research Center. He was promoted to professor in 1993. Under his direction, the department modernized the weather station and established an upgraded computer laboratory. He saw his own program designated a "Program of Unique Excellence" by the Board of Regents in the early 1990s-a distinction it has since retained.


In addition to teaching courses, LeBlanc served as a faculty advisor, handled most of the administrative duties associated with the program, recruited and worked as a member of several university-wide committees. 
