houses that Mr. Murray (Public Works Director John Tom Murray) and I had actually visited at least three years ago and that had gotten worse," Crosby said. "Some of the residents are continuing to fill in the holes. It may look good from the surface, but that's going inside the drainage pipe. The hole's still there."

According to Crosby, actions taken by residents of the subdivision have worsened the conditions of the sinkholes, such as swimming pool lines being backwashed

into the roadways and drainage pipes being connected to existing pipes by contractors hired by residents.

The sinkholes located in D'Arbonne Hills Subdivision are five- to 12-feet deep on average, Bacon said. She noted some of the sinkholes would be repaired by Sewer District No. 5, not the Police

noted. Bacon informed her fellow jurors the Police Jury had \$500,000 already allocated for this project.

"We have \$500,000 already waiting for us from Rep. Foy Gadberry in supplemental dollars that he's put towards this project," said Bacon, referring to state funding.

She offered a motion to allow Crosby to seek bids for the project and suggested funding the remaining projected cost of \$1 million using \$500,000 the state and \$500,000 of remaining American Rescue Plan Act (ARPA) funding.

Police Jurors Larry Bratton and Jimmy Tyson each expressed concerns the project would cost more than the estimated \$2.9 million. Ultimately, the Police Jury unanimously agreed to seek bids on the project.

"I'll be surprised if it fits in that budget, being a contractor," Tyson said.

On another front, Assistant District Attorney Jay Mitchell, the parish's legal counsel, asked the Police Jury to consider extending payroll services for the Fourth Judicial District Court (4JDC) in Monroe until Oct. 6, as he continued to negotiate an agreement with the district court about prepaid invoices.

Last month, the Police Jury voted to stop providing pavroll services to the 4JDC, effective Sept. 1, because the court had accrued an outstanding balance of some \$459,000 in unpaid invoices and authorized Mitchell to seek a cooperative endeavor agreement with the district court for an alternative option of pre-paid invoices.

During the Police Jury's last meeting, payroll services for the 4JDC were extended until Sept. 15 while

Mitchell worked on procuring a cooperative endeavor agreement. On Sept. 15, the Police Jury agreed to extend payroll services for the district court for another pay period, after it was recommended by Mitchell.

"The court has not been able to formally consider things until last week," Mitchell said. "I received their requested revisions on Friday afternoon. I told their attorney that I would ask you all to give another extension for just one more pay period and at the next meeting we will either have an agreement for your approval or not."

The Police Jury's next meeting is scheduled for Oct. 7.

BY REPRESENTATIVE ORGERON A JOINT RESOLUTION

Proposing to amend Article VII, Section 10.2(E)(1) of the Constitution of Louisiana, relative to federal proceeds from alternative energy production on the Outer Continental Shelf; to provide for the disposition of revenues; to provide for submission of the proposed amendment to the electors; and to provide for related matters

Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members elected to each house concurring that there shall be submitted to the electors of the state of Louisiana for their approval or rejection in the manner provided by law, a proposal to amend Article VII, Section 10.2(E)(1) of the Constitution of Louisiana, to read as follows:

§10.2. Coastal Protection and Restoration Fund

(E)(1) Subject to Article VII, Sections 9(B) and 10.1 of this constitution, in each fiscal year, the federal revenues that are received by the state generated from Outer Continental Shelf energy production including but not limited to oil and gas activity, wind energy, solar energy, tidal energy, wave energy, geothermal energy, and other alternative or renewable energy production or sources, and eligible, as provided by federal law, to be used for the purposes of this Paragraph shall be deposited and credited by the treasurer to the Coastal Protection and Restoration Fund.

Section 2. Be it further resolved that this proposed amendment shall be submitted to the electors

of the state of Louisiana at the statewide election to be held on November 5, 2024.

Section 3. Be it further resolved that on the official ballot to be used at the election, there shall be printed a proposition, upon which the electors of the state shall be permitted to vote YES or NO, to amend the Constitution of Louisiana, which proposition shall read as follows:

Do you support an amendment to require that federal revenues received by the state generated from Outer Continental Shelf alternative or renewable energy production be deposited into the Coastal Protection and Restoration Fund? (Amends Article VII, Section 10.2(E)(1))
