UTSA upsets La. Tech

Louisiana Tech held a 3-point lead at the end of the first quarter, but No. 24 UTSA scored 35 unanswered points to pull away for a final score of 45-16 Saturday inside Joe Aillet Stadium.

LA Tech (2-5, 1-2 C-USA) came out swinging as Austin Kendall hit Smoke Harris over the middle. The wide receiver then smoked every one as he raced to the end zone for a 47-yard touchdown.

However, UTSA (8-0, 4-0 C-USA) quickly silenced the crowd as they countered with a 75-yard touchdown on their second offensive play of the

game.

After those two offensive sparks, both teams had very little success on each of their next two drives, but the Bulldogs used another big play by Harris – 37-yard reception – that set up a 35-yard field goal by Jacob Barnes to retake the lead at 10-7 late in the first quarter.

The LA Tech defense was about to get the offense the ball right back after forcing a three-and-out, but a personal foul called on a late hit out of bounds gave the Roadrunners new life.

Twenty-four more penalty

yards by the 'Dogs aided in a two-yard rushing touchdown by Sincere McCormick to give UTSA its first lead of the game early in the second quarter.

The visiting team would never trail again. The Roadrunners went 72 yards on 10 plays to score on their next offensive possession to go up 21-10, which ended up being the half-time score.

They ended up tacking on a pick-six, two more rushing touchdowns by McCormick (one coming after a fumbled kickoff return by LA Tech) and a late field goal.

LSU's Pointer named to preseason

After the media named LSU senior guard Khayla Pointer to its Preseason All-SEC Team last week, the league's coaches named her to their Preseason All-SEC First Team on Tuesday.

After being named to the All-SEC First Team and Defen-

sive Team last season, Pointer announced in April that she would return for her final year of eligibility in Baton Rouge. She averaged a career-high 16.9 points per game last season, dished out 90 total assists and accumulated 55 steals. Pointer eclipsed 1,000 career

points last year and will be a critical part of first-year head coach Kim Mulkey's team.

"She is an all-conference player, and she is a leader out there on the floor," Coach Mulkey said about Pointer. "She's learning. It's a new system for her."

Ole Miss upends LSU

OXFORD, Miss. — A goal-line stand at the end of the first quarter flipped the momentum of the contest, as No. 12 Ole Miss defeated LSU, 31-17, on Saturday afternoon at Vaught-Hemingway Stadium.

After taking a 7-0 lead midway through the first quarter on a 90-yard drive, LSU (4-4, 2-3 SEC) looked to silence the home crowd with a second TD. However, the Tigers turned the ball over on downs with an interception at the Ole Miss 1.

Ole Miss (6-1, 3-1 SEC) scored 31 unanswered points to take control, as LSU lost two fumbles, recorded one first down, and missed a 55-yard field goal during the second and third quarters.

LSU linebacker Damone Clark had a career day, recording 20 tackles including a sack and a forced fumble that wiped an Ole Miss touchdown off the board in place of a touchback. His tackles total was one shy of the LSU record (21) set by Al Richardson against South Carolina in 1982, and was the most by a Tiger since Kevin Minter's 20 at Florida in 2012.

LSU starting quarterback Max Johnson played three quarters, completing 13-of-21 passes with an interception and a pair of fumbles as a result of sacks.

Freshman Garrett Nussmeier entered in the fourth quarter and led the Tigers to a pair of scoring drives. He completed 7-of-12 passes for 103 yards with a touchdown pass to wide receiver Malik Nabers.

Rynning back Tyrion Davis-Price led LSU with 17 carries for 53 yards including a 1-yard touchdown run in the first quarter, while freshman running back Corey Kiner added 49 yards on 10 carries.

Jaray Jenkins (52 yards), Jack Bech (41 yards) and Nabers (30 yards) each had four receptions for LSU, while Trey Palmer had a 44-yard catch.

Rebels Quarterback Matt Corral completed 17-of-22 passes for 180 yard with a touchdown, while adding a rushing touchdown. Snoop Conner led Ole Miss with 117 yards on 14 carries, while Jerriion Ealy added 82 yards on nine attempts including a

36-yard touchdown run in the third quarter.

LSU has an open date on Oct. 30 and will return to action on Nov. 6 when traveling to Tuscaloosa to face Alabama. Kickoff time is expected to be announced on Monday.

Ole Miss won the coin toss and elected to receive the opening kickoff, with LSU defending the south end zone in the first quarter.

Following an Avery Atkins touchback, the Rebels overcame an illegal block penalty with a 15-yard reception by Drummond to the Ole Miss 37. A 2-yard sack by LSU defensive tackle Glen Logan spoiled the next set of downs, and Ole Miss punted to the LSU 10.

A 14-yard receptions by Bech on third-and-3 moved the Tigers from the shadow of its end zone. Two plays later, Johnson came under pressure and heaved a 44-yard pass to Palmer who caught the ball between two defenders at the Rebels 21. The long reception allowed LSU to complete a nine-play, 90-yard drive with a 1-yard TD run by Davis-Price.

LSU hoops holds off Nicholls

THIBODAUX – Down 46-40 early in the second half, LSU used an 11-0 run to take the lead for good and go on to a 74-62 win Saturday afternoon over Nicholls State University at Stoper Gymnasium in an NCAA charity exhibition.

The contest, played before a nice crowd of fans from both schools, benefitted Hurricane Ida relief efforts in the Houma-Thibodaux area.

LSU had trailed 34-30 at intermission after leading most of the first half as the Colonels, who unveiled their 2021 Southland Conference championship banner prior to the game, had success getting to the free throw line, hitting 10-of-12 compared to just 1-of-3 for the Tigers.

But after getting the 46-40 advantage in the first few minutes of the second half, the Tigers were able to hit a three, make some defensive

stops and culminated an 11-0 run with three free throws by Parker Edwards to take a 51-46 advantage with 12 minutes to play. The Tigers would push the lead to eight at 59-51, outscoring Nicholls 19-5, the final 7:37 of the contest.

LSU was able to assert its muscle and got to the line 18 times in the second half, making 16 while the Tigers defended without fouling as Nicholls was just 1-of-3 at the stripe in the second half and made just 3-of-15 attempts.

LSU was limited as along with Adam Miller's right leg injury earlier in the week that is expected to cause him to miss the season, the Tigers were without Darius Days, Xavier Pinson, Efton Reid, Justice Williams and Shareef O'Neal. The Tigers started freshman Brandon Murray and Jerrell Colbert, sophomores Mwani Wilkinson and Eric Gaines and transfer sophomore Tari Eason.

MINUTES OF A REGULAR PUBLIC MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF VIDALIA, LOUISIANA, HELD ON TUESDAY, SEPTEMBER 14, 2021 AT 6:00 P.M. IN THE TOWN HALL MEETING ROOM, 200 VERNON STEVENS BLVD., VIDALIA, LOUISIANA

The Mayor and Board of Aldermen of the Town of Vidalia, Louisiana, met, in regular session, in the Town Hall Meeting Room on Tuesday, September 14, 2021, at 6:00 p.m.

There were present: Mayor Buz Craft, Aldermen Jon Betts, Robert Gardner, Tommy Probst, and Alderwoman Rosa I. Demby.

There was absent: Alderman Brent Smith.

There were also present: Jay LaSyone, Municipal Manager; Debra Moak, Municipal Accountant; George C. Murray, Jr., Municipal Attorney and members of the press.

The meeting was opened by the Mayor and the Pledge of Allegiance was recited by those present, followed by the invocation given by Alderman Betts.

A quorum being present, the Mayor declared the Mayor and Board of Aldermen of the Town of Vidalia, Louisiana, to be duly convened, in regular session, as the governing authority of said municipality, and opened the meeting for the conduct of business.

After being reviewed, the typed minutes of the regular meeting of August 10, 2021, were approved with no changes. The motion for approval was made by Alderman Betts, seconded by Alderman Gardner, and unanimously carried by those present.

The Mayor then opened the floor for public comments on current agenda items. The Mayor then recognized Mrs. Destiny Robb who had questions and comments on several of the agenda items. At the conclusion of Mrs. Robb's comments, there being no further comments or questions, the Mayor closed the floor for comments.

Agenda Item No. 1 was the presentation of the financial statement for July, 2021. The Mayor called on the Municipal Accountant, Debra Moak, CPA, who presented the financial statement. As customary, she began by explaining the various fund balances, which summaries included a comparison of actual expenses to budget expenses. The summary sheets, previously given to the Aldermen, were reviewed in detail, and she reported on the various positive and negative fund balances and indicated the net changes in the various funds through July 31, 2021. As usual, she reminded the Aldermen that those statements were provided to them in their meeting packet. At the end of her presentation, there being no questions or comments, the Mayor thanked Mrs. Moak for her usual thorough presentation.

Agenda Item No. 2 was Board discussion and vote on approval of occupational license applications. The first application was by Jason Durel for "Miss-Lou ENT & Allergy", at 1635 Carter Street. There being no questions or comments, on motion for approval by Alderman Betts, seconded by Alderman Gardner, and unanimously carried by those present, the application was approved. The second application was by Apple American Group II, LLC, for "Pizza Hut #2137" at 1913 Carter Street. The request is for a change of ownership. There being no questions or comments, on motion of Alderman Gardner, seconded by Alderman Demby, and unanimously carried by all present, the application was approved. The third application was by Eric Grantham for "DELTA HYDRO CLEANING, LLC", at 400 N. Magnolia Street. Mr. Grantham spoke on behalf of granting the application. Following Mr. Grantham's remarks, a motion for approval of the application was made by Alderman Betts, seconded by Alderman Demby, and carried unanimously by those present, the application was approved. The fourth application was by Terrell Fife for "T-Time Nutrition" at 1642 Carter Street-Suite 4. Mr. Fife spoke in favor of granting the application. At the conclusion of Mr. Fife's presentation, there being no questions or comments, on motion for approval by Alderman Gardner, seconded by Alderman Probst, and unanimously carried by those present, the application was approved. The fifth application was by Thomas Gattle, Jr. for "Terral River Service, Inc.", at 710 Levee Road. There being no questions or comments, on motion for approval by Alderman Betts, seconded by Alderman Demby, and unanimously carried by those present, the application was approved.

Agenda Item No. 3 was Board discussion and vote on outdoor sign applications. The first application was by Terral River Service for an alumina-panel sign, 10 feet in length by 5 feet in width with 12 feet height from ground to bottom of sign. The sign will advertise Terral River Service in accordance with the picture attached to the sign application. There being no comments or questions, it was moved by Alderman Demby and seconded by Alderman Betts to approve the application and the motion carried by unanimous vote of all present. The Mayor began by explaining what steps had been taken in the past in negotiating for the Lease Agreement with Enterprise. The Mayor then recognized Mr. Joey Nunn who spoke to the Board concerning the proposal. A copy of the form of the Master Equity Lease Agreement was in the meeting packet. Following a few questions by Alderman Gardner, and a discussion between the Board members, the Mayor and Mr. Nunn, a motion was made by Alderman Probst to approve the Master Agreement, seconded by Alderman Betts, and unanimously carried by those present.

Agenda Item No. 6 was report on recent inspection of Town Animal Shelter by La. Dept. of Agriculture. The Mayor then reported on the very good report from the Dept. of Agriculture and Forestry. A copy of the letter and Animal Control Shelter Inspection Form was included in the packet. The Mayor also thanked Mrs. DeeDee Roberts for her efforts in being instrumental in obtaining such a good report.

Agenda Item No.7 was Board discussion and vote on approval of Bryant Hammett & Associates to provide all professional services related to the Louisiana Water Sector Program. The Mayor began by explaining to the Board what this Water Sector Program is all about. The Mayor then called on Mr. Bryant Hammett to give further explanation and to answer any questions or comments. Following Mr. Hammett's presentation and answering questions from the Board, it was moved by Alderman Betts, seconded by Alderman Probst, and unanimously carried by all present, approving Bryant Hammett & Associates to provide all professional services related to the Louisiana Water Sector Program and to authorize Mayor Craft to sign the contracts and necessary documents to carry out the intent of this motion.

During part of his presentation, the Mayor recognized Elizabeth Tanner and thanked her for her efforts in overseeing the Town's efforts to carry out Mayor Sidney Murray's intentions for the use of Hydro funds as set forth in the Hydro Ordinance. Mr. Bill Murray commented on the purpose of the Hydro project. There being no further discussions or questions, a motion was made by Alderman Betts to set the amount to be distributed as rebates to the retail electric utility customers of the Town of Vidalia for this year to be fixed at \$2,503,463.00. The motion was seconded by Alderman Gardner and unanimously carried by those present.

Agenda Item No. 11 was Board discussion and vote on approval of funding from excess Hydroelectric revenues for the Town Beautification and Landscaping Project to be managed by Vidalia Beautification Committee and the Vidalia Garden Club as presented at public hearing held August 31, 2021, and September 2, 2021. The Mayor began with an explanation of the request to be approved for funding beautification and landscaping projects. The Mayor then recognized Mrs. Ellen Yates who spoke to the Board on the nature of the projects. The projects were the Carter Street Project; the Riverfront flower beds project; and the Old Historic Courthouse Square project. A brief summary of those projects was in a hand out given to the Board and she spoke at length on the projects about the many things that would be done to finish the projects. The estimated cost of the projects is \$250,000.00. Mrs. Cindy Galloway then spoke with a particular interest on the various flower beds and, at the conclusion of her presentation, Mrs. Yates finished up their combined presentation. There were questions from the Board and from the audience. Alderman Probst mentioned other projects which have been approved in the past and still have not been done and ought to be done as soon as possible. At the conclusion of the presentations and discussions, a motion was made by Alderman Betts, seconded by Alderman Demby,

to approve the funding of the Beautification projects for the total of \$250,000.00. The voice vote thereon was as follows:

YEAS: Alderman Betts and Alderwoman Demby.
NAYS: Alderman Gardner and Alderman Probst.
ABSENT: Alderman Smith.

The Mayor then advised that he is voting YEA to break the tie. Therefore the motion passed.

Agenda Item No 12 was discussion of plans to install culverts in area of Viking Street and Eleanor Street. Mayor Craft explained the need for installing new culverts in those areas and indicated that there would be no votes needed at this time as this was for information only. There were no questions or comments.

Agenda Item No. 13 was discussion of Town streets designated for overlay project. The Mayor and Mr. Lee Staggs, head of Street Department, gave a rather detailed report on streets designated for overlay projects. The cost is estimated to be in the \$500,000.00 range and consisted of, among others, Simonton and Miranda Streets; front Lee Street; Dogwood; Dandridge; and North Magnolia.

Agenda Item No. 14 was discussion of plan for clearing power lines of overhanging limbs and/or trees throughout the Town. The Mayor briefly outlined his current plans for clearing power lines of overhanging limbs and/or trees creating dangerous situations. He stated that he continues to work on that project. Following the Mayor's presentation, it was moved by Alderman Gardner, seconded by Alderman Probst, and unanimously carried by those present, to approve the preparation of a plan to be approved at a later meeting.

Agenda Item No.15 was adjournment. The Mayor announced that there is no further business, and asked for a motion to adjourn. A motion to adjourn was made by Alderwoman Demby, seconded by Alderman Betts, and carried unanimously by all present. The meeting was declared adjourned.
