Warhawks sweep Arkansas State

It also marked ULM's third consecutive win over Arkansas State, matching the Warhawks' longest streak (1984-85) in series history.

"It definitely was a grind-it-out win," ULM head coach Keith Richard said. "It's difficult to beat any Division I team twice in one season, and we're trying to do it against a conference opponent on back-to-back days. These Saturday games aren't going to be pretty at times because fatigue does become a factor, regardless

of how deep you go into your 11-0 run with his 3-pointer from bench. It's tough physically and the right baseline and Russell mentally. There were times in the second half where the play wasn't

"The question becomes who can make the big plays at critical moments when neither team has been scoring because the opponent is experiencing the same things. Who can get the big stop when your team needs one? Who can grab the big rebound? Who can make free throws down the stretch? We led for the first 30 minutes of the game, then fall behind midway through the second half. That's our team's first taste of this kind of game, and the way they responded was a good sign for us. They competed against the opponent. They competed against physical and mental fatigue. They competed against me (laughing). But, they found a way to win."

Josh Nicholas sparked an early

Harrison's four-point play gave ULM (4-5, 2-0 Sun Belt) its largest lead at 15-4 with 13:59 left in the first half. The Warhawks hit eight of their first 10 shots from the field, including all three from 3-point range, and enjoyed a 20-11 advantage with 12:19 to play in the opening half.

A-State (3-6, 0-2) responded with a 12-3 run of its own and tied the score at 23-all on a layup from Caleb Fields with 6:48 remaining in the first half. The Red Wolves connected on 6-of-8 field-goal attempts during that stretch while ULM experienced a scoring drought that lasted 4:13.

Johnnie Williams' 3-pointer from the right wing in transition fueled a 9-2 spurt as the Warhawks built a seven-point lead at 32-25 on 3 from Koreem Ozier with 3:53 left. A-State a 7-3 run to cut its halftime deficit to 35-32.

Playing in back-to-back games, fatigue became a factor in the second half as neither team scored for nearly the first four minutes. Trailing 42-34 with 14:33 left, Keyon Wesley scored five-straight points to key an 11-0 run for the Red Wolves. Antwon Jackson made the second of two free-throw attempts to give A-State its first lead of the game at 43-42 with 10:14 on the clock. Jackson added two more free throws as the Red Wolves took a 45-42 lead with 9:17 remaining.

ULM went exactly six minutes without a field goal until Thomas Howell's layup, off an assist from Luke Phillips, pulled the Warhawks within 45-44 with 9:02 to play. Markise Davis connected on a 3-pointer.

Terry Bowden has a history of winning throughout his career as a head coach, which took him from Salem (West Virginia) to Samford (Alabama) to Auburn and North Alabama.

"I knew of his father's history but not much about his and I looked him up and got to know his history a little bit more," ULM quarterback Jeremy Hunt said. "We are all very excited about him and the new direction he's looking to take this team. We will all miss Coach V and the staff."

PUBLIC HEARING

Ordinance on the Town Re-classification & Proposed 2020-2021Budget Mayor Washington stated that on the conference call meeting on September 1st it he stated and presented printed materials to the board that the Road Tax would project approximately \$7,000; but he wanted to amend that amount because the check we are currently getting from the police jury has increased by \$1,000. We are now projecting \$12,000 annual for Road tax at the end of the year and our net income should have at least \$940.00 left in the Road Tax category after we pay truck expenses, Workerman's Compensation and salaries. He also stated that his concern with the budget on the general fund is we adjust the fines on DWI Income from what it was last year some \$20,000 up to \$81,000. Mayor Washington stated that he had discussed the proposed budget for the police department with Chief Madison. The reason they came up with that figure was because they were looking at salaries, auto insurance, Workerman's compensation, conference fees, chief membership association he has to be in that came up to about \$78,000. The Mayor said that he asked the Chief if he could make this budge and the Chief replied "yes"!

Mayor Washington expressed how Mr. Floyd Barber was a very important member to the community by serving it well for years and he would truly be missed. Mayor Washington read the resolution and then presented it to Mr. Barber's son, who thanked the town for what they had done.

Alderman Kevin Mitchell made a motion to accept the ordinance to Re-classify the Town of Clayton as a Village and it was seconded by Alderman Willie Evans

The Mayor stated based on the 2010 Census the Town of Clayton sho uld have been classified as a Village but it was not done. Therefore, we do have a Proclamation from the Governors' office date July 23, 2020.

Alderwoman Michelle D. Bethea made a motion to adopt the 2020-2021 budget and it was seconded by Alderman Carl R. Thompson. The motion was carried!

B. Review of Monthly Bills & Monthly Financial Reports

The Mayor stated that the town is not so far gone that we cannot get it back, but it's going to take a commitment and discipline to pay those individuals that we owe. The town went with the suggestion of the Public Serve Commission by mailing letters to its citizens that were 90 days behind. The mayor would give them a change to sign a payment plan with the town to pay their past due bill and to keep the current bill paid. The payment could be set up for 3 to 6 months according to how much they owed. If the agreement is violated, than their utilities would be cut off. Mayor Washington stated that he was not trying to be mean, but the town had bills to pay! He also stated that if anyone needed to talk to him, they could do so by phone or in person. Mayor Washington said that when he first filled the seat of mayor, the town was well over \$400,000 in debt, including the Concordia Bank loan. We have caught up on paying Louisiana Municipal Gas and making payments on the back due bills. In the past few months we have paid some of the debts down.

D. Concordia Bank Loan Payment

Mayor Washington stated that at the advice of the Legislator office he went to Concordia Bank in Vidalia to speak with Mr. Biglane about what type of agreement could be made for the town on paying the bank.

Whatever the bank agreed on would not be official until we go to Baton Rouge and meet with the Legislator and Bond Commission and if they say no, we still have to keep paying on the loan. We started out with a \$350,000 loan and we defaulted by not making payments which caused the interest to build up. Since 2019 we have paid the loan down to \$234,805.33. To keep it under \$300,000 and at 2.25 interest, we have to do an 8 year payment plan which would put us at \$2,600.74 per month or a 9 year plan which would put us at \$2,404.00. Mayor Washington said he recommended we go with the 9 year plan, reason being to set up a \$2,500.00 automatic payment out of the bank and if we have an extra \$500.00 we will write the bank a check.

E. Occupational License Application (Mr. Jefferson)

Alderwoman Michelle D. Bethea made a motion that the Village of Clayton accepts Mr. Jefferson application for an occupational license for a car wash and it was seconded by Alderman Willie Evans. The motion was carried!

F. Gate for Lagoon Road

NOVEMBER 10, 2020

The meeting was called to order by Mayor Wilbert Washington and opened with a prayer by Alderman Kevin Mitchell followed by the Pledge of Allegiance. Roll call was done by the clerk. Present were, Mayor Wilbert Washington, Aldermen Willie Evans, Carl Ray Thompson, Kevin Mitchell, Abdul Sabir and Alderwoman Michelle D. Bethea. Also present were Clerk Sally Lewis and Chief Bobby Madison.

A motion was made by Alderman Bethea and second by Alderman Evans to add two items to the agenda, a resolution of death, out of respect for the former chief of police, the late Clarence "PaPa" Skipper and to discuss OEP (Office of Emergency Preparedness). All voted aye and the motion carried unanimously!

A motion was made by Alderman Evans and second Alderwoman Bethea to approve the October 6, 2020 minutes. All voted aye and the motion carried unanimously!

Public Participation: None

Mayor Washington stated he had received an email from Mr. Stuart Saulters, AP-GA's Vice President of Government Relations stating the town needs to pass a resolution appointing a director and an alternate director that would be responsible for attending meetings that are held by the LA Municipal Natural Gas Authority. The motion was made by Alderwom an Bethea and second by Alderman Mitchell to nominate Mayor Washington as the director and Alderwoman Bethea as the alternate director. All voted aye and the motion carried unanimously! Mayor Washington stated that the Community Development Revitalization Program had been around since the 90s. This program allows the town to make loans to businesses to improve its municipality. Mayor said he didn't know how to administer the fund and he could not find any guidelines on how to use the funds, so he call the USDA office and they said that we had to return the funds since it had not been used for so long. After discussing the grant it was determine that they had made a mistake on how much the original grant was. Mayor stated he

will be meeting with USDA next week and he would get all the information needed to how we can get business started. After a lengthy discussion on the use of the town vehicles, Mayor Washington suggested this item be tabled until our next meeting.

Mayor Washington reported to the board that the attorney that the town was using has gone to a better job. Mayor Washington asked for at least two alderpersons to work together to provide the board with names of attorneys and bring it to the next meeting so we can vote on an attorney. Aldermen Abdul Sabir, Carl R. Thompson and Alderwoman Michelle D. Bethea all agreed to seek the names of attorneys. Mayor Washington reported the town sold the land that they leased to a tower company and to his understanding the board voted not to lease anymore land. Mayor said in the towns' current financial state we need to reconsider in leasing a piece of land.

Mayor Washington reported to the board that hehad gotten a letter from the Office of Community Development for LGAP and CWEP applications to be submitted by February 1, 2021. For the 2021FY the maximum allocated amount available for the parish in the LGAP is

\$58,008 and for CWEP is \$64005. The Mayor said we qualified for both grants. Clayton's well at the water plant is in need of repair and we should try to get funds from the CWEP and also funds from the LGAP to purchase equipment. Mayor Washington stated he had spoken to Emerson Slain, who works for the Town of Ferriday and he said he would help fill outthe applications. The Mayor said that he would bring the application back to the board and if the board does not want what's on the applications we can change it and put in something else.

A motion was made by Alderwoman Bethea and second by Alderman Evans that we use the Concordia Sentinel as the town's official journal. All voted aye and the motion carried unanimously! The Mayor stated that he went to a meeting in Vidalia with the OEP. He stated

that he didn't know about the things the town could claim form damage and be reimbursed. Mayor Washington also said the OEP were asking for a one point contact person. Alderman Abdul Sabir was appointed as the OEP contact person working along with Chief Madison.

A motion was made by Alderwoman Michelle D. Bethea and second by Alderman Kevin Mitchell that the town present a resolution of death to the family of former police chief, for Clarence "PaPa" Skipper at the next town meeting. All voted aye and the motion carried unanimously!

Police Chief Madison reported to the board that everything was good. Chief Madison also, stated that he attended a meeting to try and get somethings for the town that would require going through Homeland Security. Chief Madison stated that he had been giving the board a printout but his computer system was not working. Chief Madison gave a breakdown of 6 violations and only 5 people had paid ad that the white police unit was not working and the black unit has no air! Alderwoman Bethea said that she wanted a typed monthly report on what was coming in and what was going out for the police department.

Ms. Tommy Etta Scott appeared before the board stating that for the first time she would be preparing Thanksgiving dinner for senior citizens age 65 and older on Nov. 17th at GG's Diner on Highway 65. A motion was made by Alderwoman Bethea and second by Alderman Mitchell to
