

# La. Tech adds transfer

RUSTON – The Louisiana Tech men's basketball team added some depth to its front-court on Monday as the program announced the signing of transfer Andrew Gordon.

Gordon, a native of Clearwater, Florida, is a 6-10, 250-pound forward who comes to Ruston after spending last season at West Virginia University.

"We are happy to welcome Andrew Gordon to the Louisiana Tech family," said head coach Eric Konkol. "Andrew is a physical frontcourt player that protects the rim and scores inside. He has the ability to positively affect the game with his size, strength and athleticism. Andrew has been a part of successful basketball programs and we are excited to work with him."

As a Mountaineer, Gordon saw

action in 34 games with four starts. He averaged 2.3 points, scoring a season-high 13 points in a start against Baylor, as well as 1.7 rebounds per game. He also posted seven points in just seven minutes of action against Kansas in the semifinals of the Big 12 Championship.

Prior to playing in Morgantown, West Virginia, he sat out the 2017-18 season at Northwest Florida State College in Niceville, Florida due to injury. His freshman year, he averaged 3.7 points and 3.6 boards per contest.

Gordon played his first ever season of organized basketball as a senior at Dunedin High, leading them to the playoffs for the first time since 2002. He starred on the football field as a wide receiver and defensive end.

# Media pick Alabama to win SEC again

SEC Football Media Days concluded on Thursday with media in attendance predicting Alabama to win the 2019 SEC Championship over Georgia in a rematch of last season's dramatic SEC Championship Game.

Alabama received 203 votes to be crowned SEC Champion on December 7 in Atlanta at Mercedes-Benz Stadium, while Georgia was second with 49 votes.

Georgia was selected to win the SEC Eastern Division with 1,789 points, including 233 first-place votes, while Florida was second with 1,499 points and 21 votes to win the division. Missouri was third with 1,149 total points. Points were awarded on a 7-6-5-4-3-2-1 scale.

Alabama was picked to win the SEC Western Division with 1,813 total points, while LSU was second with 1,493. Alabama received 253 first-place votes in the SEC West. Texas A&M was third with 1,268 points.

Alabama set a new record with 12 members selected to the First Team.

The previous record was 10 by Alabama in 2017.

Only seven times since 1992 has the predicted champion at SEC Media Days proceeded to win the SEC Championship Game, including last season's thrilling classic.

The game was the most-watched and highest-rated regular-season college football game on any network in seven years with a 10.1 rating and 17.5 million viewers. It also marked the second most-watched SEC Championship ever in 26 years since the game debuted in 1992.

# Northwestern State wins off the field

NATCHITOCHEs – In less than 30 days, the Northwestern State athletics department will welcome the 2019-2020 athletic year, which brings with a chance for success both inside and outside the athletic arena.

For the Demons and Lady Demons, that means attempting to improve on another stellar individual and team year of community service and engagement.

Northwestern State student-athletes donated 4,458 hours of community service during the 2018-19 campaign while NSU coaches and staff added an additional 1,810 hours of community service and engagement.

"With community service and engagement being long-term staples of the NSU athletic program, I am proud of our current student-athletes, coaches and staff for sustaining that platform by continuing to give of themselves for the benefit of others," said NSU Director of Athletics Greg Burke, who leads by example through his involvement in a number of civic and community service organizations.

"This focus is not something that started here a few years ago. Rather, it dates back well over a decade ago to a time when our 'Victorious For Life' program had its genesis, and community service was one of the main tenants of that program, which is designed to prepare our student-athletes for life after

graduation through personal and career development."

The continued largesse of community service hours falls in line with Burke's core goals for the athletic department, and NSU student-athletes have received national recognition for their off-the-field endeavors.

Senior offensive lineman Chris Zirkle was chosen from more than 2,500 student-athletes as the Southland Conference's male representative for the NCAA Leadership Conference, held in April in Orlando, Florida.

This past week, Zirkle was announced as a nominee for the All-state American Football Coaches Association Good Works Team, giving Northwestern State its second nominee in the past four seasons (JeMarcus Marshall, 2016). Zirkle's recent honors continued the legacy that was enhanced with the introduction of the Victorious For Life program.

Since 2011, Northwestern State has seen linebacker Yaser Elqutub voted as the captain on the 2011 Allstate AFCA Good Works Team and Demon basketball guard Sabri Thompson earn a spot on the 2017 Allstate National Association of Basketball Coaches Good Works Team, making him one of five Division I men's basketball players selected that season.

"Servant leadership is an integral part of the leadership development process we work to

incorporate in our student-athlete development programming on a daily basis," Assistant Athletic Director for Student-Athlete Development Kaitlyn McCanna said. "By participating in a variety of community service opportunities throughout the year, student-athletes are able to connect with the Natchitoches community and surrounding areas on a deeper level while hopefully developing a lifelong love of giving back."

That fact is not lost on most NSU student-athletes, especially the members of the Student-Athlete Advisory Committee.

"My time on SAAC has been a constant learning process from first attending the meetings as a representative of the volleyball team to now being elected as its president," senior Megan Lohmiller said. "I have learned there are so many opportunities to give back to our Natchitoches community. It truly does make an impact on the people living in this town. It shows that we athletes respect and appreciate all the support we receive from alumni, residents, students, and teachers. Community service allows us to give back to the ones who allow us to be student-athletes."

Since the Southland Conference began the Steve McCarty Citizenship Award in 2007, Northwestern State student-athletes have taken home nine of the

26 such honors, a conference high.

Northwestern State has been honored for its department-wide commitment to service as well. NSU won the inaugural "Southland Strong" Community Service Award and has placed in the top four in four of the five years of the award's existence.

"The student-athletes representing their individual teams in our Student-Athlete Advisory Committee have really taken this organization to a new level," McCanna said. "This is the group that set the benchmark of reaching more than 5,000 hours of community service annually, and with the momentum of coming off close to 4,500 hours this past year, there is no doubt they'll look to meet or exceed this goal in the upcoming year."

It is a goal that brings a smile to Burke's face. "In my little Ohio hometown of Alliance, I watched my parents – while raising four children – dedicate time for the betterment of the community, and it was a lesson well-learned and one I feel is important to impart to today's youth so they value the importance of 'paying forward' the opportunities they are provided," he said. "It is especially pleasing to see the impact our student-athletes have on the Natchitoches community in ways which towns and cities without a university are not able to benefit."

# Southeastern Louisiana seeks improvement

Southeastern Louisiana head coach Frank Scelfo, senior quarterback Chason Virgil and senior linebacker Isaac Adeyemi-Berglund represented the Lions at the Southland Conference Football Media Day Thursday.

Entering his second year, Scelfo's message was clear. He expects the program's success to be fueled by the improvements made in the locker room.

"We're excited about the newcomers we're bringing in and how our returning talent has developed. There's no doubt we've improved our overall depth," Scelfo commented. "But this biggest growth we've seen over the off-season has come off the field. Our team is bought in to our culture and we understand success on the field starts with leadership and the dedication to excellence in the classroom and the community. We see the love and trust building throughout our team and that's vital to our success."

Scelfo extolled his veterans for willingly assuming leadership roles. Two of those leaders are Virgil and Adeyemi-Berglund, both poised for productive senior seasons.

"Chason and Isaac are not here just because they are good football players," Scelfo said. "They're here today because they're two of

our best leaders and represent what type of student-athletes we want representing us on and off the field. We're trying to build a culture here and it starts with the student-athletes. These two young men are examples of the type of people we want in our program as we move forward."

Virgil led the Southland with 3,034 passing yards as a junior and heads into his senior season with a wealth of receiving weapons at his disposal, led by All-Southland returners Juwan Petit-Frere and Branshan Schwebel, as well as veterans CJ Turner, Austin Mitchell and Lorenzo Nunez. The Lion offense will also benefit from a renewed rushing attack led by Devonte Williams and Marcus Cooper.

"We're fortunate to have a lot of great playmakers on our offense," Virgil said. "I see my role similar to that of a point guard in basketball. We have so many guys who can make things happen when the ball is in their hands. My role is to just get the ball to them in the best position to make plays."

Adeyemi-Berglund, who led SLU with 10 tackles for loss and six sacks as a junior, is one of two All-Southland returners on a young Lion defense, along with senior safety Xavier Lewis. Adeyemi-Berglund is eager to

be one of the veterans for SLU's first defense under new defensive coordinator Lance Guidry, most recently the head coach at league foe McNeese.

"Coach Guidry coaches with a lot of passion and as a result, our defense is going to play with more passion," Adeyemi-Berglund commented. "Our mindset is all about competition. We're pushing each other to be better every day and we've seen the results during the spring and summer."

Southeastern was picked eighth in the Southland Conference preseason poll, which was released Thursday morning, but expects to exceed preseason prognostications.

"We can win every game on our Southland Conference schedule this season," Scelfo said. "Conversely, we can lose every game on our Southland Conference this schedule this season. We have to be ready to play every week in this league."

"We had such an up-and-down season last year," Scelfo added. "The good teams don't have such high peaks and low valleys. The good teams are steady and consistently improve as the season moves forward. We think the growth we've made off the field is going to help us become one of the good teams."

## MINUTES OF A REGULAR PUBLIC MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF VIDALIA, LOUISIANA, HELD ON TUESDAY, JULY 9, 2019 AT 6:00 P.M. IN THE TOWN HALL MEETING ROOM

The Mayor and Board of Aldermen of the Town of Vidalia, Louisiana, met, in regular session, in the Town Hall Meeting Room in Vidalia, Louisiana, on Tuesday, July 9, 2019, at 6:00 p.m.

There were present: Mayor Buz Craft, Aldermen Jon Betts, Tommy Probst, Tron McCoy, Robert Gardner, and Alderwoman Sabrina Dore'.

There were absent: NONE.

There were also present: Debra Moak, Town Accountant; Bill Murray, Town Manager; George C. Murray, Jr., Town Attorney; Jay LaSyone, Town Clerk, and Pam Middleton, Executive Secretary to the Mayor; and representatives of the press

The meeting was opened with the reciting of the Pledge of Allegiance and the invocation was given by Alderman Gardner.

A quorum being present, the Mayor declared the Mayor and Board of Aldermen of the Town of Vidalia, Louisiana, to be duly convened, in regular session, as the governing authority of said municipality, and opened the meeting for the conduct of business.

After being reviewed, the typed minutes of the Special Meeting of May 30, 2019, and the regular meeting of June 11, 2019, were both approved, with the following change being made to the June 11, 2019, minutes: In Agenda Item No. 6, Mr. Jahn's name was corrected and his title was corrected to be Chief Operating Officer, not President. Motion for approval was made by Alderman Gardner, seconded by Alderwoman Dore', and unanimously carried.

Addressing Agenda Item No. 1, the Mayor called on the Town Accountant, Debra Moak, who presented the financial statement for the month of May, 2019. As customary, she explained the fund balances for each of the funds, which summaries included a comparison of actual expenses to budget expenses. She also reviewed the several summary sheets, previously given to the Aldermen, and reported on the various positive and negative fund balances and indicated the net changes in the various funds through May 31, 2019. Following her presentation, there being no questions or comments and the Mayor thanked Mrs. Moak for her usual thorough presentation.

Agenda Item No. 2 was the consideration of occupational license applications. The first application was by Casey M. Crouch for Bella Rouge Boutique at 8 Cadet Street. There were no questions or comments and it was moved by Alderwoman Dore', seconded by Alderman Probst, and unanimously carried, that the application be granted.

The second application was by Omsai Mira, LLC, d/b/a Budget Inn at 700 Carter Street by the owner, Jitendrakumar Bhakala. There were no questions or comments and it was moved by Alderwoman Dore', seconded by Alderman Probst, and unanimously carried, that the application be granted.

Agenda Item No. 3 was for outdoor sign applications, and there were no applications. Addressing Agenda Item No. 4, the Mayor advised the Board that he is introducing, at this meeting, the proposed Ordinance adopting and enacting the Policies and Procedures Manual for the Town of Vidalia, Louisiana. He explained the need for the Ordinance and reported that the Notice of Intent and the Notice of Public Hearing will be advertised as soon as the dates are decided and that the proposed Ordinance is available for inspection at Town Hall.

Addressing Agenda Item No. 5, the Mayor advised the Board that it is appropriate at this time to appoint the Pro Tempore to serve through June 30, 2020, and requested that the Board make their decision. It was moved by Alderwoman Dore', seconded by Alderman Probst, that Alderman Gardner be appointed Mayor Pro Tempore to serve through June 30, 2020, and the vote was unanimous.

Agenda Item No. 6 was Board approval to appoint The Seventh Judicial District Attorney's Office as City Court Prosecutor for the Town of Vidalia, Louisiana. At the outset of the discussion, Alderwoman Dore' moved to table the matter as more information is needed, and the motion was seconded by Alderman Probst, only Alderman Gardner opposed the motion and the motion carried.

Agenda Item No. 7 was Board adoption of a Resolution to enter into an Intergovernmental Agreement and Transfer of Property with the Vidalia Port Commission and to authorize Mayor Buz Craft to sign all documents necessary to implement the terms of said agreement. The Mayor advised the Board that it is now appropriate to consider the adoption of the resolution. Following a short discussion, a motion was made by Alderman Gardner, seconded by Alderwoman Dore', and unanimously carried, that the Resolution, as presented, be adopted.

Agenda Item No. 8 was Board approval of new hire for the Vidalia Police Department: Marvin Warner – Full-time. Following a short discussion, on motion by Alderman Gardner, seconded by Alderman Probst, and unanimously carried, the hire was approved.

Agenda Item No. 9 was a discussion of planned upgrades to the Town's sewerage system. The Mayor began by discussing the plans and needs to upgrade the Town's sewerage system. He talked of the problems and proposed solutions. Following a question and answer session, concerning the capacity of the Lagoon and the capacity of the pumping system, which questions were answered by Mr. Mark Morace, the Mayor called on Mrs. Heather Malone to speak about the upgrades approved for the Town and the current monies in capital outlay for upgrades over the next five (5) years.

At the conclusion of the discussion, Alderman Probst asked to be recognized and discussed the pending Animal Control Ordinance and had comments about trash and debris pickup.

Following Alderman Probst's comments, there being no further business, the Mayor asked for a motion to adjourn, which motion was made by Alderman Betts, seconded by Alderman Gardner, and unanimously carried, and the meeting was adjourned.
