New faces vie for Tech QB

Head Coach Sonny Cumbie has been synonymous with explosive offenses dating back to his days as the signal caller at Texas Tech.

Bulldog fans have seen many high-octane offenses themselves throughout the years and should expect no different in 2022.

For the third-consecutive season, the quarterback position is up for grabs in the middle of fall camp. However, no familiar faces vying for the role as the quarterback room was completely overhauled following the 2021 season.

Transfers Matthew Downing (RS Jr., TCU/Georgia) and Parker McNeil (RS Sr., Texas Tech, Troy, Navarro CC) headline the quarterback position battle.

Rounding out the quarterback room is the 2021 Louisiana Football Gatorade Player of the Year Landry Lyddy (Fr.), in addition to Northern Colorado transfer Andrew Brister (Rs Fr.), Navarro JC transfer Jack Turner (So.) and Lonnie Ratliff IV (Fr.)

"Quarterback is where it really starts on offense," Cumbie stated, "Both Matthew (Downing) and Parker (McNeil) are the two that have the most experience, but that does not mean others can't get into it. It is not a job that is decided by one play or one day. It is decided by consistency throughout fall camp and how they prepare and execute in live situations."

McNeil and Downing are familiar with Cumbie's offense as McNeil spent last season at Texas Tech with Cumbie and Downing played under Cumbie in 2020 while at TCU.

Downing and McNeil are both fierce competitors but vying for the same starting role has not hurt their friendship.

"We have a nice cohesive quarterback room," Downing stated. "It is always a pleasure to work with guys like we have. Me and Parker are great friends and hang out a lot off the field. We are all able to build off each other's ideas and ask questions. We challenge each other every day. Parker is a great quarterback. He works

hard and it has been a lot of fun."

"Me and Matthew (Downing) are competing as hard as we can," McNeil said. 'Matt is a great quarterback so it is always a great challenge. He always pushes me to do better and I hope I do the same for him." "Both Matthew and Parker have done

a lot of good things through fall camp," Cumbie remarked. "They both have each had their days with the ones and then with the twos. They both have had good moments and moments where they have to value the football more. I have been pleased with where they are at in terms of knowledge and execution. Landry Lyddy has done a very good job too and is picking up where he left off in the spring. He has really improved over the summer in terms of what we are doing and knowing where to go with the ball. I am really pleased with our quarterbacks and how they have competed."

While the starter remains unknown, one certainty is that they will have plenty of weapons to target. The Bulldogs return 59.6 percent of their receiving yards, 65.3% of their receptions and 59% of their receiving touchdowns from last season.

"Our receivers have been great so far," Co-Offensive Coordinator and Wide Receivers Coach Jake Brown said. "Our guys have done a good job of learning the playbook and catching on. Our older guys have done a good job of helping the younger guys out. We have a really close room and we all pull for each other, the energy has been great."

Smoke Harris returns for his Redshirt junior season after tallying 71 receptions, 756 yards and six touchdowns last season. He also led the Bulldogs in receptions in every single game in 2021, becoming the first player since Biletnikoff Award Winner Troy Edwards (1998) to accomplish the feat. The Bulldogs' second-leading receiver, Tre Harris is also back. Harris posted 40 catches, 562 yards and four receiving touchdowns last season. Smoke

"It is really big having receivers like Smoke and Tre back," Brown explained. "They have taken a lot of reps in their career. They are leaders that lead by example."

"All of our newcomers have impressed me so far," Brown added. "Every day we are getting a little bit better and that is all that we can ask of them. We have thrown a lot at them with learning a new offense but they are getting a lot better every day." One newcomer at the wide receiver position that has been making a lot of noise in fall camp is Tru Edwards, a transfer from Hawaii by the way of Navarro Junior College where he was coached by Co-Offensive Coordinator Scott Parr. Edwards is the son of former Tech great Troy Edwards. Tru Edwards

One thing that is vital for Brown and the receivers this season is the importance of their play when it comes to setting the tone of the offense.

"I tell the receivers that they set the tone every day. If we make plays we set the tone and if we don't make plays then the energy level is low. In game and in practice our play impacts the tone of our offense."

Tech is just 23 days from its season opener on Sept. 1 at Mizzou.

Kickoff at Missouri is slated for 7 p.m. and the game will be broadcast nationally on ESPNU. A 2019 Korn Ferry Tour Finals graduate who returned to the Tour in the "Floor of Five" category this year (150-200 on Sunday at the final event of the the PGA rankings), the 30-yearold Englishman entered the regular season finale on the bubble but played his way back to the PGA TOUR with a 9-under 62 – which featured three eagles, including a hole-out deuce at the challenging par-4 18th – in the third round.

It was moved by Mrs. Parker, seconded by Mr. Carson and unanimously carried to have the superintendent meet with Mr. Fred Worthy with Merit Health to find out what can be provided and how we can expand it in the athletic training contract.

Superintendent Bachus asked to table Item E from the agenda and she will bring back the teacher incentives next month with a better plan. It was moved by Mrs. Forman, seconded by Mr. Raven and unanimously carried to table Item E.

After hearing from Superintendent Bachus regarding pay raises for support personnel, there was discussion by the board members. It was moved by Mrs. Parker, seconded by Mrs. Forman and unanimously carried to approve the three parts of the plan with a start date of August 1, 2022:

Cost of living increases in the amount of 2% are to be granted to em-(a) ployees exceeding the maximum level of 25 years' experience as reflected by their respective pay scales. Adjustments are to be made on a 3-year cycle, are to be calculated only on the base salary and are to be granted upon an employee receiving a satisfactory evaluation,

(b) Pay raise of 3% of base pay for support personnel,

Part-time people, who have no fringe benefits but are certified teach-(c) ers, will have a pay raise from \$25/hour to \$30/hour. Our \$20/hour people, who are degreed personnel who may not be certified, we will increase to \$25/hour. Our \$10/hour interventionists increase to \$13/hour. Our \$12/hour interventionists increase to \$15/hour.

After discussion regarding the update to the principals' contracts, it was moved by Mr. Carson, seconded by Dr. Riley and unanimously carried to approve the updates to the contracts as recommended by the school board attorneys

Superintendent Bachus explained that the district has a plan for virtual learning in case the governor puts us back to Phase 1 or Phase 2, but she requested that we do not offer virtual learning for 2022-23. We already have a homebound plan established for children who are ill. Mr. Carson noted that the virtual learning program was for a limited time, only for last year, so there was nothing to vote on.

Superintendent Bachus welcomed the parents who were in attendance and noted that there were 58 parents who attended the Discipline Policy meeting on Monday. Superintendent Bachus noted that the current discipline policy has been in effect since 1999 and several parts of this policy are outdated and some parts are now illegal. We started this policy by reviewing our current policy and our attorneys came out and gave us updates on discipline. The biggest changes were cell phones and fighting. It was moved by Mr. Carson, seconded by Mrs. Forman and unanimously carried to approve the disciplinary policy subject to the typographical change needed in Section 16b.

Mrs. Parker requested that a feasibility study be done on the infrastructure of all schools in Concordia Parish to update our schools or possibly build new schools. In the discussion, Mr. Butcher recommended starting out with a survey at the school level and also hiring someone with the expertise to handle this type of study. This would include sending out RFPs and involving them in the study beginning with the survey. It was moved by Mrs. Parker, seconded by Mr. Raven and carried unanimously to form a core committee to send out RFPs and to select a committee to carry out this study and that the final committee is made up of representatives of all stakeholders.

Superintendent Bachus made the following announcements:

Thank you to everyone who came tonight, and thank you for attending the Discipline Policy meeting Monday. We had 25 teachers and 58 parents at that meeting. In addition to that, yesterday we had 66 people come to the substitute teacher meeting. I invited all of the parents and substitute applicants to the meeting tonight so we can get to know our constituents better. At the substitute teacher meeting, over half of them were new to the school system. We actually had to send some of those home who have been working for us previously because there was no room for them to sit. We did not anticipate that level of desire and interest. We will have them fill out a survey after their first day to let us know how it went because we don't want them to sub one day, we want them to keep working for us.

The CPA report June, 2022 have not received back so a 7) motion to table was called and carried unanimously.
